# ANNUAL EXECUTIVE SUMMARY FOR THE WILLIAM & MARY BOARD OF VISITORS

## 2022

The Board of Visitors is the governing authority of William & Mary (W&M), which includes the Virginia Institute of Marine Science (VIMS), and Richard Bland College (RBC). The Board has taken multiple actions to ensure compliance with the provisions of the *Code of Virginia §23.1-1303*, subsection B.13., which require the Boards of Visitors of each public institution of higher education to submit to the General Assembly and the Governor an annual executive summary no later than the first day of each regular session of the General Assembly.

During 2022, the W&M Board of Visitors held regular meetings on February 9-12, April 20-22 (annual meeting), September 21-23 and November 17-18, and a Board Retreat on July 26-28. Three meetings of the Executive Committee were also called. See the Table 1 below for details.
