# ANNUAL EXECUTIVE SUMMARY FOR THE WILLIAM & MARY BOARD OF VISITORS

### 2021

The Board of Visitors is the governing authority of William & Mary (W&M), including the Virginia Institute of Marine Science (VIMS) and Richard Bland College (RBC). The Board has taken multiple actions to ensure compliance with the provisions of the *Code of Virginia §23.1-1303*, subsection B.13., which require the Boards of Visitors of each public institution of higher education to submit to the General Assembly and the Governor an annual executive summary no later than the first day of each regular session of the General Assembly.

During 2021, the W&M Board of Visitors held regular meetings on February 25-26, April 22-23 (annual meeting), September 22-24 and November 18-19, and a Board Retreat on July 27-29. The Richard Bland College Committee held regularly scheduled meetings, via Zoom (during the Virginia State of Emergency) on February 23 and April 19, just days prior to the full Board meeting. Multiple other committee meetings were also called. See the Table 1 below for details.
