**Section 1: Required Documentation** 

The following items must be submitted along with this form before financial aid consideration can be made.

Documentation from W&M's Registrar's Office confirming the course numbers that have been approved.

Proof of enrollment at the host university. (Course numbers *must* match the courses approved by W&M's Registrar's Office).

**Section 2: Student Certification** 

Student must certify their acknowledgement of the following information before financial aid eligibility will be considered.

- I understand that W&M does not pay the host school directly and that it is my responsibility to make sure that the host institution receives payment for the program that I choose to attend.
- I understand that financial aid funding, if eligible, will not be released early if the semester at the host school occurs prior to the start of the applicable semester at W&M.
- I understand that I will not be eligible for financial aid if the classes that I am taking at the host school are not approved by the W&M Registrar's Office.
