1. For this application to be complete, the 2012-13 **FAFSA** (Free Application for Federal Student Aid) must be filed online at [www.fafsa.gov](http://www.fafsa.gov) by March 15. The Title 4 code for WM is 003705. Questions regarding the FAFSA can be referred to the Financial Aid Office.

The OWJ application must be submitted no later than March 2 and the FAFSA filed in a timely fashion, so that the applications can be processed and ready for the interviews in mid-April. If the FAFSA data is not received by the time interviews are scheduled, the OWJ committee will not consider the application complete.

2. If more space is needed for any items, you may use a separate sheet of paper. Please indicate the applicable item.
3. Verification of work status from your employer is required. If you are not currently working in food service, include a full explanation of your recent food service employment experience and your current status.
4. An interview with the OWJ Scholarship Committee is an integral part of the application process required of all applicants. You will be contacted to schedule an April interview.
5. Return your completed application to the Order of the White Jacket, P.O. Box 2100, Williamsburg, VA 23187-2100, or bring it to the Alumni House.

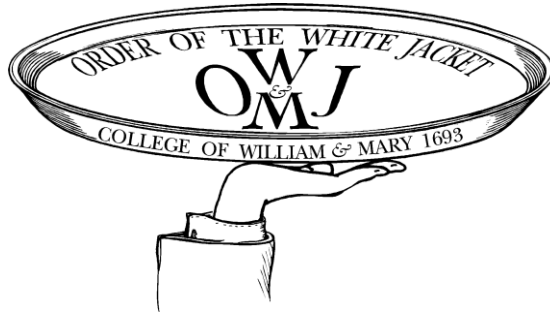
