Certification of Financial Support for International Students Academic Year 2013-2014



This form and the estimates herein are provided solely for I-20 and DS-2019 issuance. All international students who will apply for F-1 or J-1 visa/status must show adequate financial support for their program of study in the United States. The necessary immigration documents (I-20 or DS-2019), cannot be issued until W&M has received a **completed Certification of Financial Support** and any supporting documents.

All documentation must be **legible and not more than 6 months old at the time of admission**. Scanned and faxed copies are acceptable. However, students must bring the original documents to the U.S. Consulate or Embassy for the visa application, and may be asked to present them again at the U.S. Port of Entry when entering the U.S.

Graduate assistantship or W&M scholarship: Complete Section 1, and attach a copy of the letter from the College. If your award does not cover the total estimated costs, you will also need to include funding from personal funds or a sponsor, and complete Sections 2 and/or 3 (you may substitute a bank letter for section 3).

Sponsoring government, employer, or organization: Complete Section 1, and attach a copy of the letter from the government, employer, or organization. If your award does not cover the total estimated costs, you will also need to include funding from personal funds or sponsor, and complete Sections 2 and/or 3 (you may substitute a bank letter for section 3).

List of acceptable financial documents: Bank statements, certificate of deposits, liquid investment accounts, scholarship/funding letters, & loan confirmation letters. These documents are **NOT** acceptable: Pay stubs, property deeds/titles, and salary confirmations.

Scanned or faxed copies of financial documentation, including this form, are acceptable.
