## 2010-2011 Annual Report The Committee on Academic Status Marc Sher, Chair

The Table of Actions & Decisions describes the majority of petitions considered in 2010-2011by the Committee, the Medical Review Committee and the Dean of Students on behalf of the Committee. There was an overall decrease of 77 actions from 2009-2010 to the 2010-2011 total of 824 petitions. Student requests for exceptions for late adds, overloads, and retroactive full medical withdrawal had the greatest decreases from the previous two semesters. There was also a slight decrease in Academic Reinstatements as well as Appeals.

The Table of 2010-2011 Academic Year Academic Standing reports academic continuance decisions made by the Committee. From Spring 2010 till Spring 2011 there were fewer probation and academic warning students. However there was an increase in the number of first and second suspensions in Spring 2011.
