CAS Annual Report

Summary


In the 2017-18 school year, the CAS committee reviewed 813 CAS petitions. CAS petitions included requests for the following actions:

- Appeal of a previous CAS decision
- Late Add
- Late Drop
- Late Withdrawal
- Medical underload (i.e. requesting to take less than 12 credits because of a medical purpose)
- Other, which included comments on the action
- Overload (i.e. requesting to take more than 19 credit hours)
- Partial Medical Withdrawal (i.e. withdrawal from certain but not all courses due to a medical purpose)
- Reinstatement to good standing
- Underload (i.e. requesting to take less than 12 credits).

The committee also reviewed 455 MRC petitions. In total, the committee reviewed 1,268 petitions from students this year. MRC petitions included requests for:

- Full withdrawal
- Partial Withdrawal
- Medical Clearance
- Partial Withdrawal to Underload
- Medical Clearance and Re-enrollment
- Retroactive Medical Withdrawal.



Of the 813 CAS petitions reviewed by the committee, 581 were approved, 199 were denied, and 33 were cancelled.



Of the 455 MRC petitions this year, 371 (81.53%) of them were approved, 65 (14.28%) were denied, 15 (32.96%) requested additional information, and 4 (0.87%) were deferred to CAS for decision with recommendation by MRC.


Of the 813 petitions reviewed by the CAS committee, the most common petition was Overload with 223 petitions. The next most common petitions were the Late Add with 140 petitions. The third most common were that requested multiple actions, which could be any combination of actions, with 116 petitions.

Of the 455 MRC petitions, 113 (24.83%) were for Full Medical Withdrawals, 6 (1.31%) were for Medical Clearance, 95 (20.87%) were for Medical Clearance & Re-enrollment, 69 (15.16%) were for Partial Withdrawal, 136 (29.89%) were for Partial Medical Withdrawal to Underload, and 36 (7.91%) were for Retroactive Medical Withdrawal.

The most commonly requested action in CAS petitions was to overload credits. Of the 223 requests, 93 were approved. The second most commonly requested action was to Late Add a class. Of the 140 requests, 131 were approved. The third most common was to Underload from a class. Of the 95 requests, 73 were approved.

The other most requested actions in order of frequency are: late drop (75); late withdrawal (68); other (see comments) (56); appeal of a previous CAS decision (26); reinstatement to good standing (16); and partial medical withdrawal (1).
