#### Summary


In the 2020-21 school year, the CAS committee reviewed 854 CAS petitions. CAS petitions included requests for the following actions:

- Appeal of a previous CAS decision
- Late Add
- Late Drop
- Late Withdrawal
- Medical underload (i.e. requesting to take less than 12 credits because of a medical purpose)
- Other, which included comments on the action
- Overload (i.e. requesting to take more than 19 credit hours)
- Partial Medical Withdrawal (i.e. withdrawal from certain but not all courses due to a medical purpose) (MRC no longer accept Partial Medical Withdrawal as of Fall 2019)
- Reinstatement to good standing
- Underload (i.e. requesting to take less than 12 credits).

The committee also reviewed 333 MRC petitions. In total, the committee reviewed 1,178 petitions from students this year. MRC petitions included requests for: MRC petitions included requests for:

- Full withdrawal
- Partial Withdrawal
- Medical Clearance
- Partial Withdrawal to Underload
- Medical Clearance and Re-enrollment
- Retroactive Medical Withdrawal.


Of the 854 CAS petitions reviewed by the committee, 638 were approved, 216 were denied.



### CAS Petition Types





Of the 854 petitions reviewed by the CAS committee, the most common petition was Underloads with 389 petitions. The next most common were Overloads with 168 petitions. The third most common were L**a**te Withdrawals with 165 petitions.



Of the 333 MRC petitions, 70 (21%) were for Full Medical Withdrawals, 63 (19%) were for Medical Clearance & Re-enrollment, 93 (28%) were for Partial Withdrawal, 41 (12%) were for Partial Medical Withdrawal to Underload, and 31 (9%) were for Retroactive Medical Withdrawal.

The first most requested action in CAS petitions for the 20-21 school year were Underloads with 389 requests, 313 were approved. The second most requested action was to Overload in credits. Of the 168 requests, 74 were approved. The third most requested action was to Late Withdrawal from a class. Of the 165 requests, 143 were approved.
