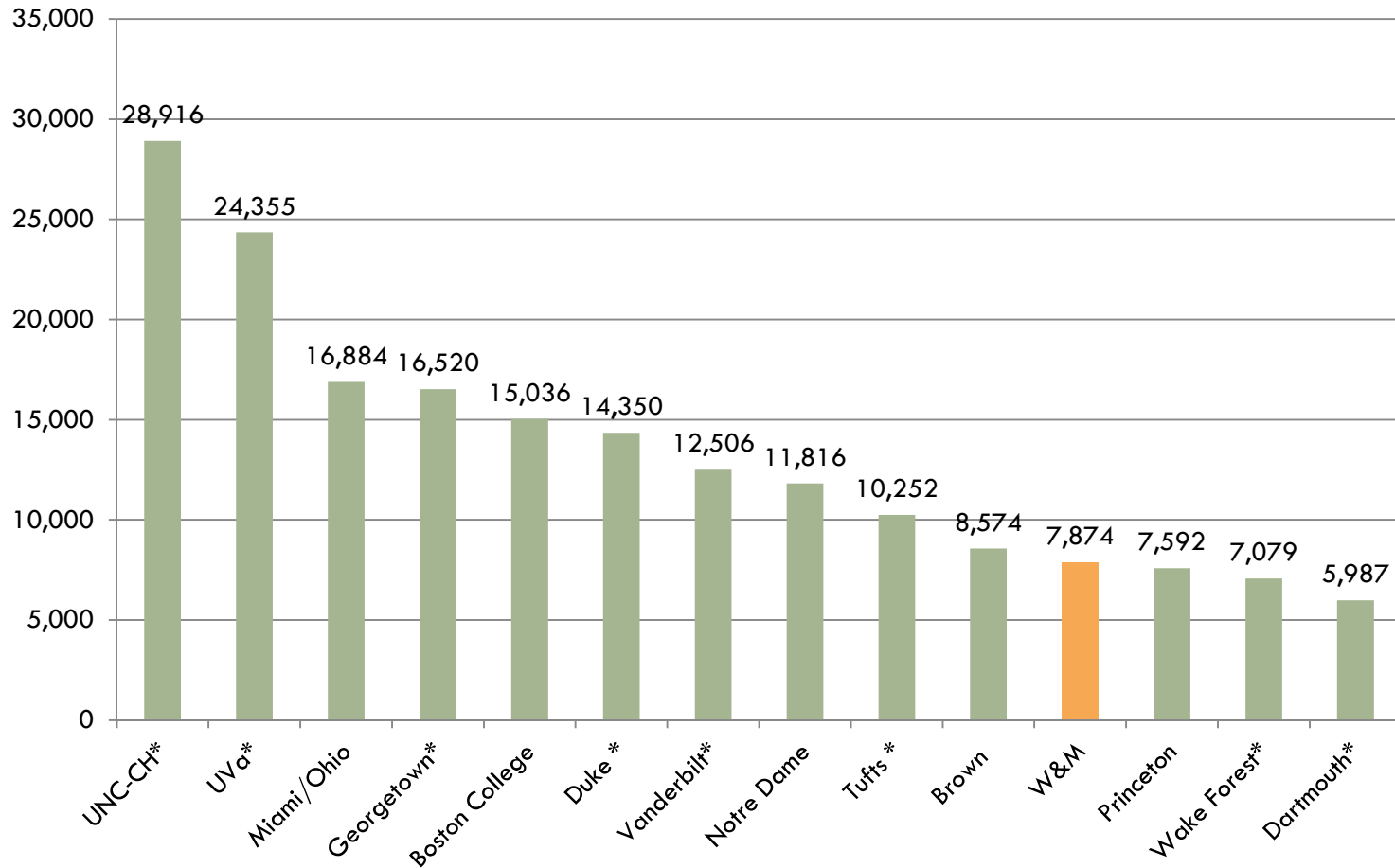

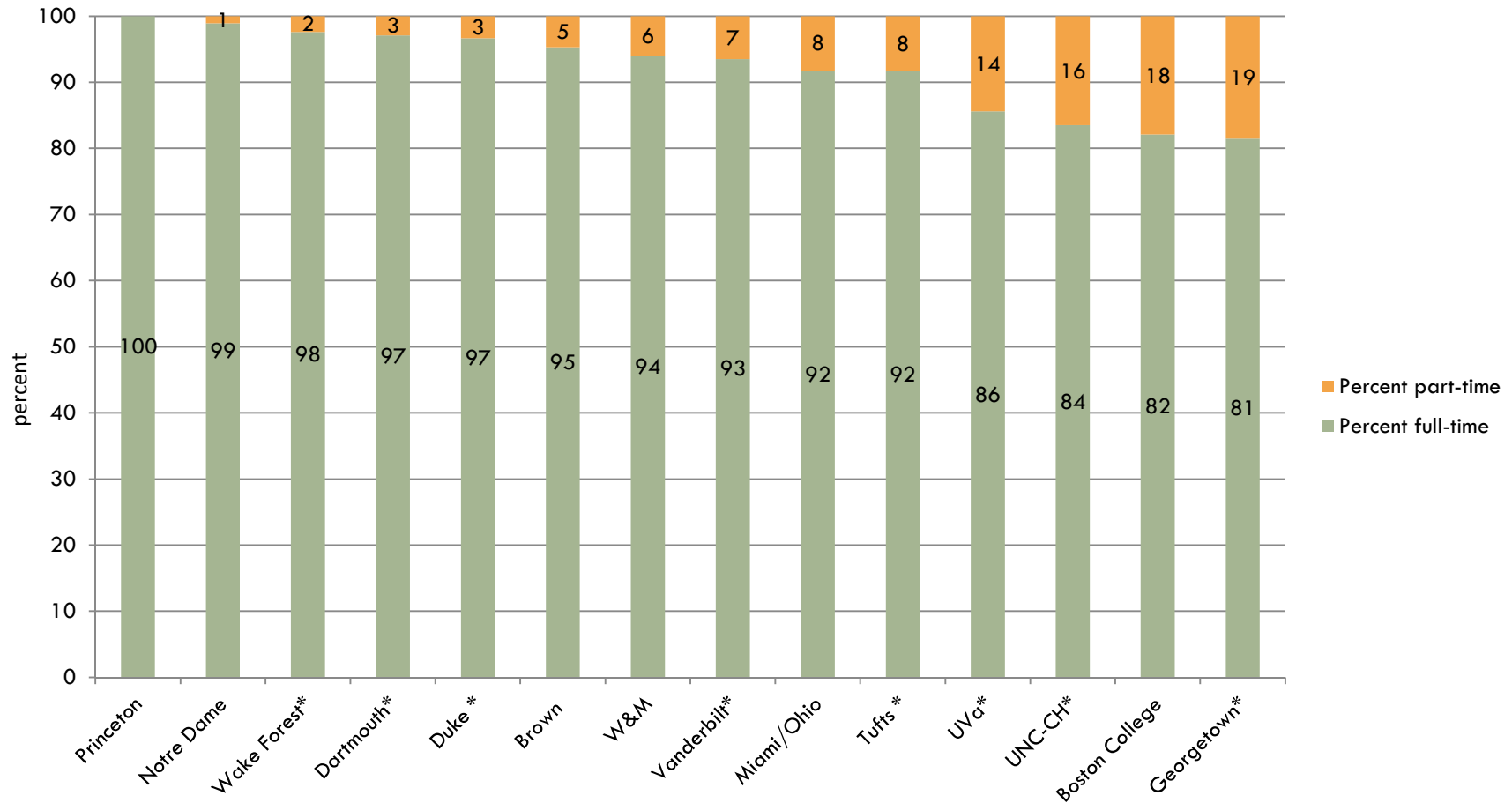
# Total enrollment (Fall 2009)

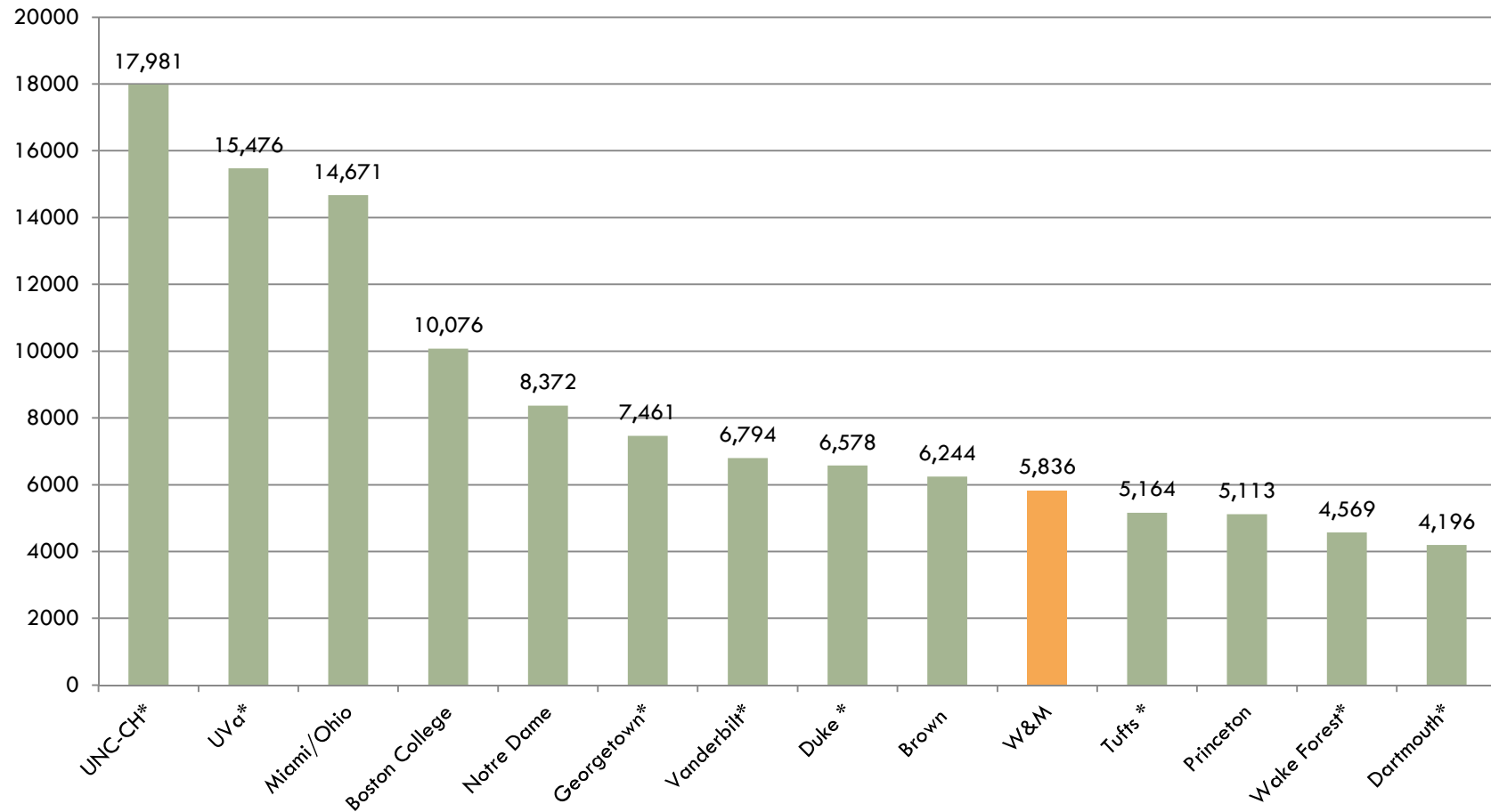
# Total enrollment: percent full-time and part-time (Fall 2009)

# Total undergraduate enrollment (Fall 2009)

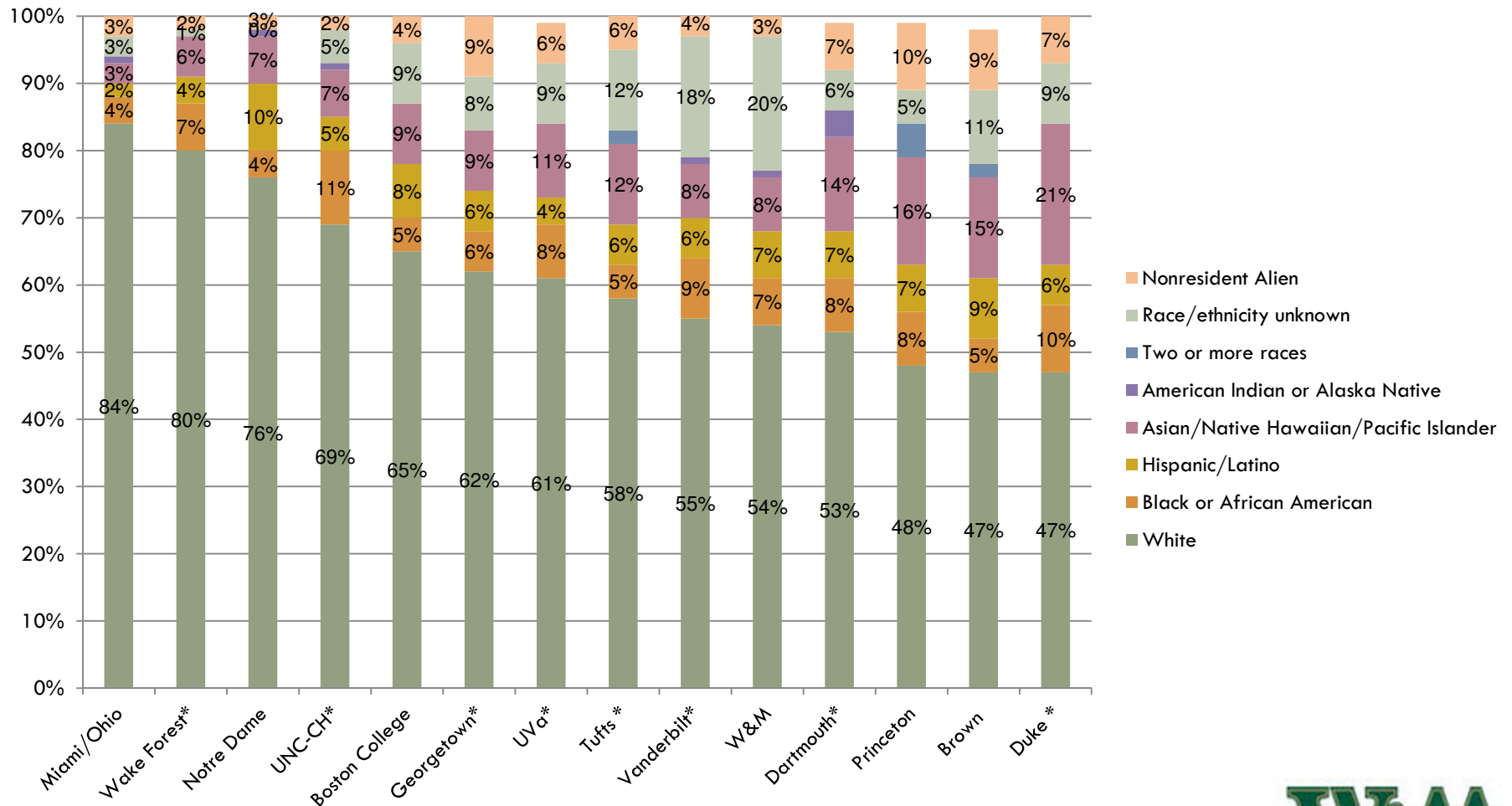

# Undergraduate enrollment by race/ethnicity (Fall 2009)



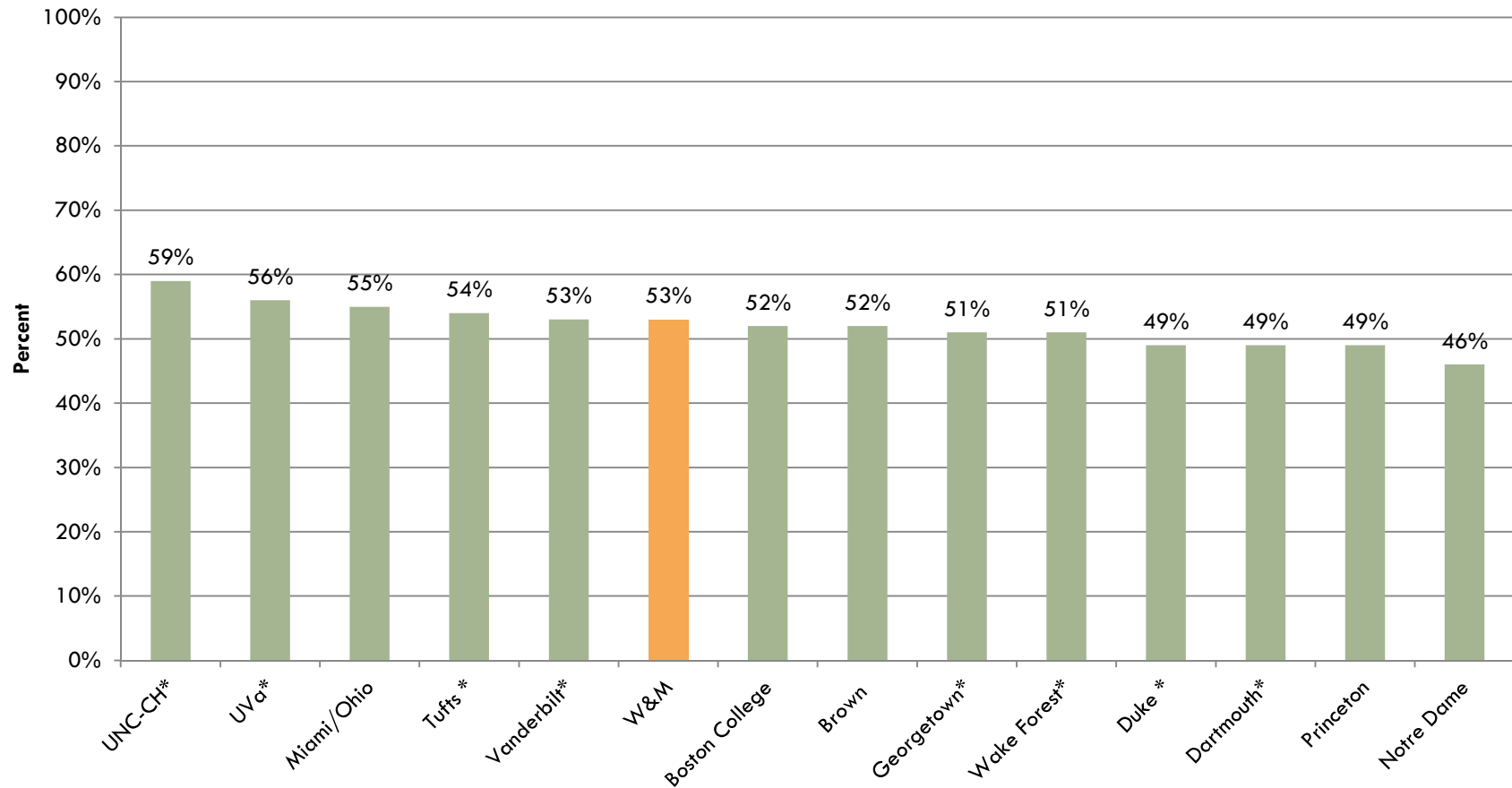

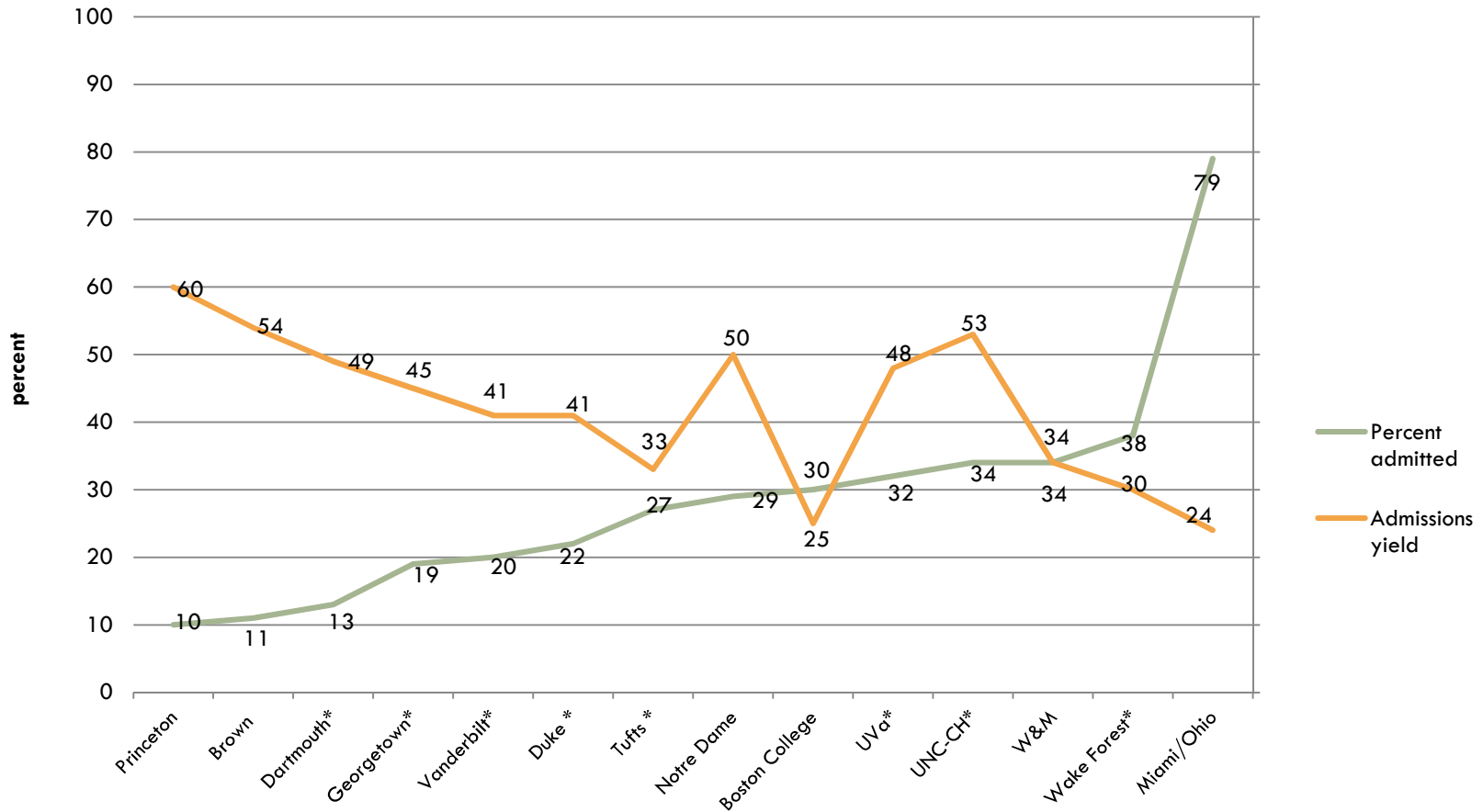

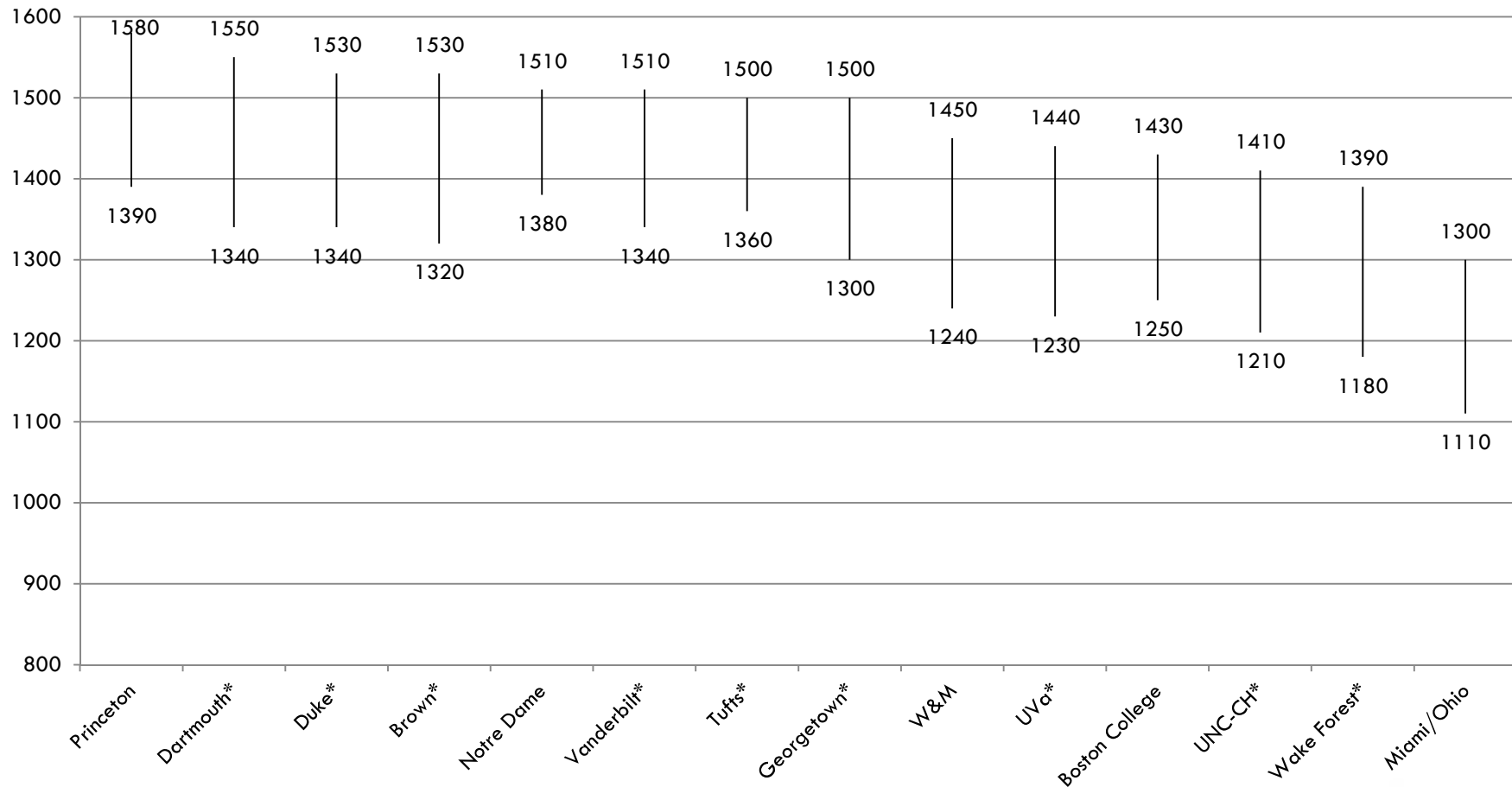

# SAT Scores: 25<sup>th</sup> -75<sup>th</sup> Percentile for Reading and Math (Fall 2009)



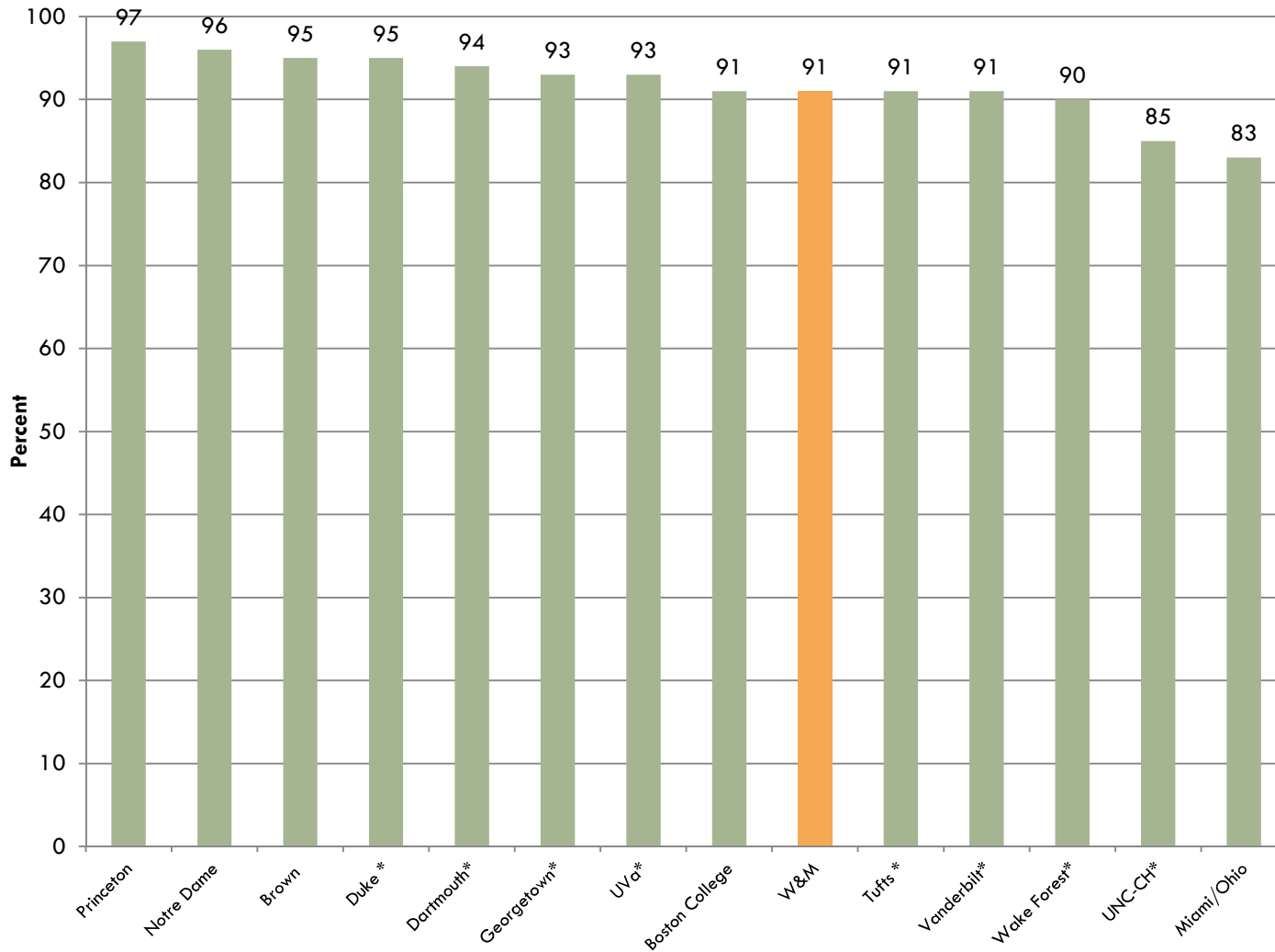

# Undergraduate graduation rate (August 31, 2009)

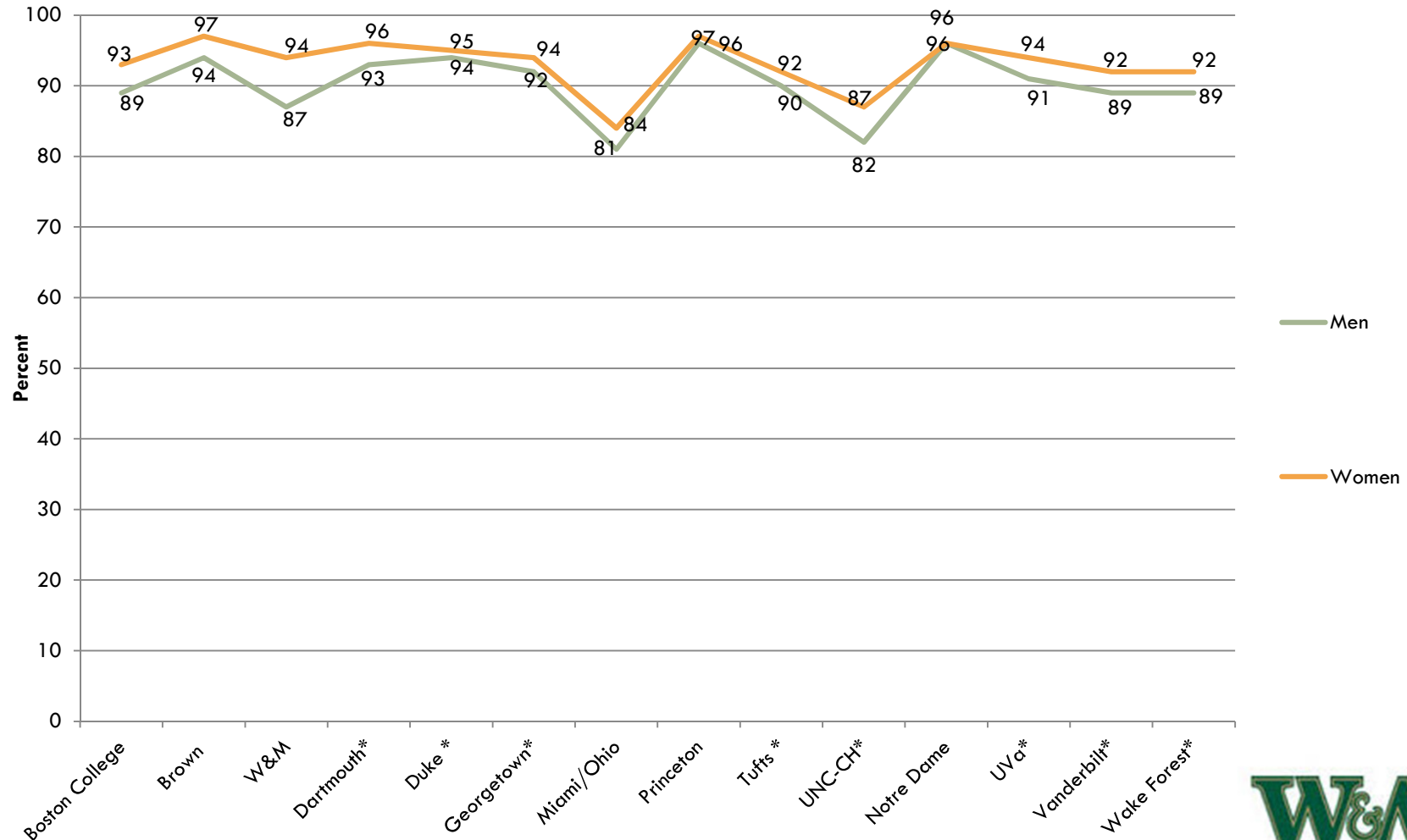

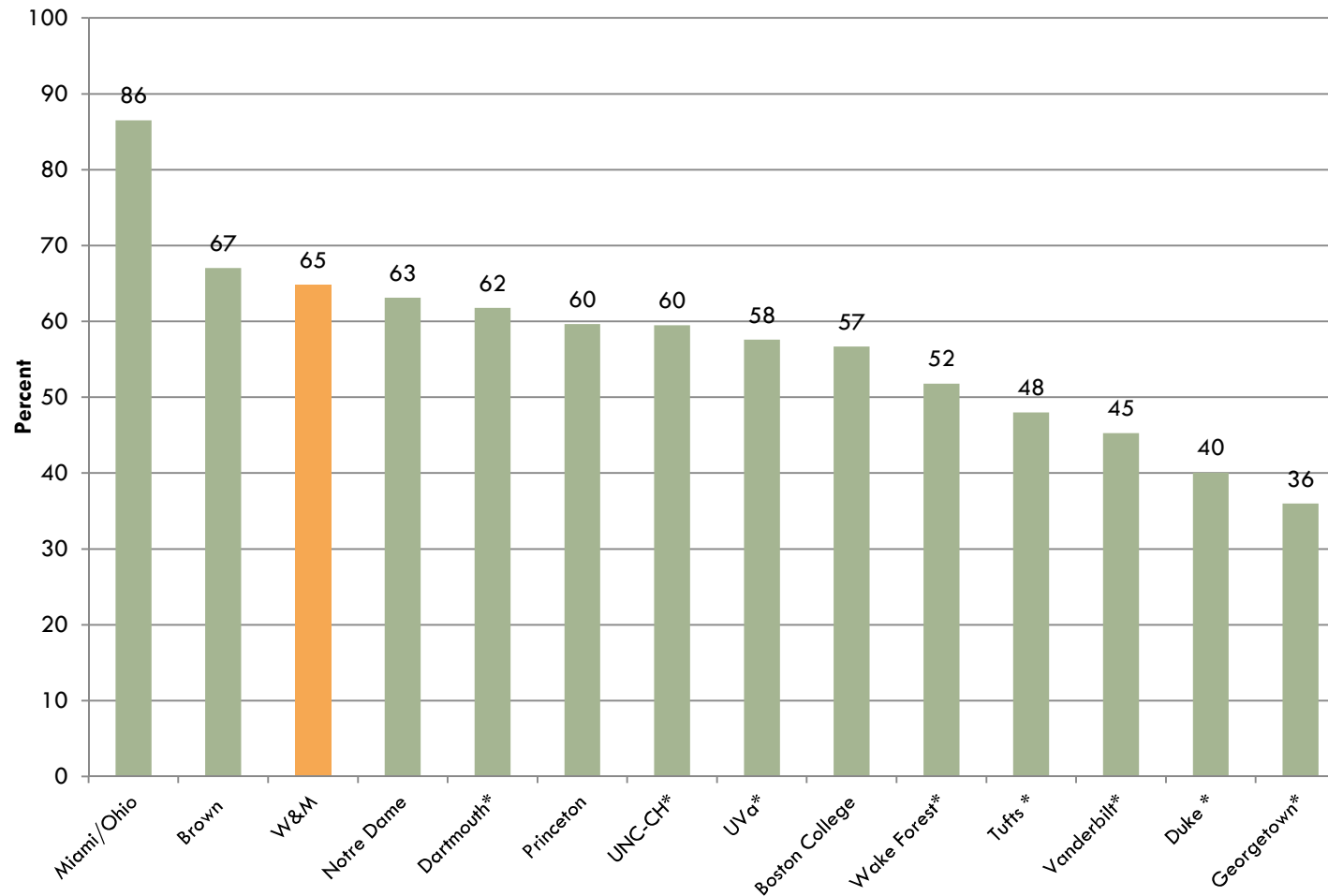
# Undergraduate graduation rate by gender

(Awarded between July 1, 2008 and June 30, 2009)



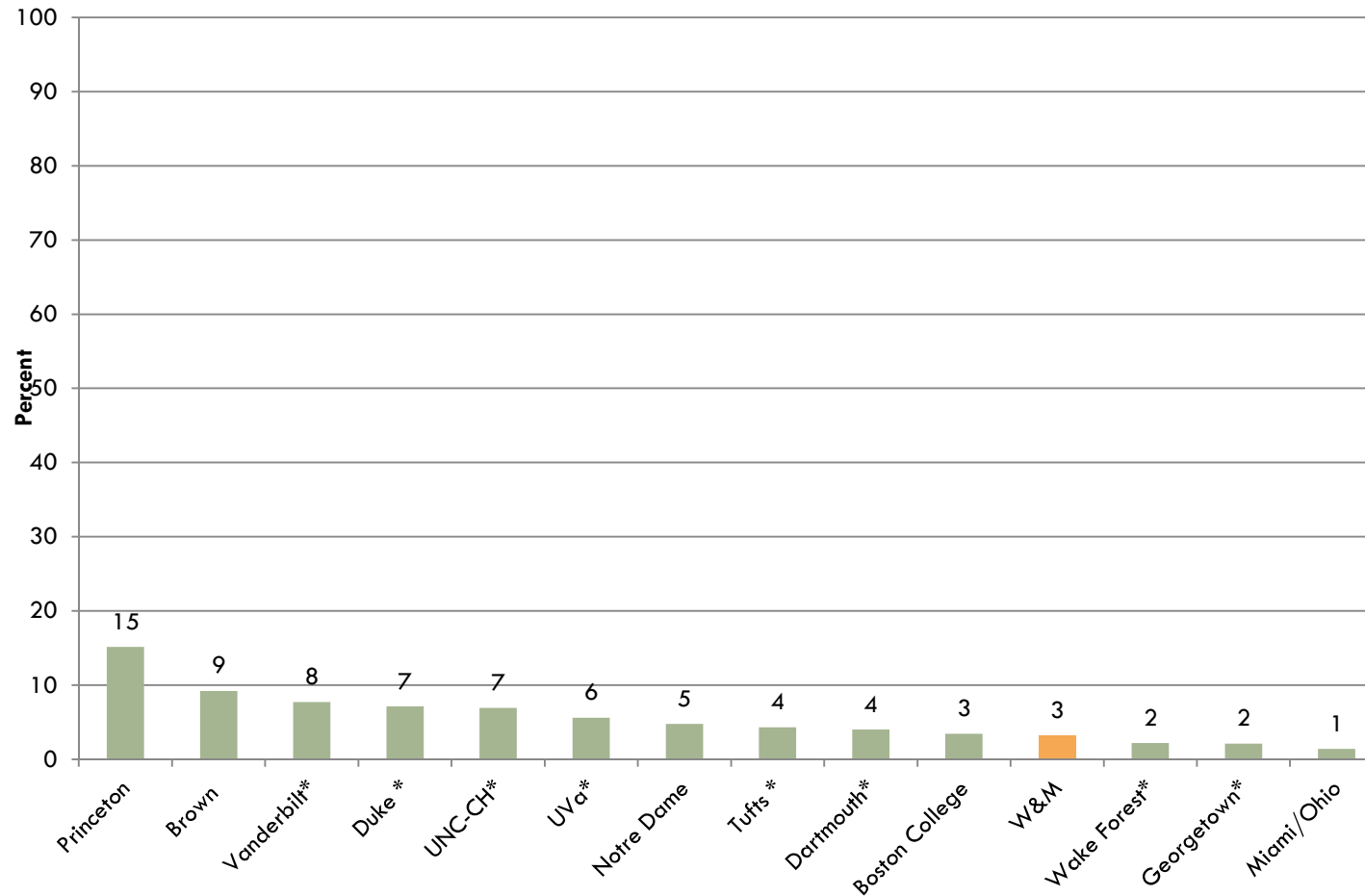

(Awarded between July 1, 2008 and June 30, 2009)



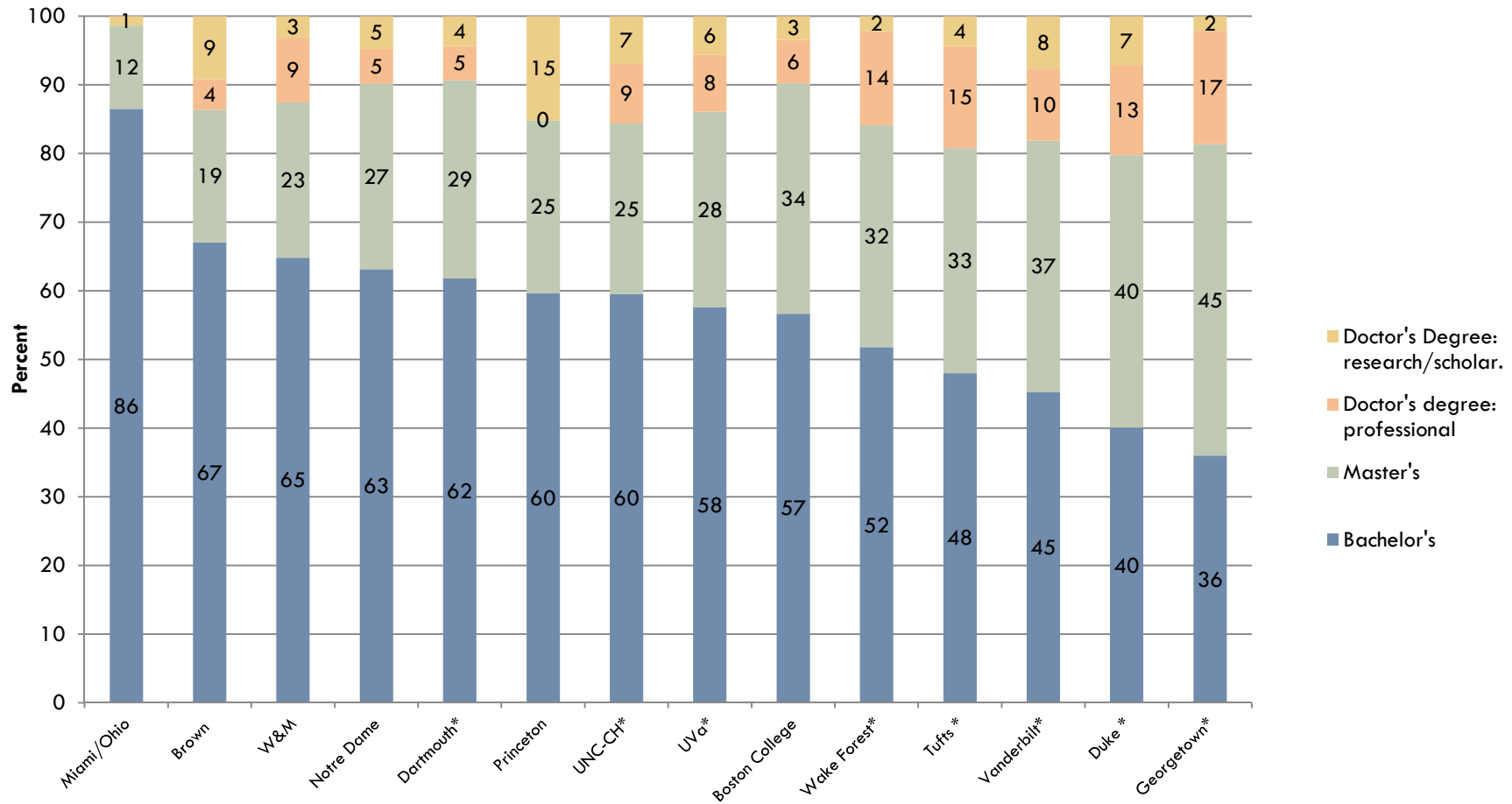

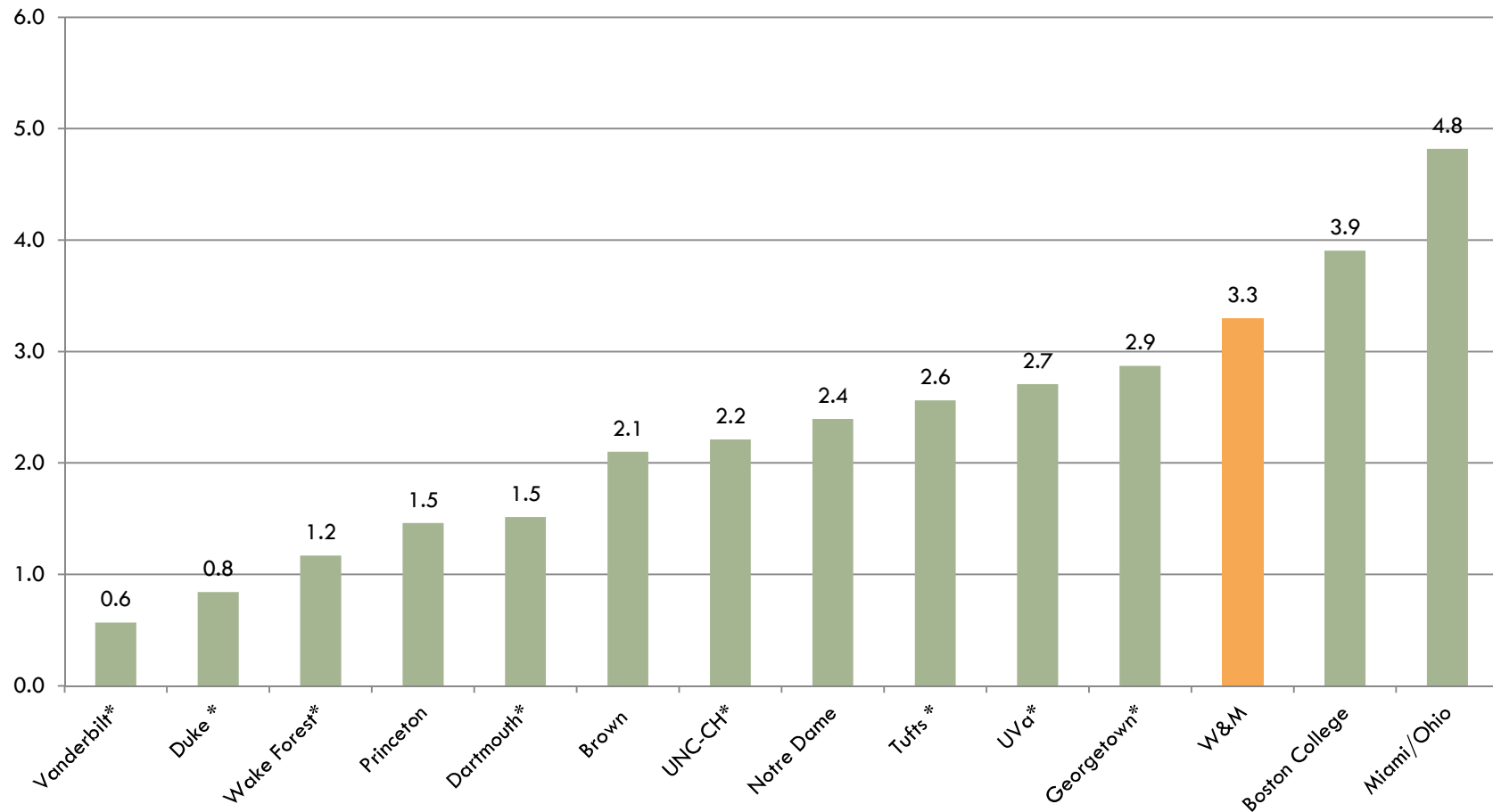

# Ratio of FTE students to FTE total staff (2009/2010)



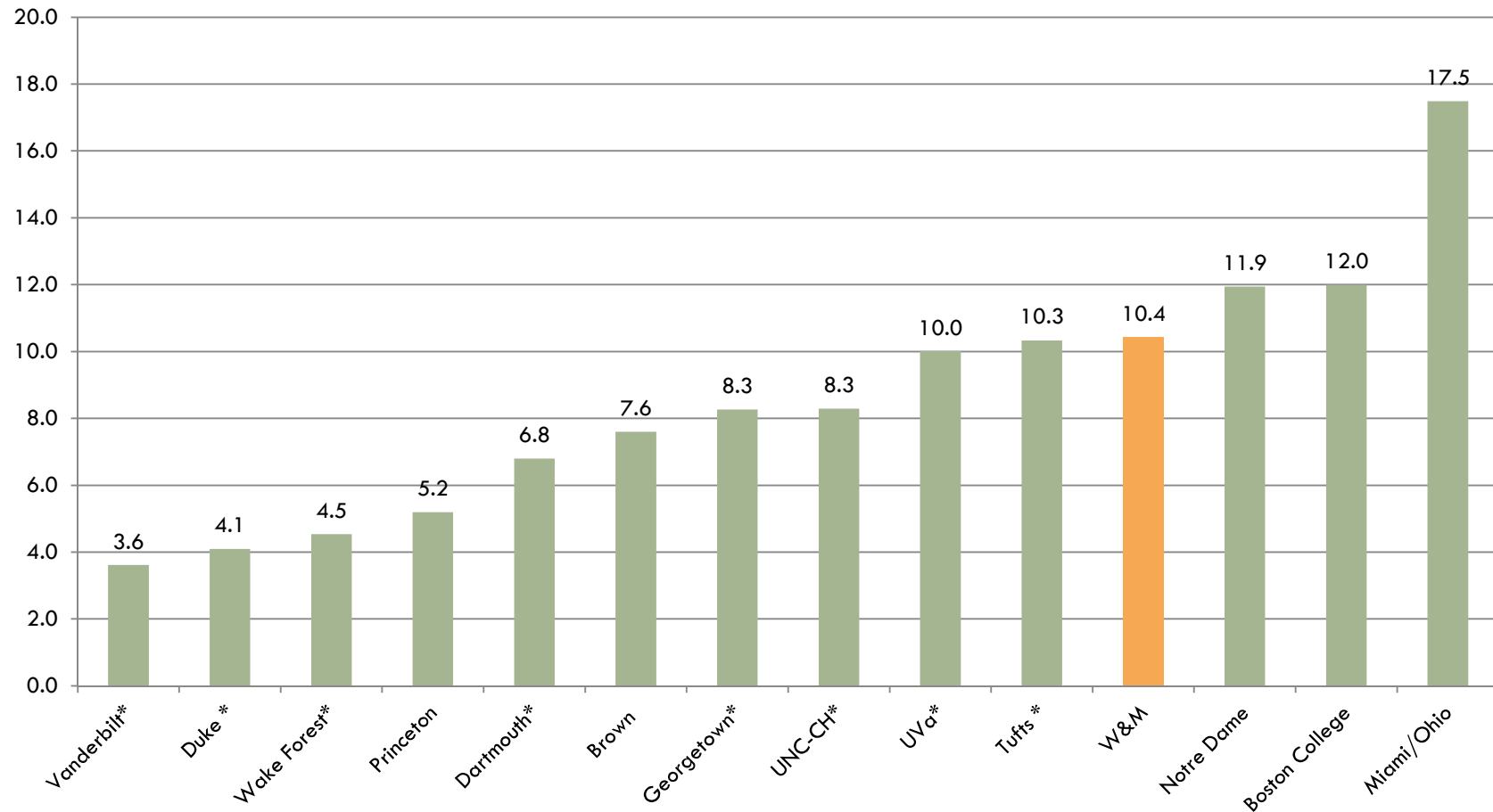

# Ratio of FTE students to FTE total faculty (2009/2010)



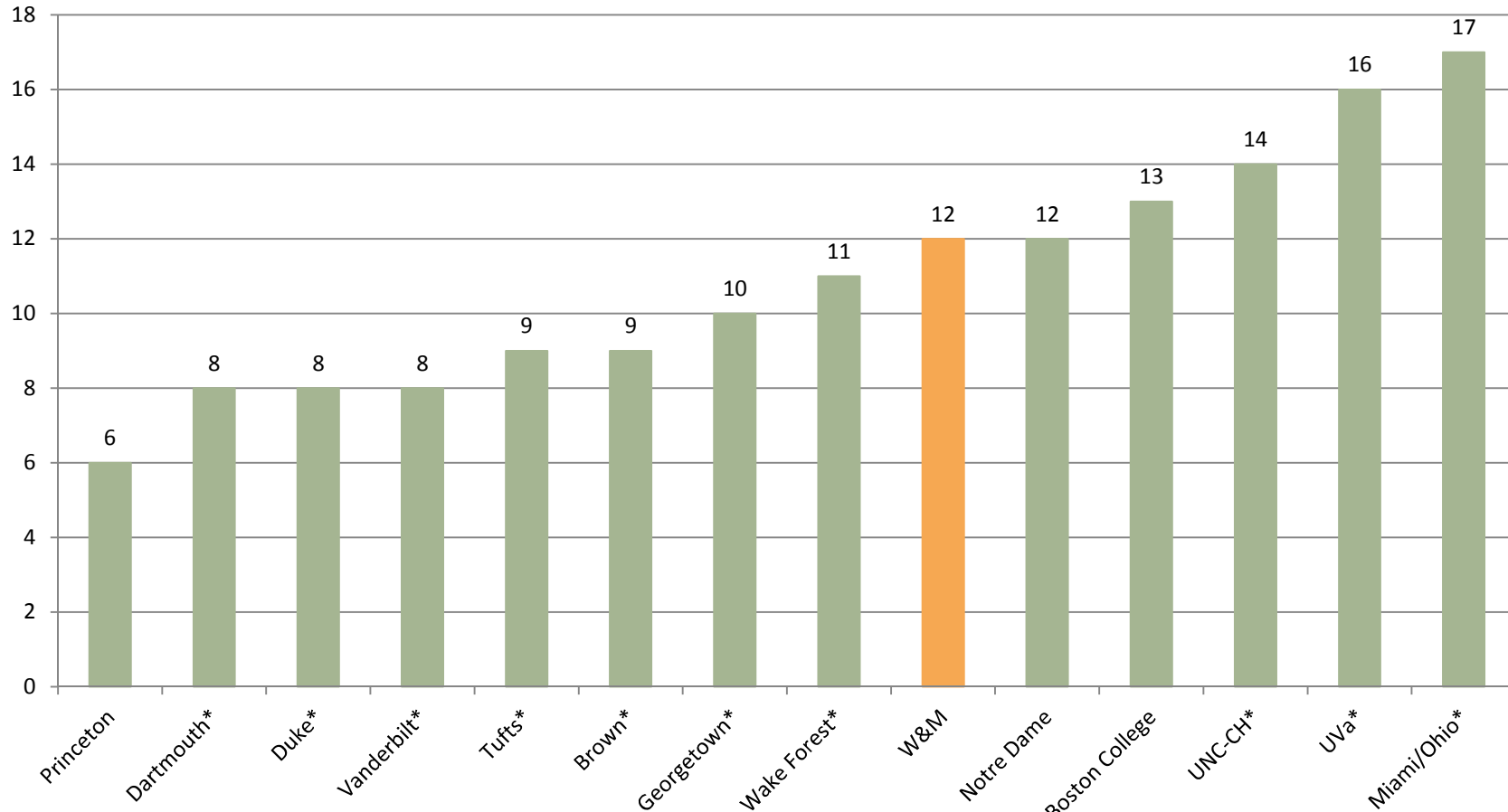

# Student to faculty ratio (2009/2010)



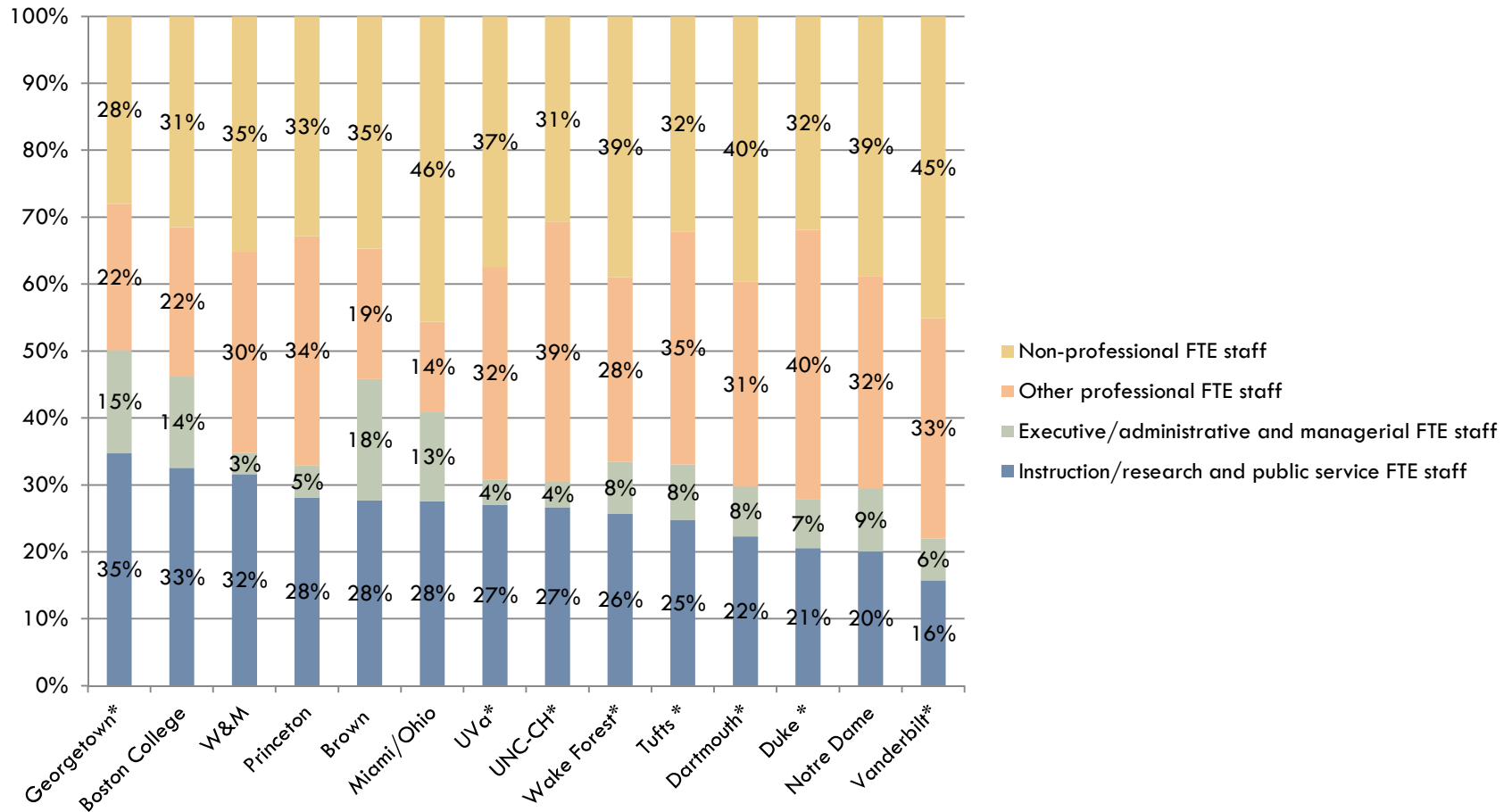

# Percentage of FTE staff by function (2009/2010)



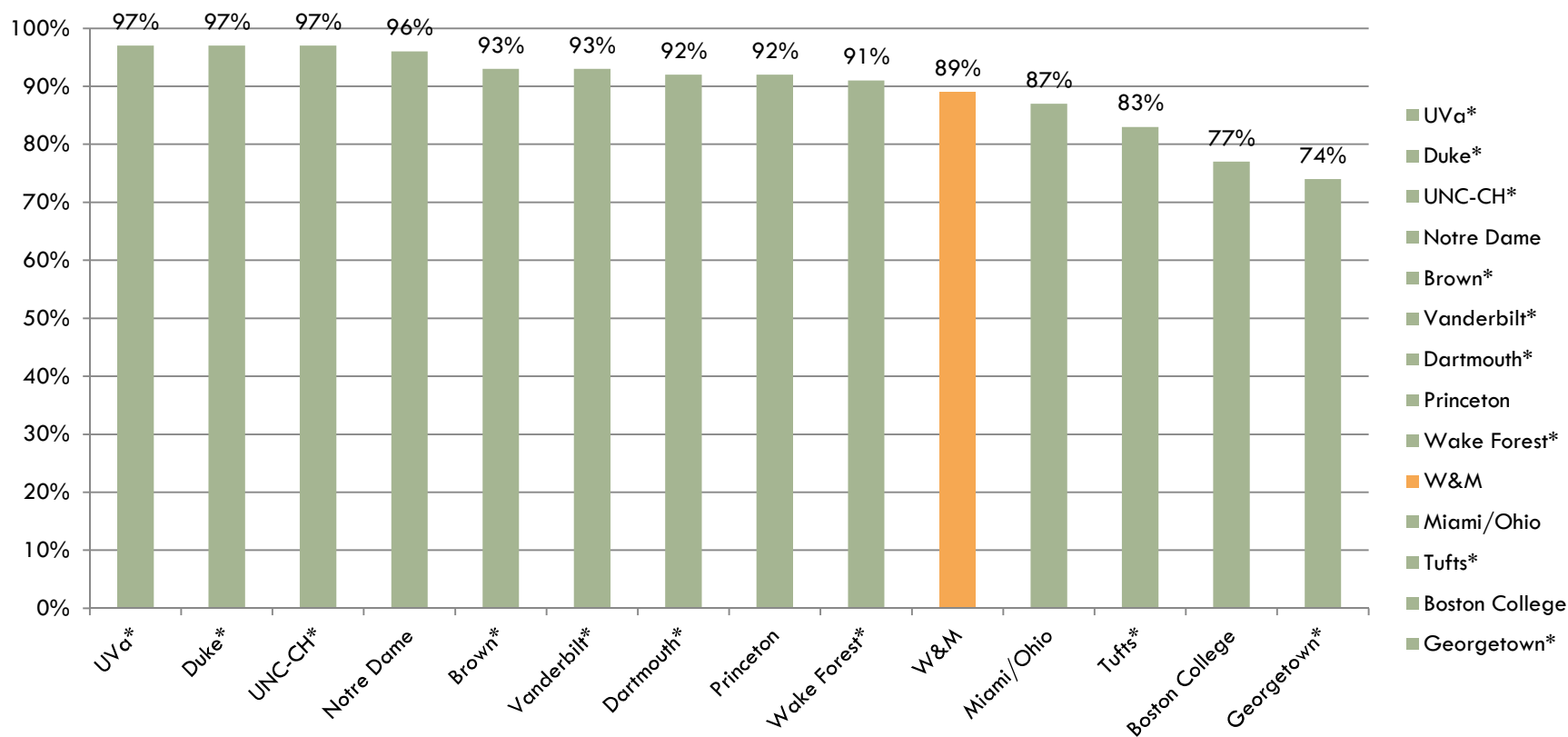

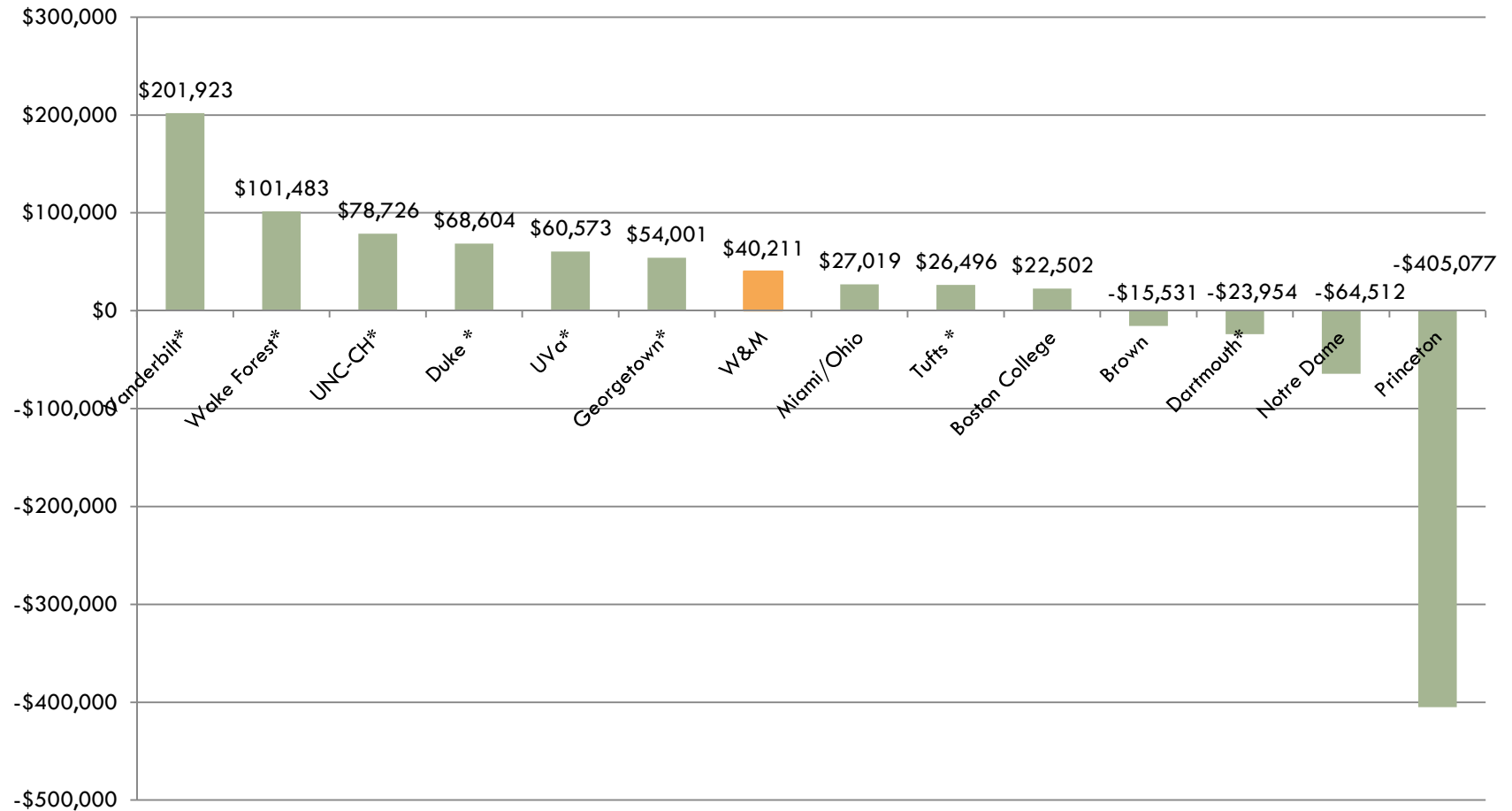

# Total revenues per FTE student (FY2009-10)

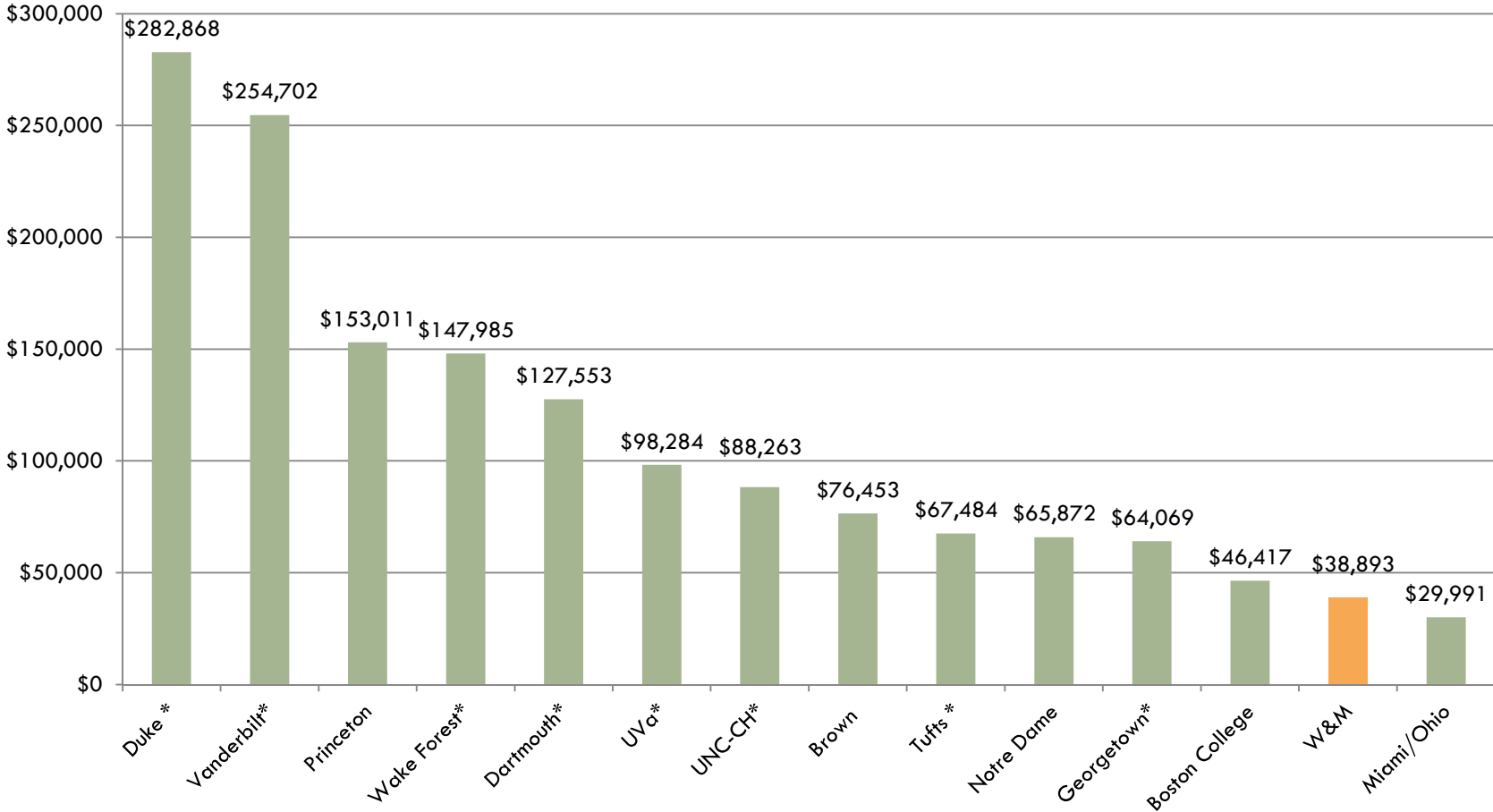

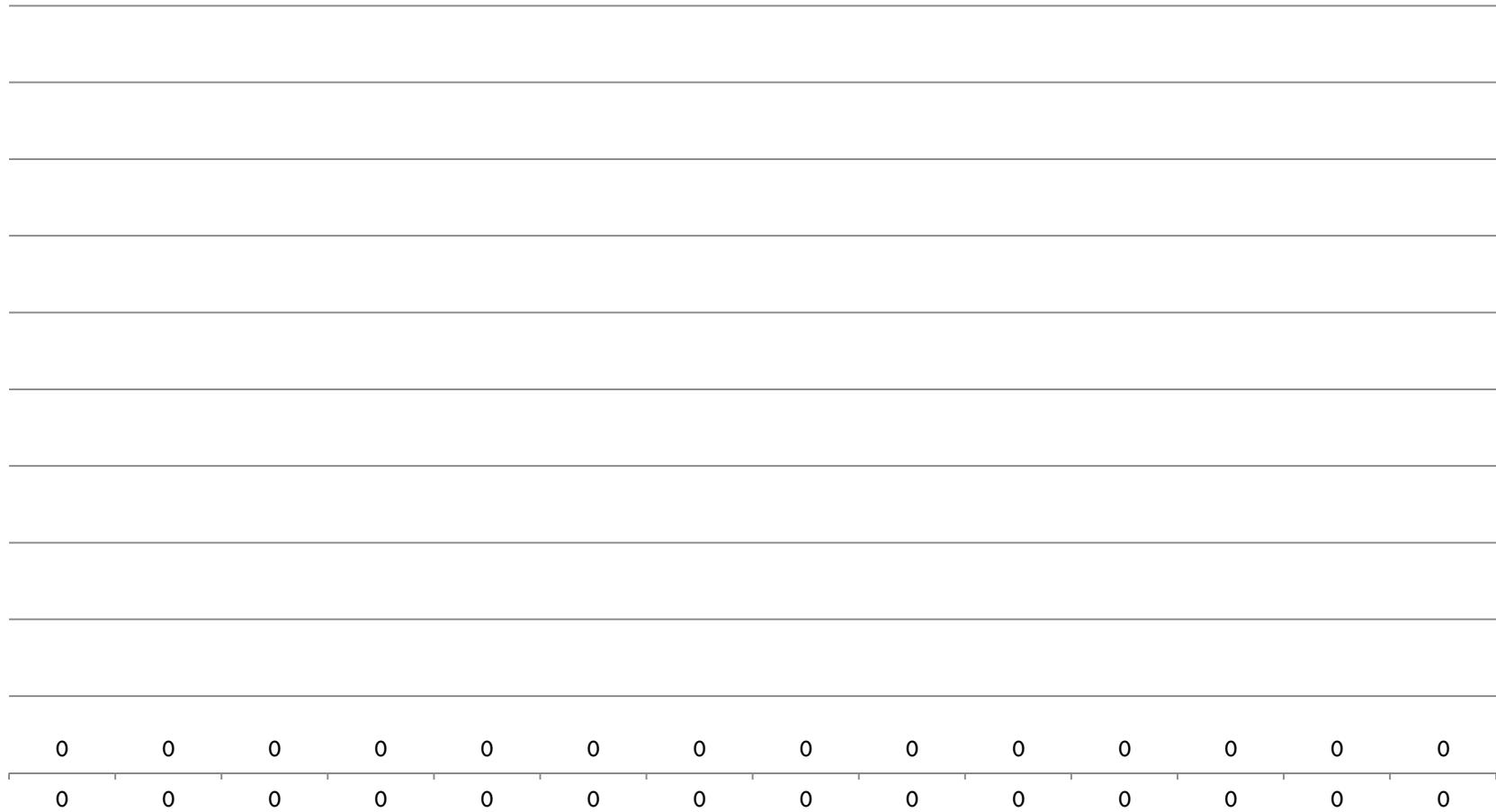

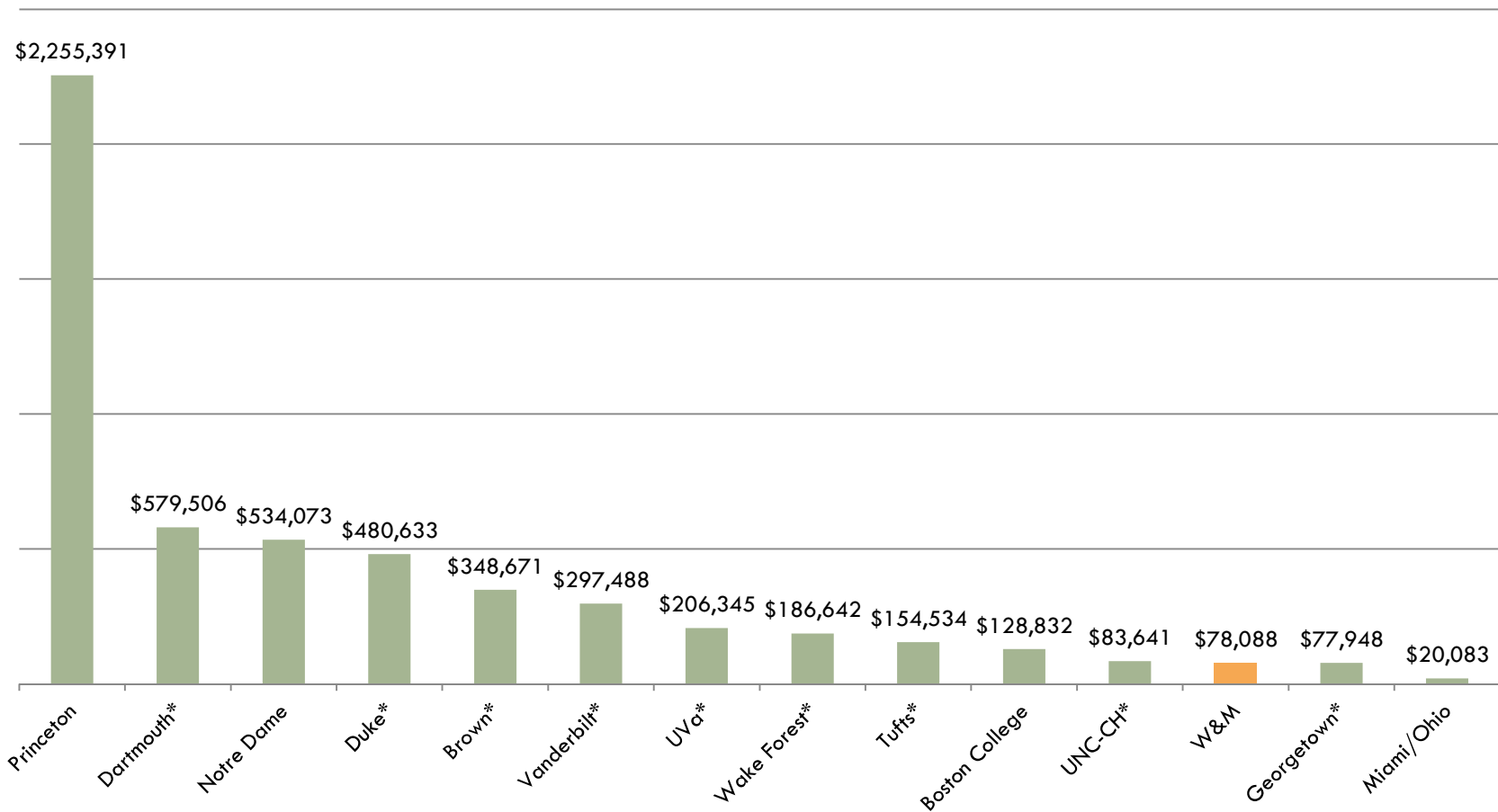
# Endowment (in millions) (FY 2007-08)

# Endowment per FTE student (FY 2007-08)

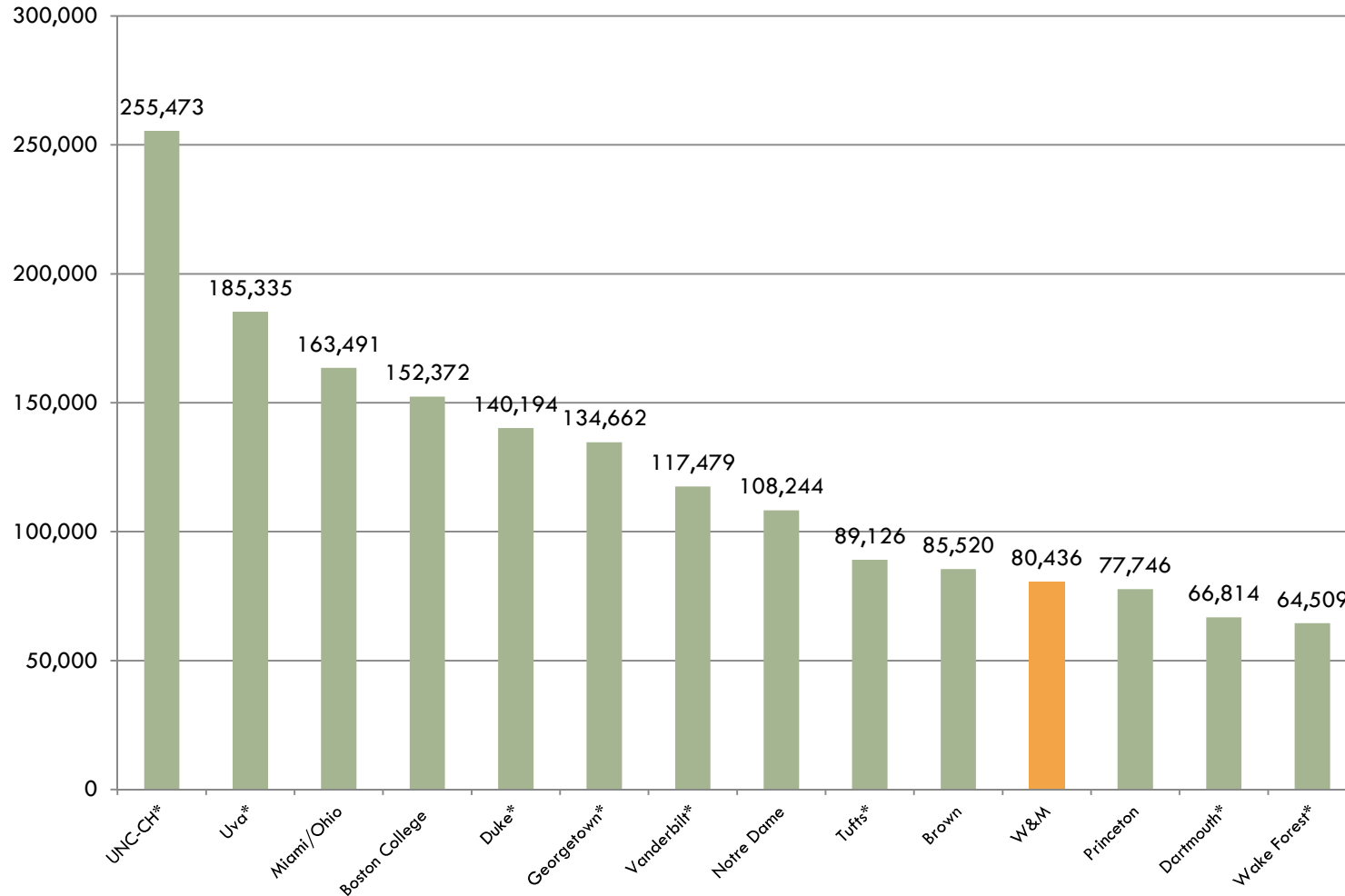

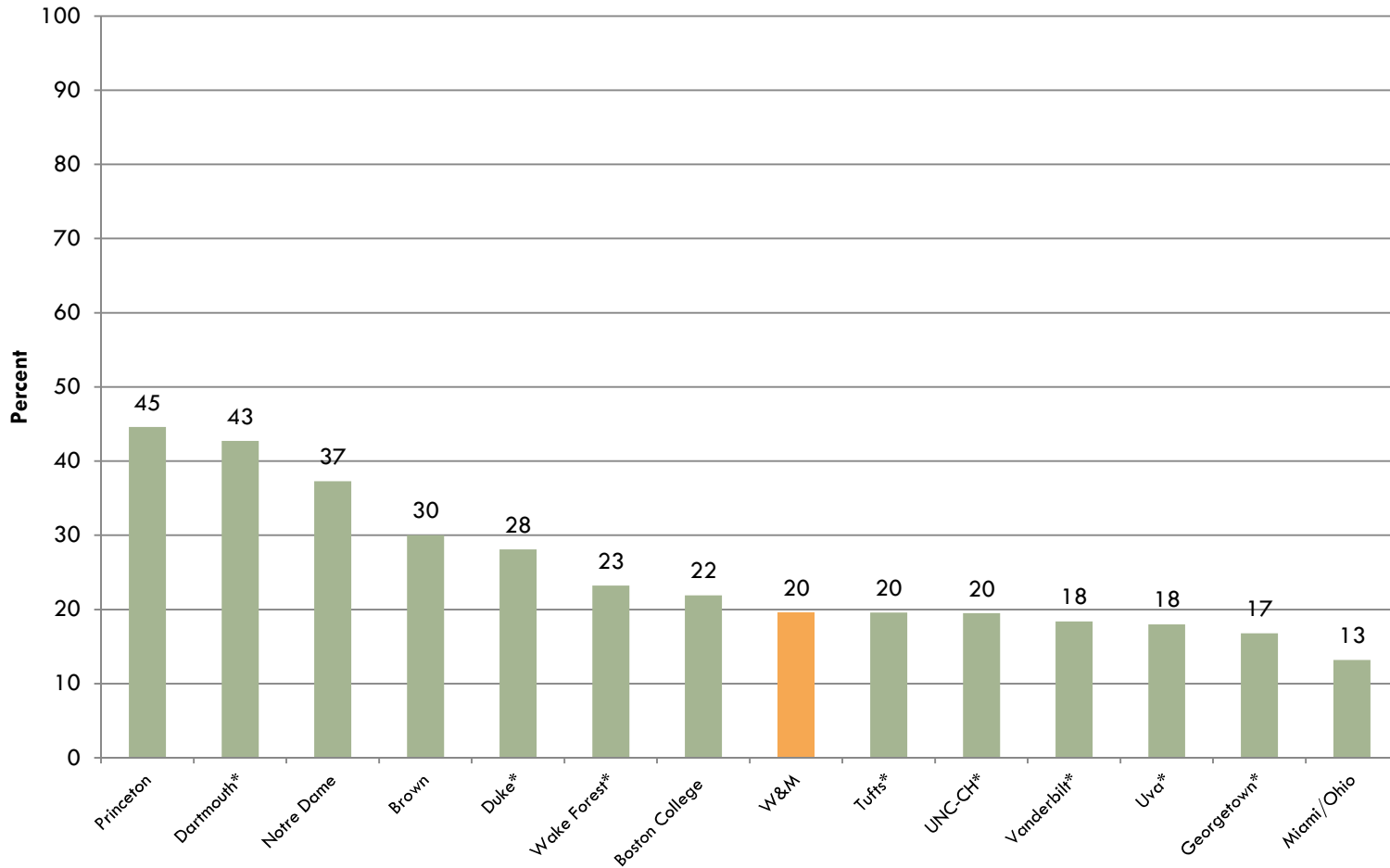
# Number of alumni of record (FY 2008-09)

# Alumni giving participation rate (FY 2008-09)

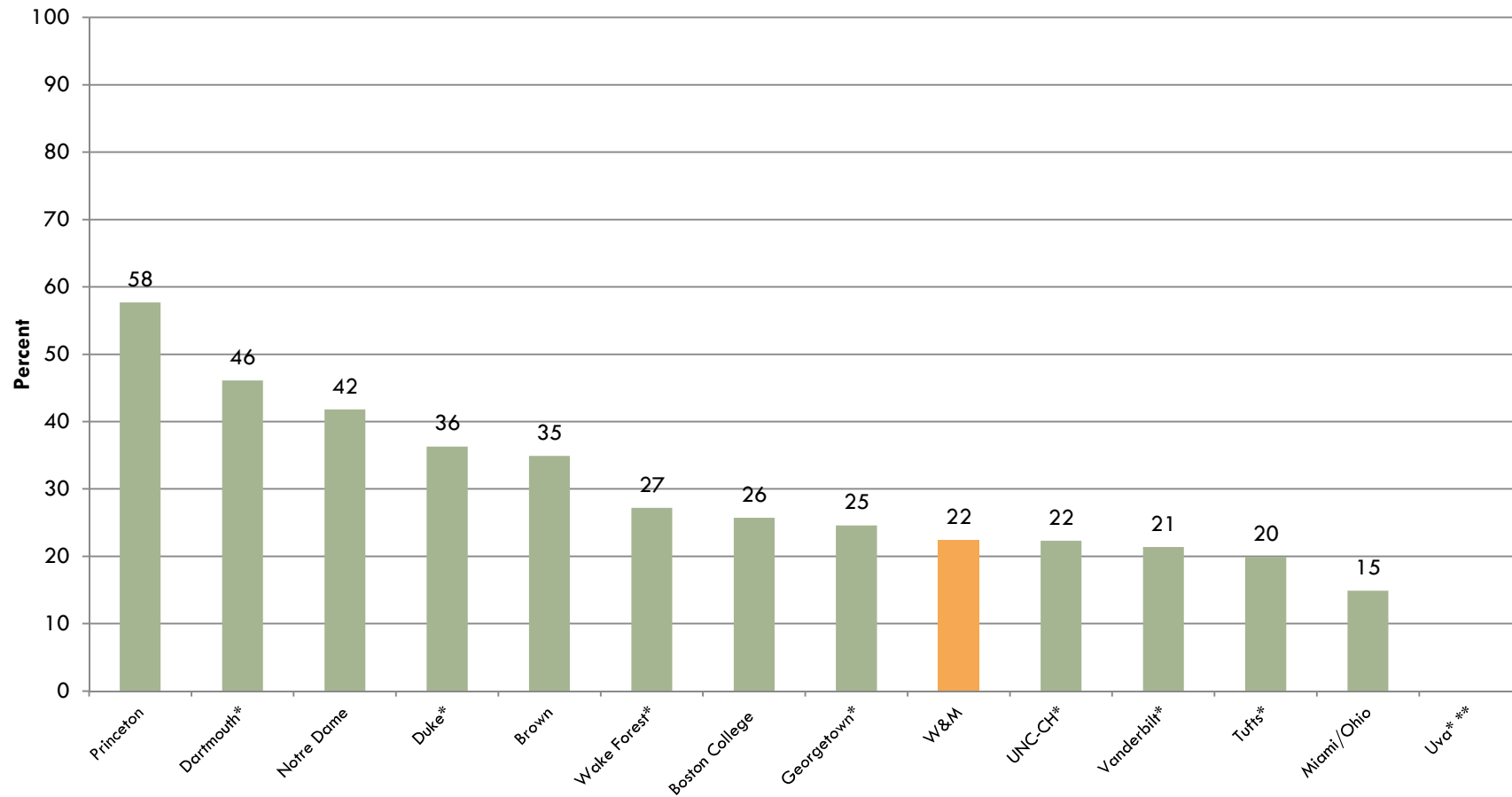

# Undergraduate alumni giving participation rate (FY 2008-09)



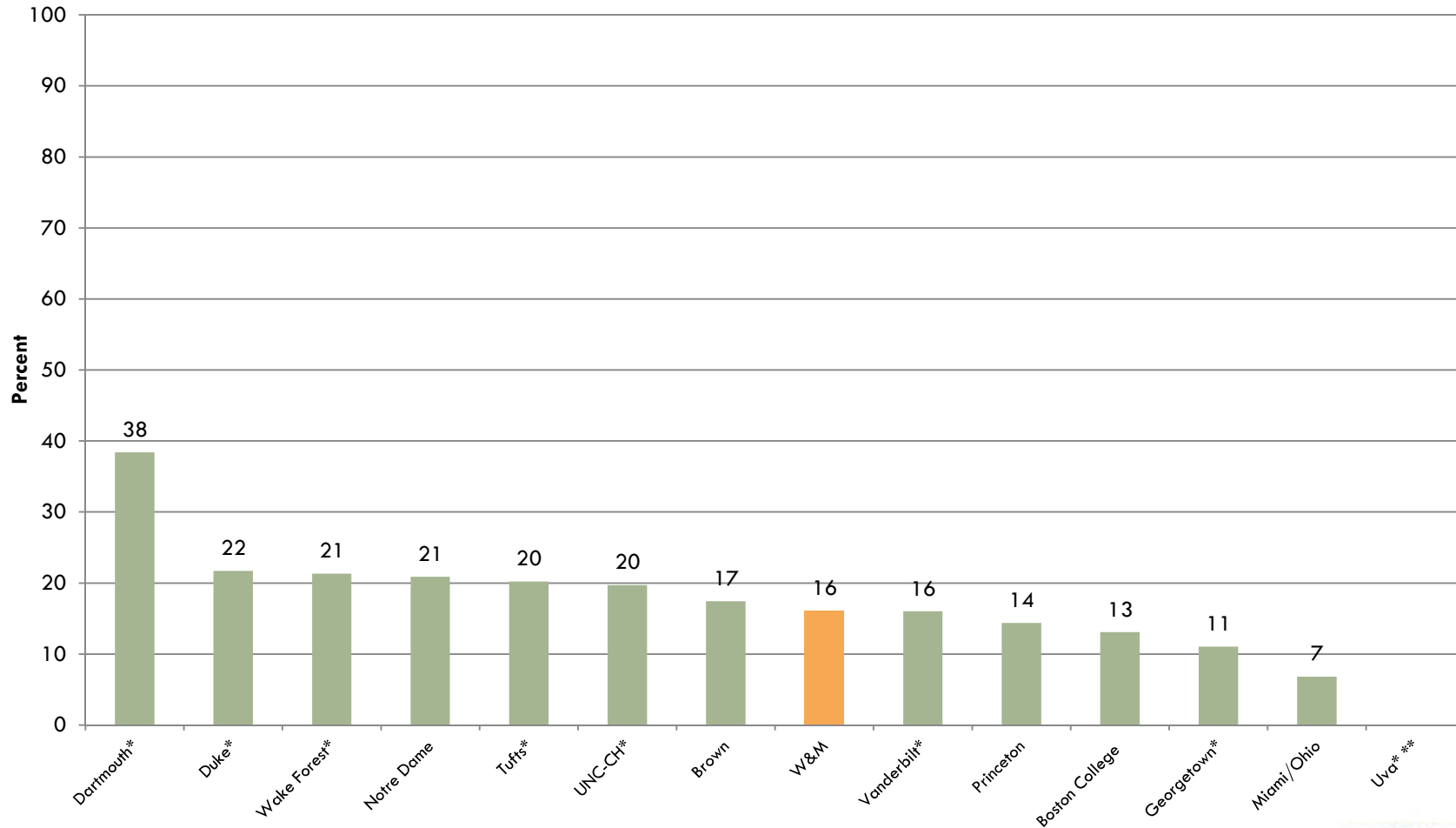

# Graduate alumni giving participation rate (FY 2008-09)



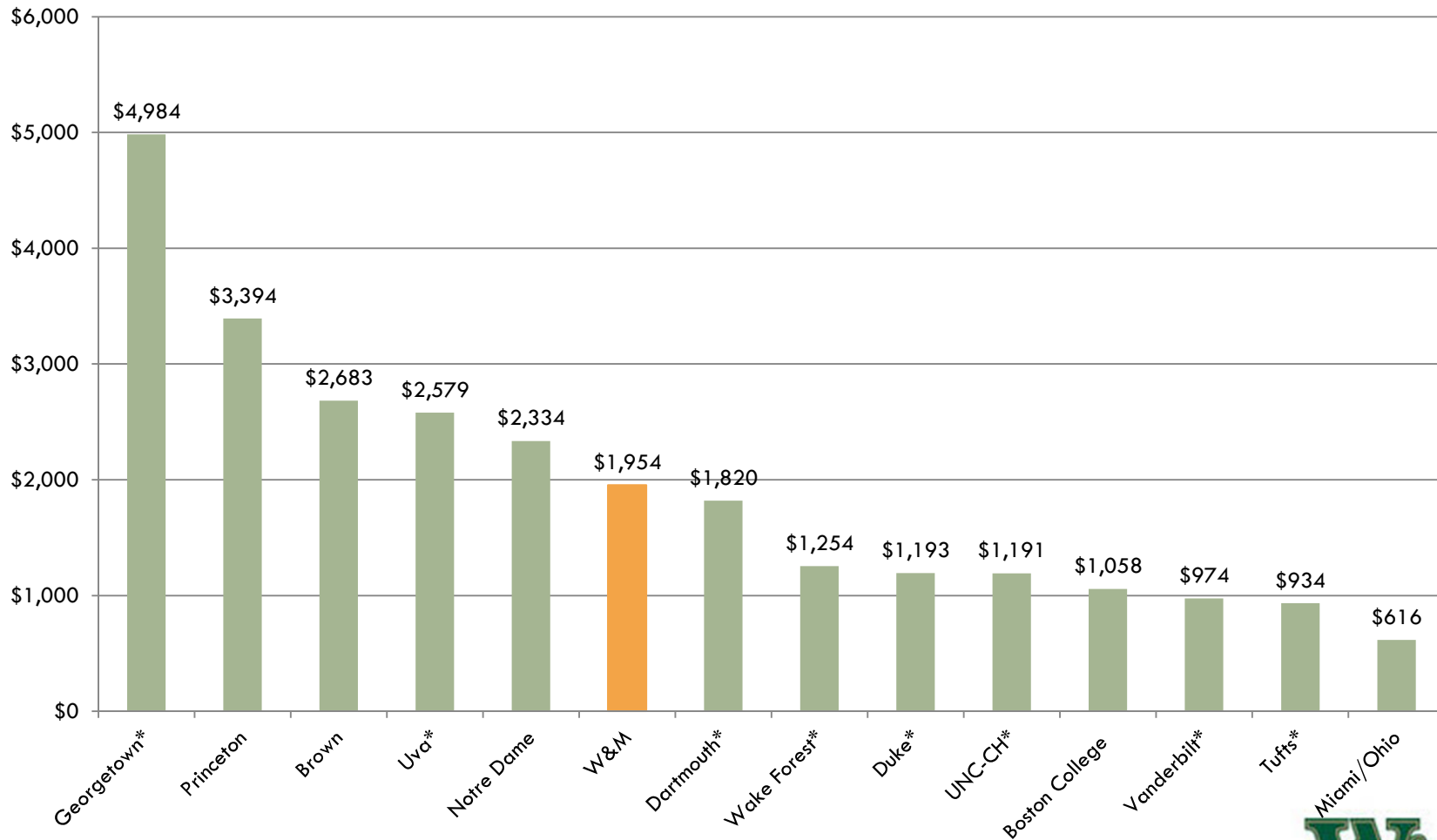

# Average alumni donor gift (FY 2008-09)

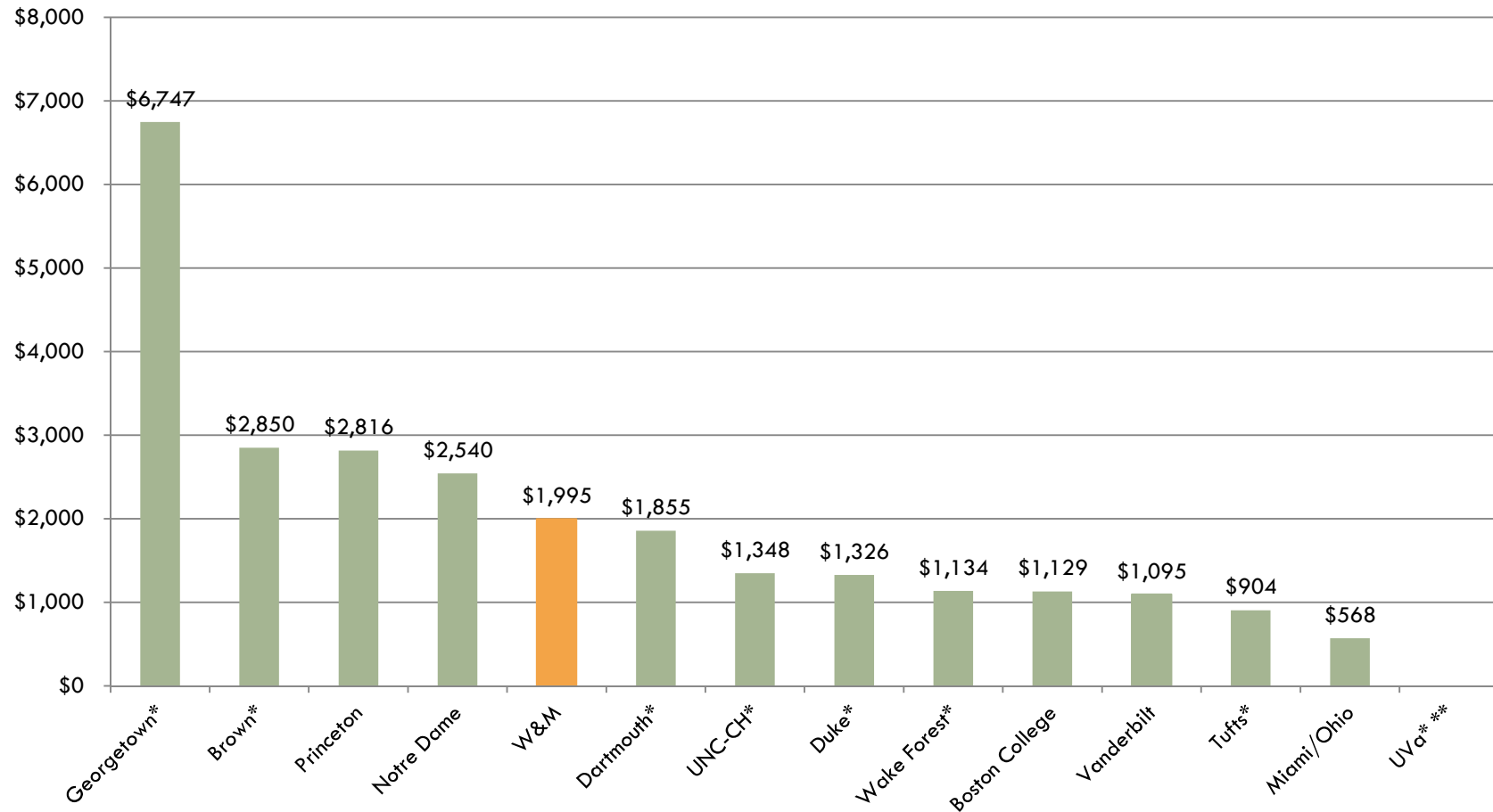

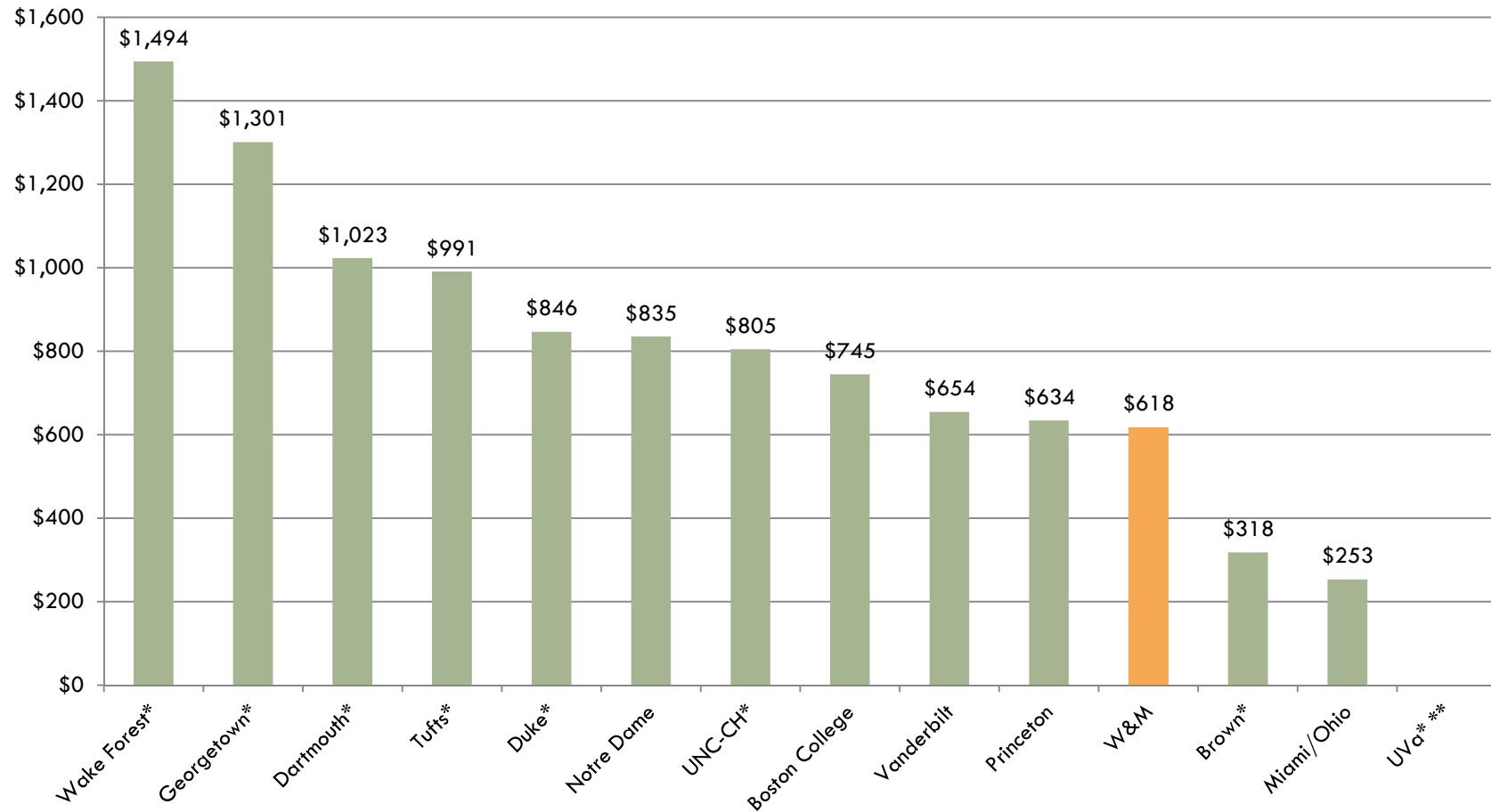

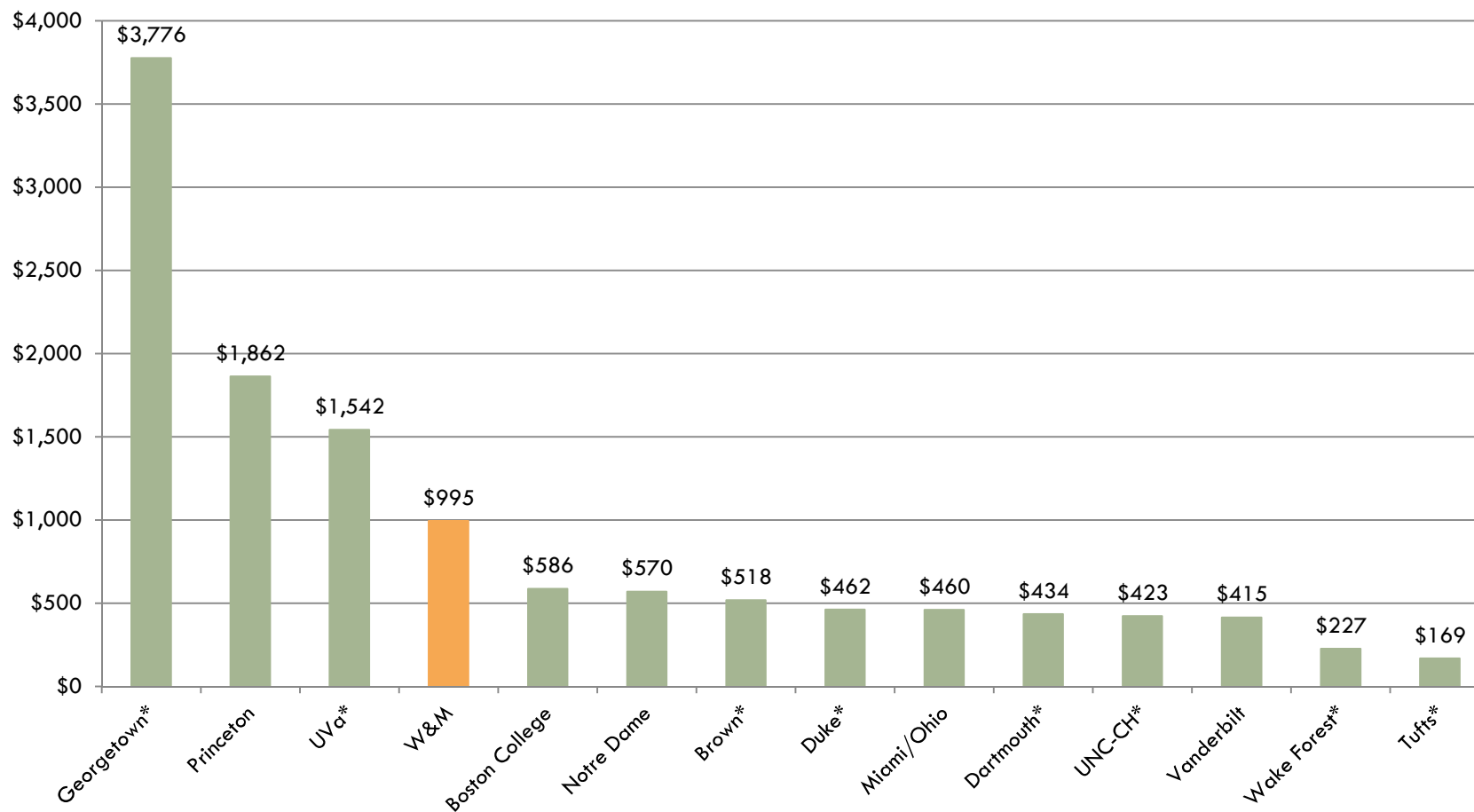

# Average alumni giving to endowment per alumni donor (FY 2008-09)

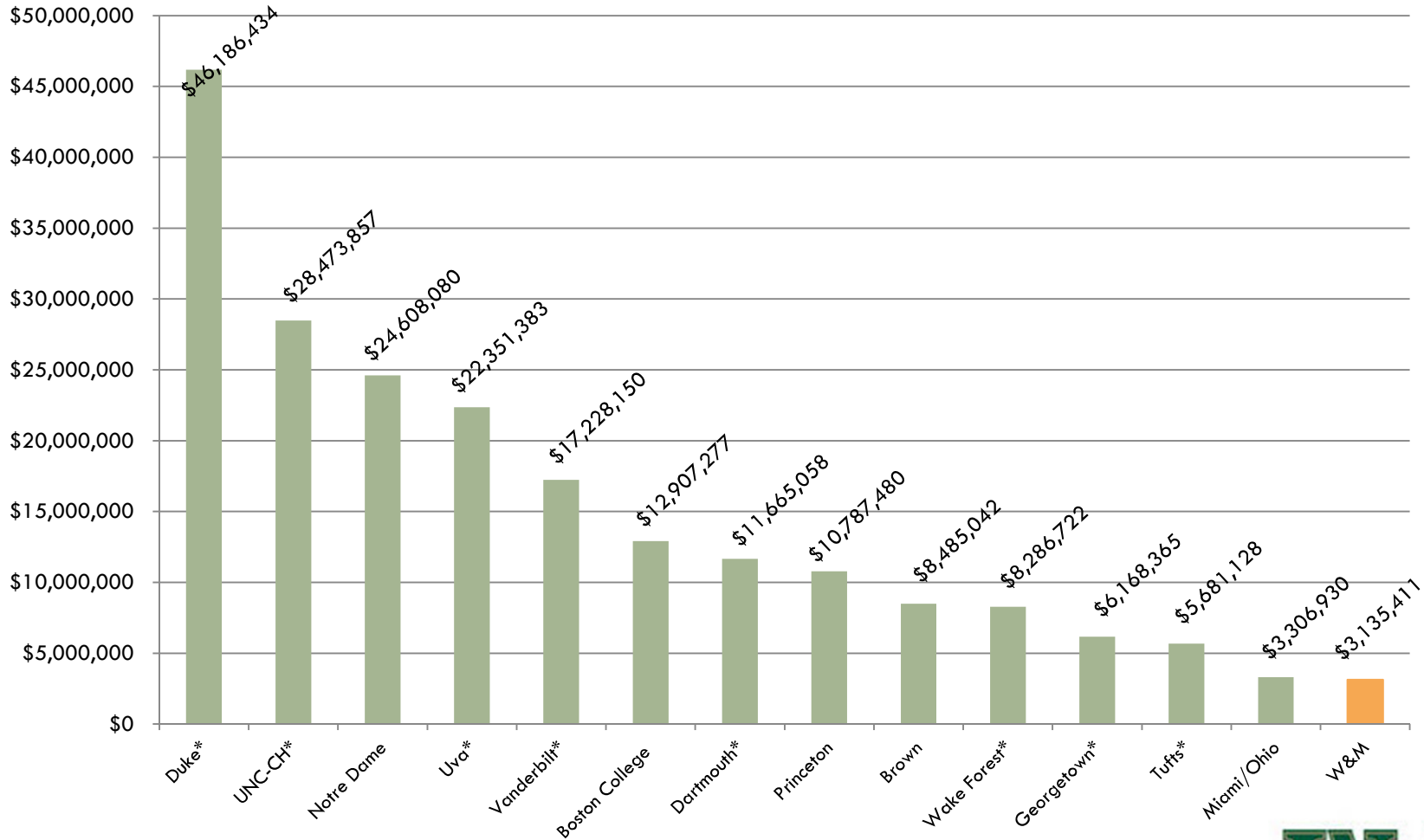

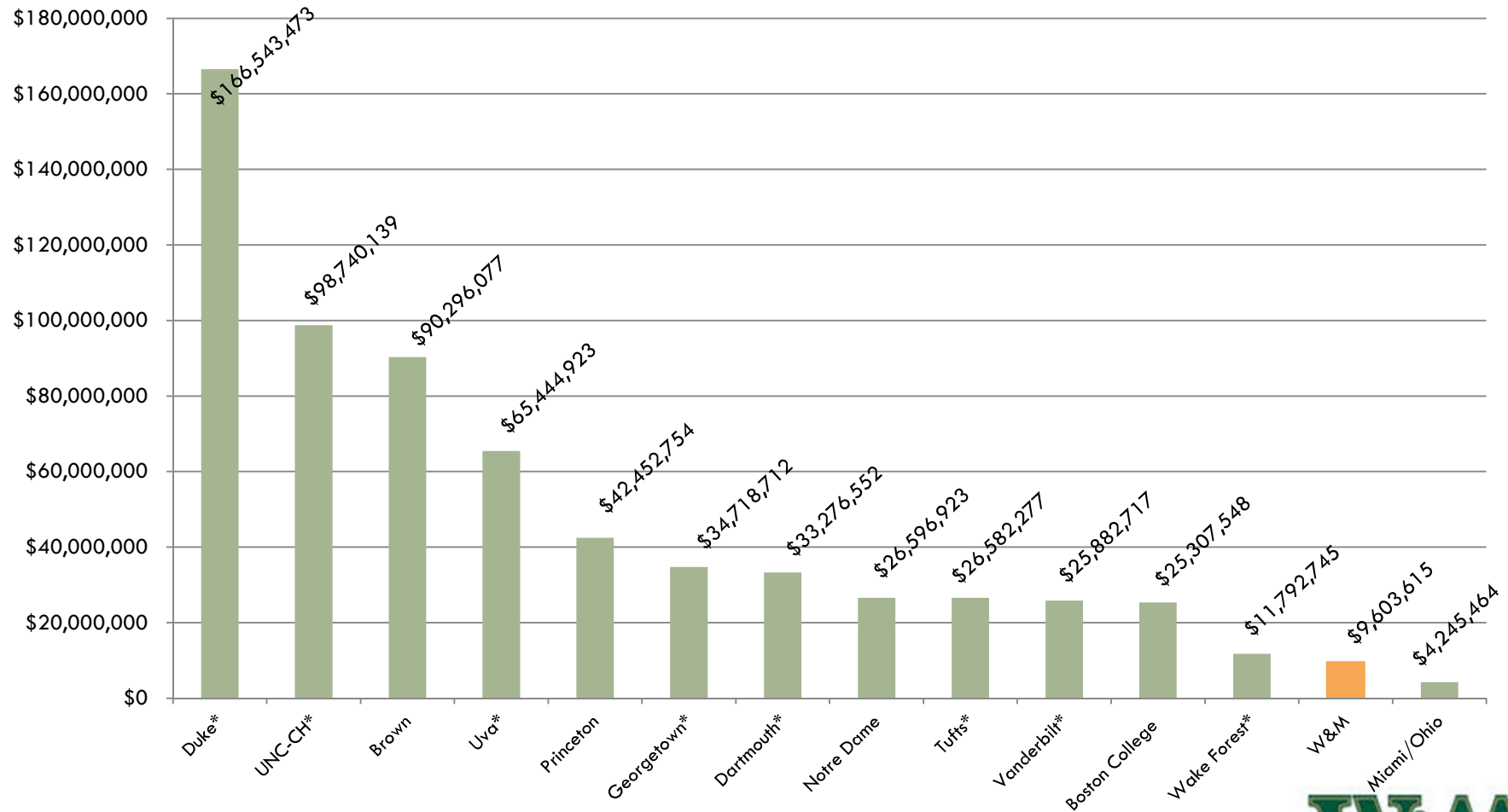
# Total corporate giving (FY 2008-09)

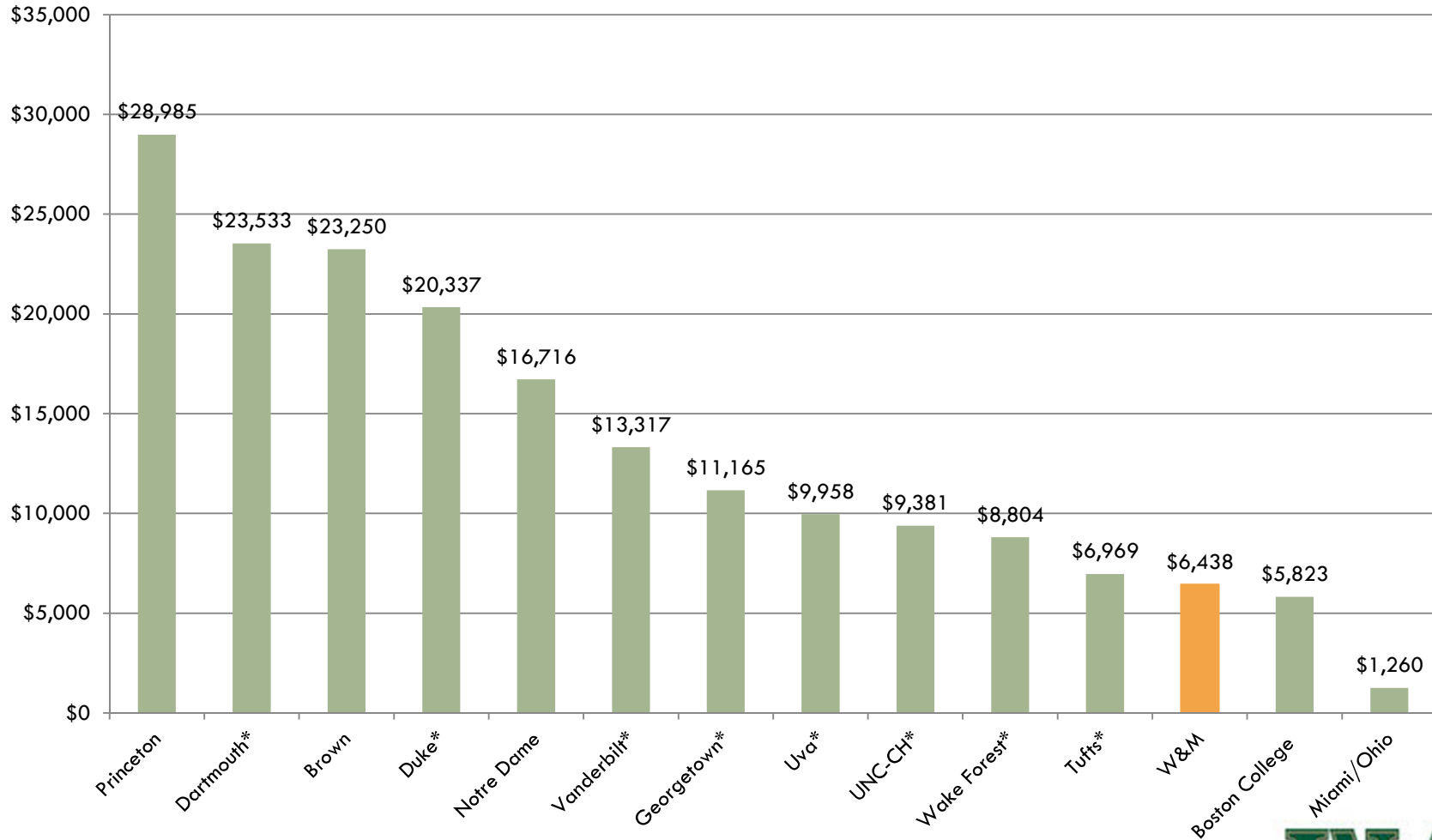
# Total foundation giving (FY 2008-09)

# Total private support per student (FY 2008-09)

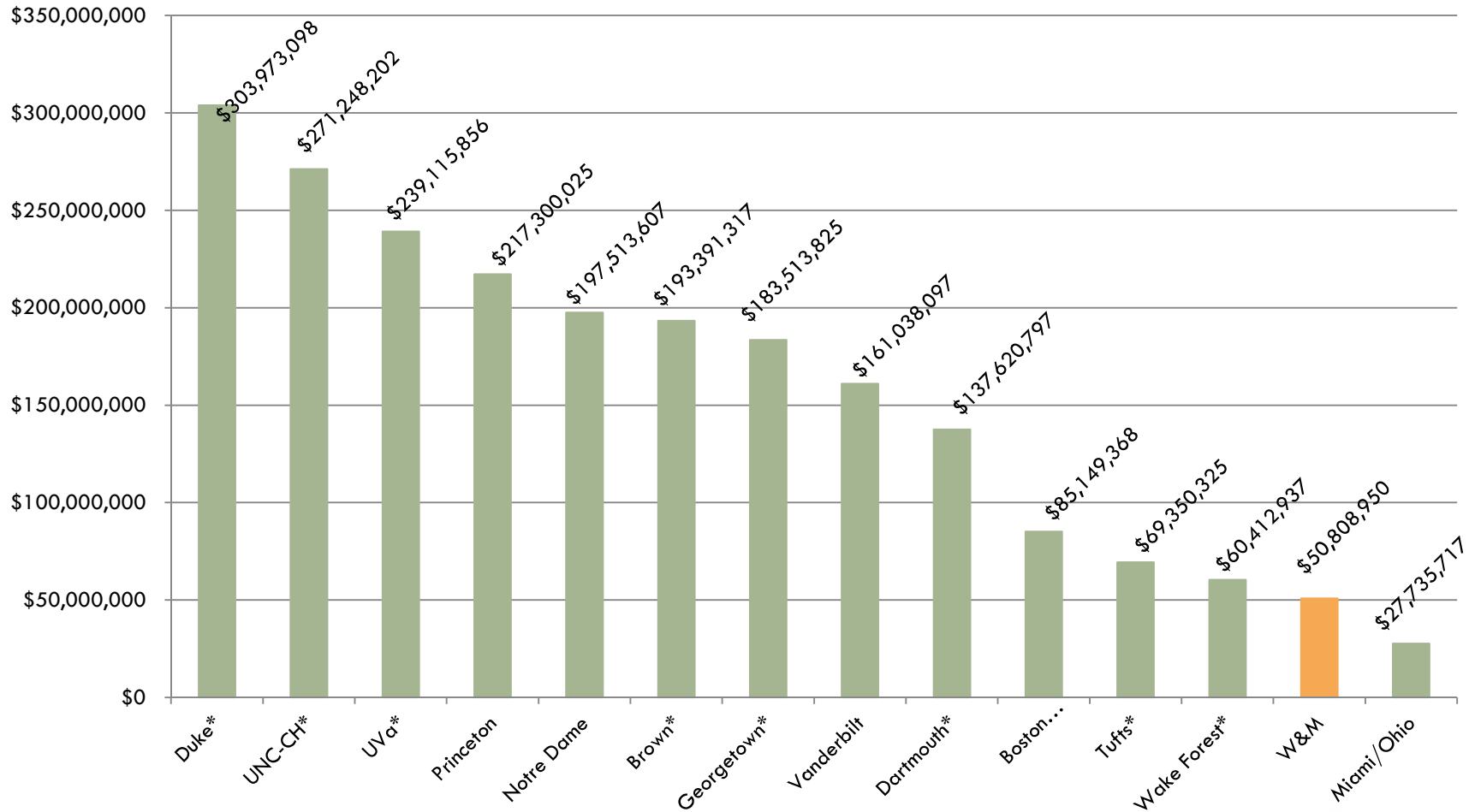

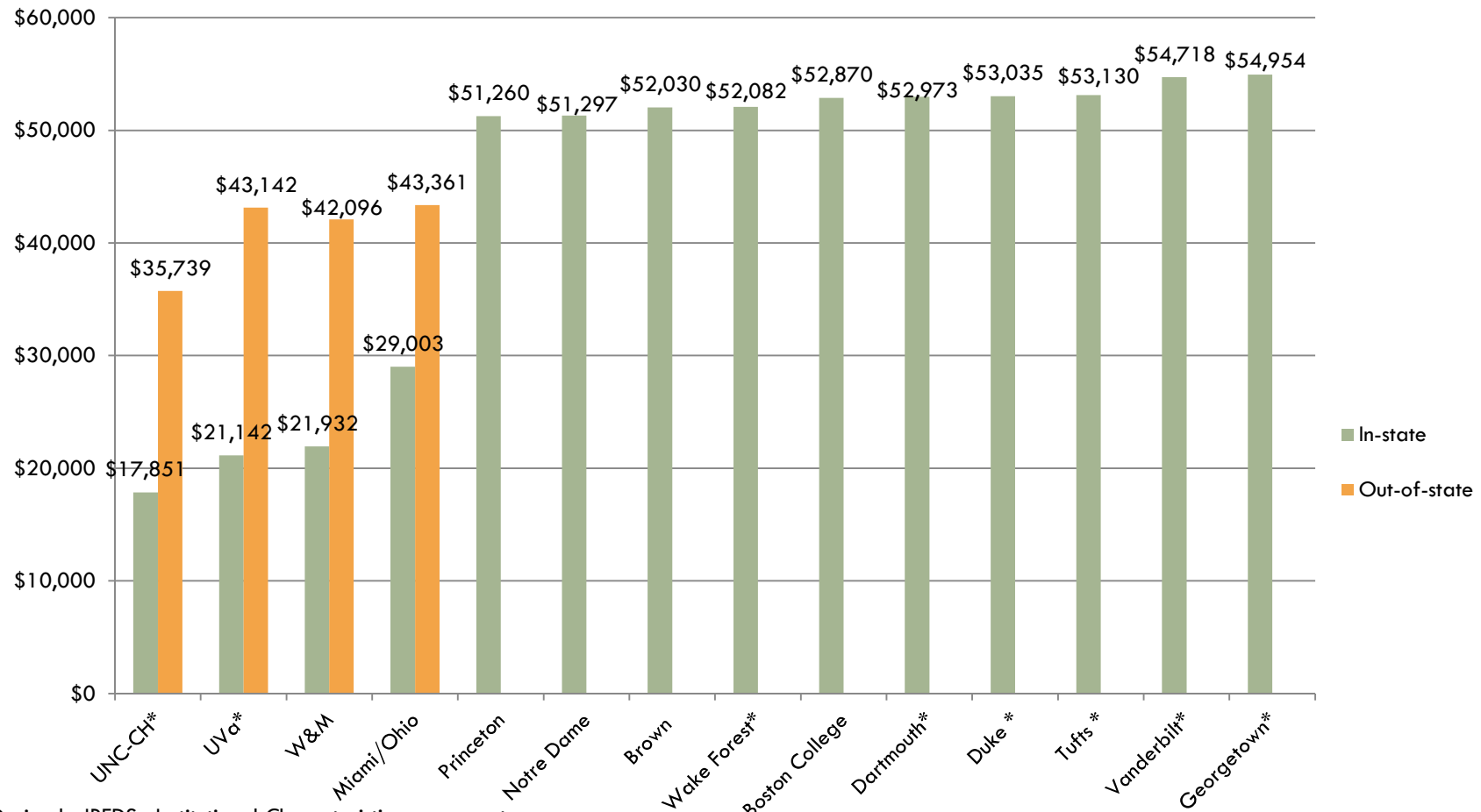

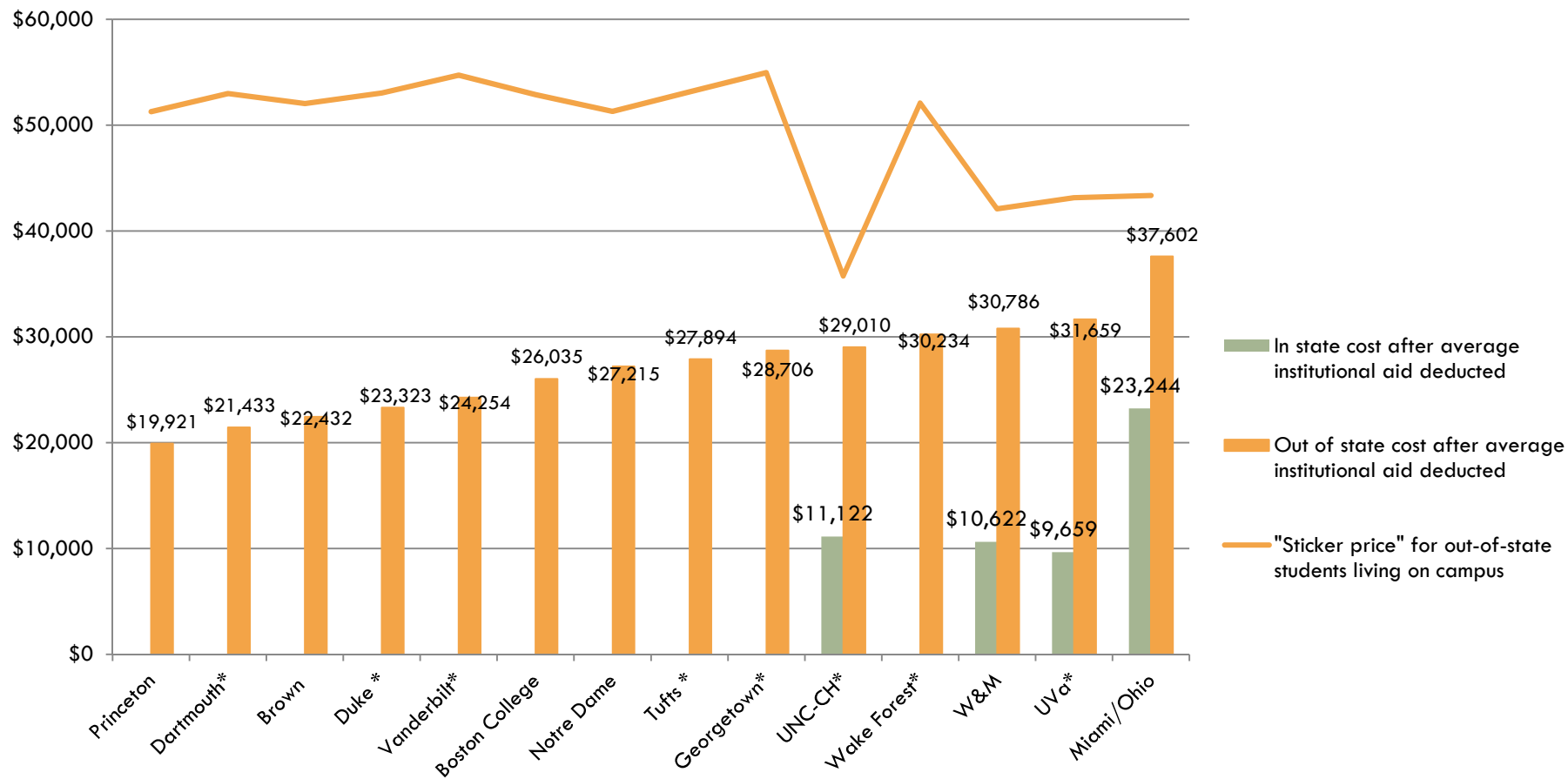

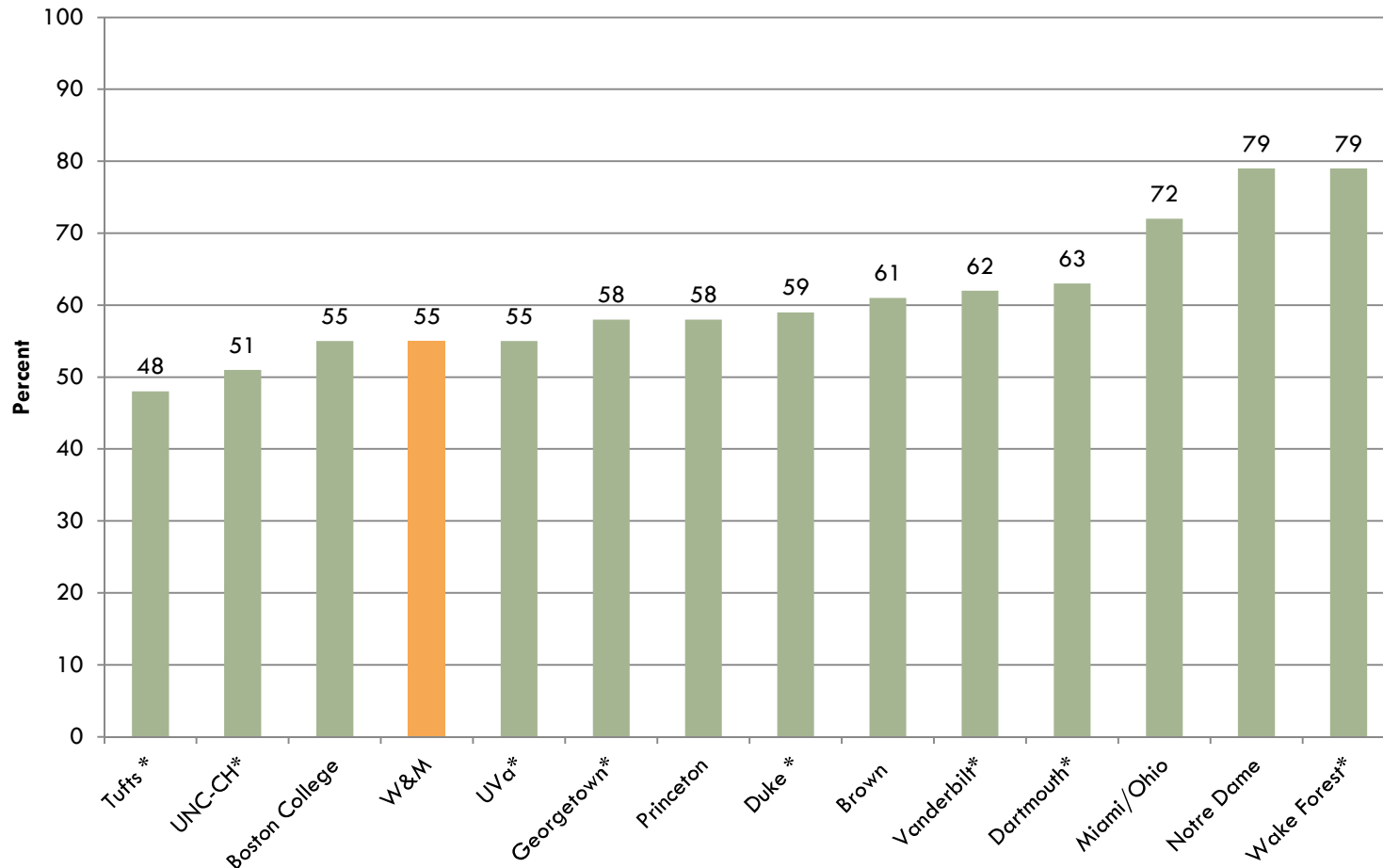

# Percent of undergraduates receiving financial aid (2008/2009)



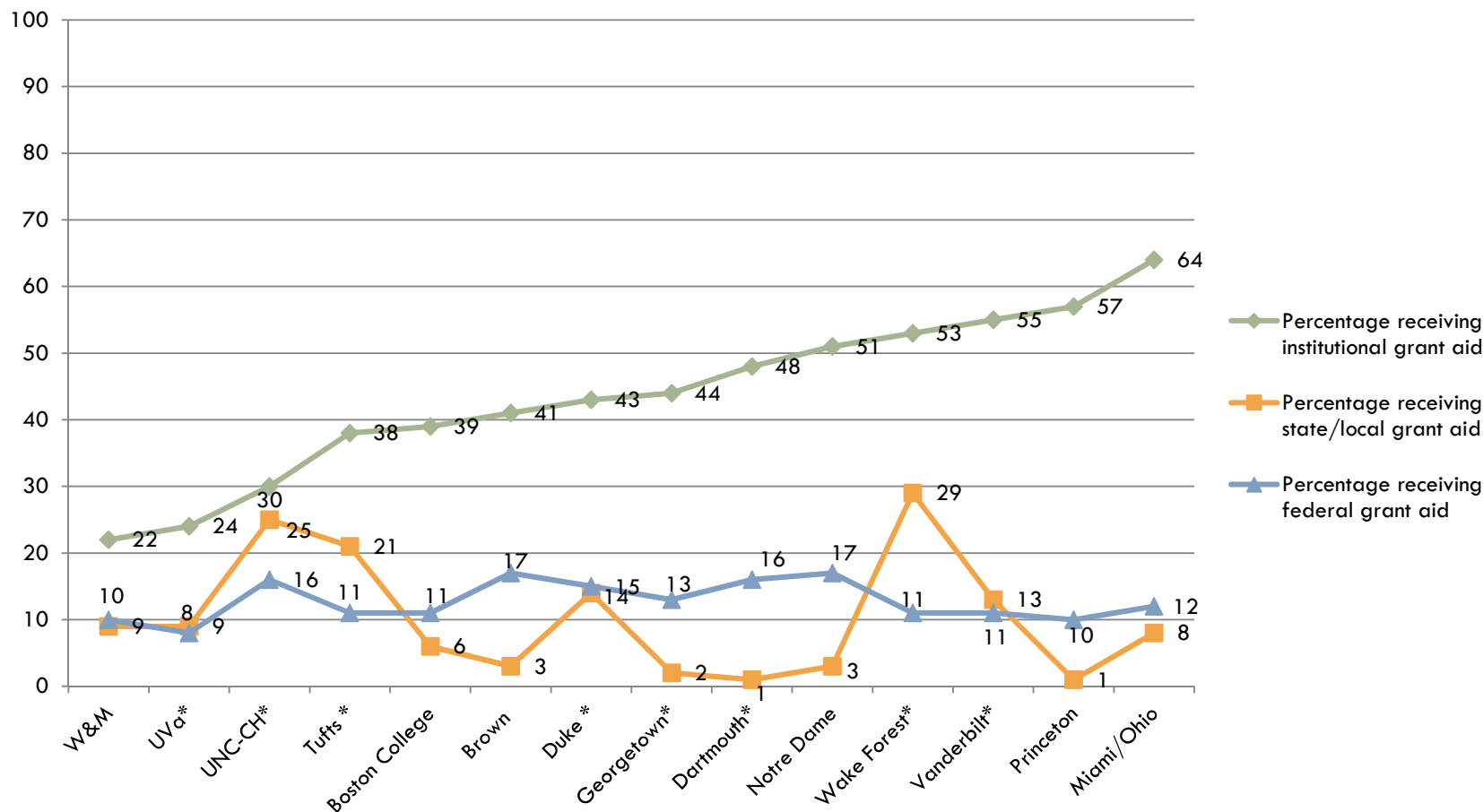

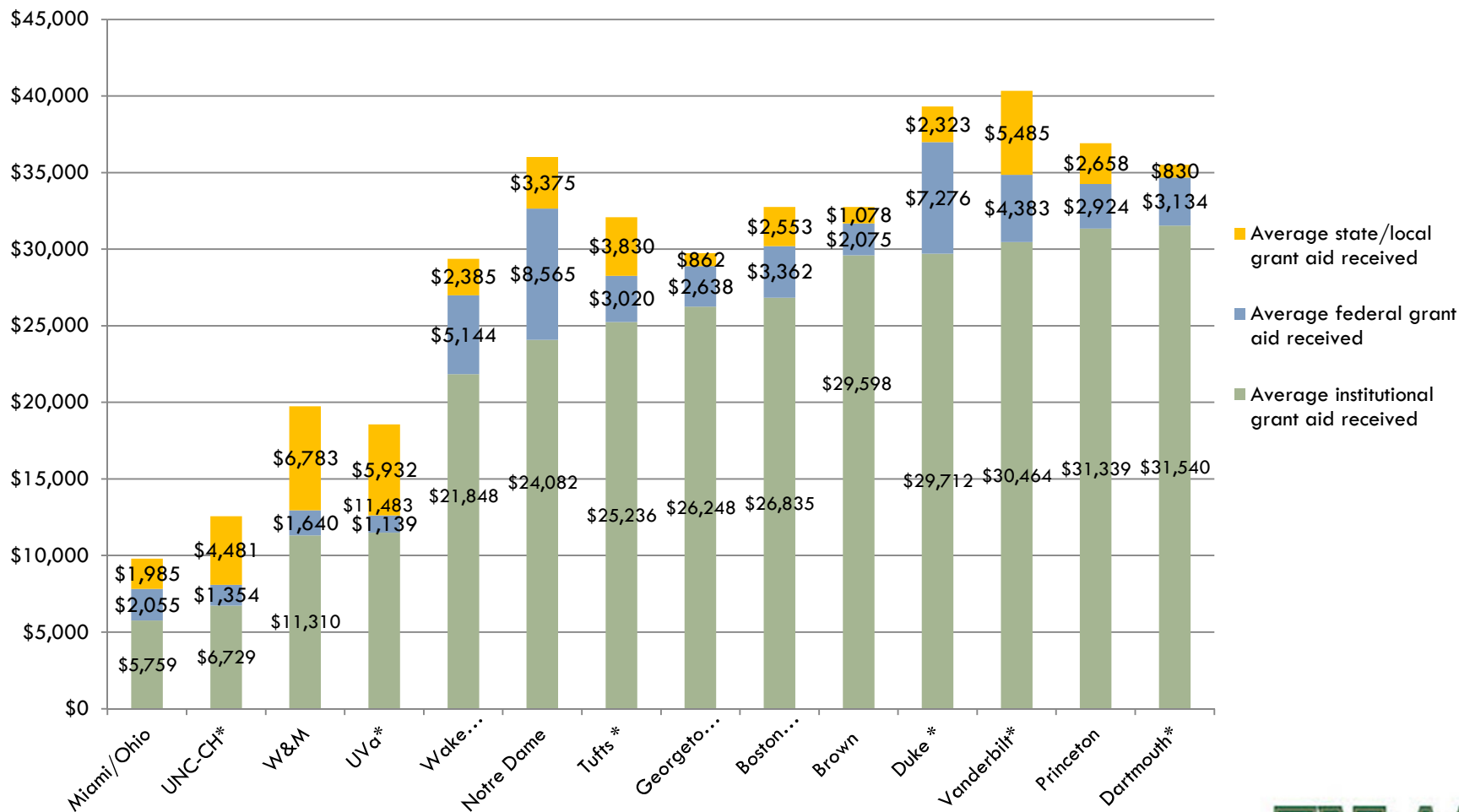
