I am submitting this form as evidence of my interest in the Bridge Program between the College of William and Mary (W&M) and Richard Bland College (RBC). I understand that I will be permitted to co-enroll in W&M classes after the completion of a minimum of 12 (spring start) or 15 (fall start) credit hours of approved general education coursework at RBC. This coursework must have been taken at RBC since graduation from high school and apply toward the Associate in Arts or Associate in Science degree. I understand that I will be permitted to pre-register for the W&M co-enrolled classes prior to completion of the RBC minimum credits, and that I will be dropped from the W&M courses and ineligible to continue in the Bridge Program if I do not complete 12 credits (spring start) or 15 credits (fall start) with a minimum 3.25 GPA by the end of the preceding semester at RBC.

I understand that eligibility for admission under the terms of this agreement is contingent upon meeting high standards of personal conduct. Conviction of a felony or other evidence of behavior inconsistent with the community standards and Honor Code of W&M may be grounds for denying admission or rescinding an offer of admission even if other requirements of this agreement are met.

I also give permission to both W&M and RBC to release information to one another concerning Bridge Program admission, course registration, and my academic performance, as well as to report any violations of judicial and honor regulations. This contract will be held on file both at RBC and W&M.
