Re: W&M Undergraduate Enrollment Projections, 2023-2026

The Enrollment Projections Working Group launched in July 2022 to improve data-driven estimates for use in planning to serve the needs of William & Mary's undergraduate students. The group met in October 2023 to update its headcount projection including the fall census data.


This headcount projection provides an estimate of the total number of undergraduates enrolled by academic class and living arrangements under current policies. The Office of Institutional Research, particularly Sophy Feng and Xuchen Zhou, deserve the lion's share of the credit for these projections. The spring 2023 and fall 2023 projections proved accurate within one percentage point of actuals.

Some important notes for reviewing the graph and table below:


• Academic class is determined based on credit hours earned, not social class/entering cohort.

Of note, undergraduate enrollment is expected to decrease slightly from the fall 2023 high point of 6,949 students. In the following fall semesters, decreases of -1.2% and -0.5% reflect the degree progress and graduation of the larger enrolling cohorts during the 2021-22 and 2022-23 academic years. The 2023-24 enrolling cohort is on target with the "Smart Growth" plan approved by the Board of Visitors in spring 2020.
