COURSE DESCRIPTION

This course will provide a discussion of international topics of macroeconomic interest. It includes topics such as the balance of payments, interest parity, determination of output and exchange rates in the open economy, purchasing power parity, systems of exchange rates, financial crises, and the international monetary systems. Relevant articles from academic journals beyond textbook readings will be included and summarized on problem sets.

LEARNING OBJECTIVES

Students should be able to achieve the following course objectives:

- Understand national income accounting and the balance of payments accounts
- Know how to model foreign exchange markets and understand equilibrium via interest parity
- Demonstrate the relationship between monetary policy and foreign exchange markets
- Define the law of one price and purchasing power parity and how they relate to the long-run exchange rate
- Analyze how determinants of AD affect the short-run exchange rate
- Compare fixed and floating exchange rate regimes and understand the policy trilemma
- Have a historical perspective on international monetary systems including the gold standard and the IMF
- Discuss the benefits and costs of financial globalization

PREREQUISITES

ECON 304 (Intermediate Macroeconomic Theory). Students should be familiar with the concepts of supply and demand, monetary and fiscal policy, and have extensive practice using equations, graphs, and tables to analyze economic situations. Students are also expected to be experts working with functions, and their graphical representation. Consistent study habits coupled with an eagerness to learn and ask questions will help to achieve the learning objectives.

ASSIGNMENTS

There are four parts to this class. In each part, there is an assignment. The assignments will require you to find, summarize, and analyze important macroeconomic data, and like the exams, consist of free-response questions. Each assignment is worth 50 points (or 5% of your final grade).

You may work in **groups of** 3 **people or less**. Please turn in one set of answers per group. I will not assign groups nor will I police them; you may change groups or work by yourself. You may work with people in either of section of this class.

CLASS ENGAGEMENT (EXTRA CREDIT)

There are two ways to engage in this class, either as a group or individually. Group engagement will involve finding, summarizing, and discussing articles on current macroeconomic events. As individuals, I expect you to engage on 3 different occasions, either in class, in office hours, or on Piazza. I will provide a separate document for more details on earning credit for engagement, which counts for 3% of extra credit.

EXAMS

There are four exams, each worth 200 points (or 20% of your final grade). If you miss an exam, the weight will shift to the next exam, and **you must take Exam 4.** Please note that anything discussed in class or any topic in the assigned reading from the textbook is "fair game" for the exams. There may be material presented in class that is not in your textbook, so **make sure that you have a full set of notes**. The exam questions will test your ability to understand and recall basic principles. They will also test your understanding of applications of theories, tools, and models.
