EPC – Minutes September 4, 2003

Jenny Taylor, the new Chair of EPC, called the meeting to order at 3:30 pm in the University Center, Chesapeake Room B.

Jenny introduced herself and all the members present introduced themselves.

Edward Pratt reviewed the issues regarding the DIL (Digital Information Literacy) Project. The project is intended to assess the computing competency of entering students and, when needed, give them a basic understanding of information technology skills early in the academic career. The deficiency of the current computing requirement is that it takes place toward the end of their undergraduate studies, i.e., their junior and senior years. With the new system, departments/programs could then revise their discipline-specific computing requirements, as necessary, to build on this baseline of knowledge. The DIL exam will be administered this semester (fall 2003), and the EPC will make a report to the faculty in spring 2004.

Ed also addressed another important task before the EPC this semester: the need to finish the review of the GER Working Group reports and to finalize recommendations to the faculty concerning changes to the GER criteria. In regards to the GER Working Group reports, the EPC has not yet reviewed the GER 4 and 6 reports. This review needs to be done early this semester. In regards to changes to the GER criteria, the EPC last year drafted recommendations for GER 1, 3, 5, and 7. It has not yet made recommendations on GER 2; recommendations on GER 4 and 6 will take place after a review of the Working Group reports. There was much debate last year surrounding the criteria for GER 2, so the EPC needs to be look at past minutes and understand the intent of the faculty when that GER was proposed and later implemented.

Also, the EPC will need to write expectations for each of the GERs, as part of the SACS accreditation process. Ed Pratt has drafted these expectations, but the EPC will need to finalize them. The Assessment Steering Committee is working on expectations for GER 1, so the EPC need not look at them at this time.

Spring projects include a review of the upper-level major writing requirement; and finalizing expectations for the lower-level writing requirement, the freshman seminar, and the Foreign Language Proficiency. The Writing Committee will draft expectations for the lower-level writing requirement and for the freshman seminar, which it will then submit to the EPC for consideration.

Jenny asked for volunteers for groups to finalize the recommendations for GER 1, 3, and 5 and to revise the expectations drafted by Ed. Ed mentioned that he will attend the meetings, so as to address any questions that might arise. Committees are to meet and to make recommendations to the full EPC on September 18.

The proposal was tabled until further information is obtained.
