#### **III.** Explanation of Decisions Above

CHINESE 200, 300 and 400: The Chinese section of MLL is requesting CHIN 200, 300 and 400, 'Chinese Studies in Beijing,' be listed in the catalog as 'Study Abroad in China' in order to allow students to study at other institutions in China and have the credit come into their transcripts under this rubric. This presents a problem because only courses from William and Mary study abroad programs may be listed in the catalog (a William and Mary program is one the Reves Center administers;

students pay William and Mary and not IES or another institution). Courses taken at non-William and Mary study abroad programs come in as transfer credit and cannot be listed in the catalog. The Beijing study abroad program is a William and Mary program, but it is unclear whether or not other programs would be. EPC will ask for clarification from the Chinese section.

**KINESIOLOGY NEW LAB COURSE:** EPC designated the new Kinesiology course as KINE 303L. This laboratory course is crosslisted with Biology. Biology will be notified of the new number, and the new course will also be in the course catalog.

**KINESIOLOGY CURRICULAR CHANGE:** The new Kinesiology curriculum was voted on and unanimously approved with amendments. See highlighted changes below for all KINE curriculum changes.

### **Kinesiology Curriculum with Amendments**

Kinesiology, the study of human movement, prepares students for a wide variety of academic and professional pursuits in the Allied Health Field. The Kinesiology major requires a minimum of 34 hours (Kin 150, KIN 200 and above) (excluding activity courses) from the core curriculum courses listed below. The major writing requirement in Kinesiology may be satisfied by obtaining a C- or better on the writing grade in KIN 470W/471W, 480W/481W, 493W, 495W or 496W. Kinesiology majors will satisfy the computing proficiency requirement by passing Kin 308 or Kin 394.

Students may choose to receive a bachelor of science (B.S.) degree or a bachelor of arts degree (B.A.) degree when completing the Kinesiology major.

Candidates for the B.S. degree with non-natural science majors in Kinesiology must complete three additional courses in computer science, mathematics, biology, chemistry, geology, or physics. This is in addition to satisfying the GER 1 and 2.

Freshman Seminars in freshman year: Carolyn Boggs states that the Banner system, along with the advising, will help to enforce the faculty approved rule that freshmen take their Freshmen Seminar in their freshman year.
