3. COLL courses

The following courses were approved:

COLL 100

PSYC 100 Nature and Nurture (Forestell)
This course was approved as a pilot course pending clarification of how the discussion section will be staffed. EPC wants to assure that the communications component of this course is being overseen/taught by continuing faculty members.

COLL 200

- CLCV 208 Roman Civilization (Spaeth) This course was previously approved as ALV reaching out to CSI. This application was for CSI reaching out to ALV. The application was approved.
- ENG/COLL 200 Narrative Medicine: Stories That Heal (Braxton) this application was not approved at the previous meeting because it was similar in content to AFST 306/COLL 200 Pathways to Equality and Healing Through Literature, Medicine and the Arts; as both these courses will be taught in the same semester, Prof. Braxton has agreed to ensure that no student receives credit for both courses; with that assurance EPC approved this application.

4. The Active Learning attribute

The EPC considered whether a COLL 200 course could carry the Active Learning attribute and decided in favor of this linkage.
