## -Course Discussions:

Discussion of non-English-language COLL 150's

Modern Languages and Literatures (Fauvel and Cate-Arries) made the case for conducting 150Ws in a language other than English (French and Spanish). Discussion was broad ranging, but EPC noted that curriculum changes required the approval of the FAS.

Such seminars will be limited to students who possess "exceptional" knowledge of the languages in question. These would be few in number, and they will meet all "published" requirements for the 150w.

Some opposing views on behalf of the Writing Committee (Zuber, Potkay, Lowry): students *need* instruction in composition. Also the question of assessing progress and competence.

It was also noted that medical schools evidently require some evidence of writing instruction.

An objection that this is akin to "English only legislation."

Homza offered to convene a focus group to examine this issue.
