## **Educational Policy Committee Minutes, November 18, 2015**

- 1. Minutes of November 11<sup>th</sup> were approved.
- 2. Brief discussion about whether or not COLL100 or COLL150 courses should be offered in the summer. No formal vote was taken, but there was little enthusiasm for offering compressed summer-school versions of these courses.
- 3. It was announced that during the spring semester, EPC will be helping evaluate the first round of questions and surveys related to COLL100 and COLL200 courses.
- 4. Lu Ann Homza reported on the QEP (quality enhancement project) that is part of the SACs accreditation. The focus of the QEP for this interval will be to expand the number of students who are included and engaged in high impact educational practices. For freshman the focus will be on multifaceted advising, including the involvement of faculty teaching COLL150 courses. The committee is looking to promote a wide variety of high impact practices in the sophomore and junior years that they anticipate will ultimately help ALL students get the most out of their COLL400 capstone experience during their senior year.
- 5. Jack Martin led a continuing discussion on a draft document regarding credit hours for on-line and hybrid courses. There are still some discrepancies between current policy, provost suggestions, and best e-learning practices that need to be resolved. As the policy recommendations are finalized, EPC will develop a separate form for submission on-line course proposals to the EPC.
