3. COLL 100 and 200 Assessment

- For courses that are anchored in two domains, need to add to the form so that questions that address mastery, methods, or other questions focused on one domain are expanded so that students respond to those questions for both domains.
- In addition the CLA is interested in the questions that get at the reaching out component they are concerned about the "watering down" of the reaching out component.
- Assessment will distribute information about the COLL assessments to those faculty who
 will be teaching such COLL courses before the semester in which they will be teaching
 the course. Assessment will also distribute this information to the Chairs and Program
 Directors.
- We recommend, via the curriculog form, other EPC communications, and communications from the Dean's Office, that faculty include statements on the syllabi of COLL courses that their course is a COLL course and the associated formal language about characteristics of such COLL courses.
