II. Delinking Requirement for Online Courses

(Following summary is provided, courtesy of Michelle and Ryan)

Concerns with online courses were discussed. Michele clarified that the information entered by instructors in Curriculog was confusing and/or incomplete. Ryan described that all current online courses deliver instruction that by using online videos and discussion board participation corresponding to the amount of in-class time. This year, some courses are also using a tool to hold synchronous class meetings, which will be recorded and student will be expected to either "attend" the session or watch it afterward.

It was agreed that faculty should include more information in their syllabus for this summer and that, next year, faculty would provide more details regarding delinking information in their course proposal to EPC.

Michele asked if we could work with EPC next Fall to create examples of acceptable delinking submissions and work with EPC in advance of formal proposal to ensure the syllabi and proposal has all the desired information. The committee agreed.

III. EPC in Summer 2017

Since the submission of COLL 300 and 400 applications will likely increase during the summer, current EPC members are expected to review proposals on Curriculog until June 30.
