**II. Discussion of EPC's ICG proposal and next steps with the subcommittee on diversity.**

Jenny sent the EPC counter proposal we discussed last week to the subcommittee on diversity. The subcommittee on diversity wants to meet this week with the hope of presenting something at the next A&S faculty meeting, but some feel this is rushing things through too quickly without time for faculty input. Jenny will call a meeting for Friday at 4 or 5 to have a preliminary discussion with the subcommittee. The Dean is moving ahead with funding training and the School of Education might come in as a partner. There's a question of exactly what should be presented at the final A&S meeting of the semester.

COLL 400: Jenny is getting pushback from departments that have senior capstone topics courses about having to have each course approved. EPC is going to continue to require syllabus submission for each topic until COLL 400 is more established.

It was noted that we have not in the past given domain designations for "skills" courses such as math, beginning language, etc. EPC made this decision last year based on their understanding of SACSCOC rules. It matters that these are not the only ALV credits a student would have; students have COLL 200 credits as well, which are clearly not skills-only courses. Sallie reminded us that COLL 100s and 150s are not supposed to be eligible for domain credits, so ART 100 should not be approved for ALV domain credits.
