- The minutes from 3/23/18 were approved.
- Susan Bosworth discussed COLL 400 assessment strategies with the committee. The
 assessment steering committee is charged with assessing the COLL 400s and providing
 feedback to EPC. Others on the committee include Denise Ridley-Johnson, Laurie Wolf,
 Tom Linneman, and John Donahue. The assessment strategy is outlined in the handout
 distributed electronically and at the meeting.
 - o Major questions to be addressed in the assessment:
 - 1. Do courses continue to address components of the COLL application? (assessed via course portfolios: syllabus and faculty narrative)
 - 2. Are the COLL courses working? Are students learning what the faculty expect them to learn? (assessed via student work uploaded to Blackboard; all COLL 400 final products [usually papers] will be collected)
 - There will be a working group of faculty members (non-experts in the discipline) to review the student work and determine whether it demonstrates critical thinking and problem solving. Rubrics from AAC&U will be used to assess the competencies.
 - 3. How can assessment assist the EPC? Adjustments to COLL/COLL 400? Curricula?
 - o Might we have an EPC subcommittee in the fall to assist with these efforts?
