#### 3. Update on Pass/Fail Task Force

Josh gave an update on meetings that have included task force members and Ginger Ambler, Kelly Crace, Kathleen Powell, representatives from the Mason School of Business (Jennifer Dahnke, Ram Ganeshan, Lisa Szykman, Amy Xia), and the registrar of Davidson College. The committee then continued debating the benefits and costs of a retroactive P/F option. It was suggested that a direct discussion with Kelly Crace would be helpful for the committee's understanding of issues surrounding student stress and mental health, and the likely effects of the proposed P/F policy.

#### 4.New Business

Magali Compan raised the question of how the content and quality of EPC-approved courses, in particular COLL 350 courses, can be verified as instructors of those courses change. One suggestion was for EPC to send periodic requests for faculty teaching COLL courses to resubmit course proposals if the syllabus has changed substantially.
