Subject: Report of the Educational Policy Committee, May, 1988 through December, 1989

This report covers the activities of the Educational Policy Committee from May, 1988 through December, 1989. Further details on each matter mentioned below are in the minutes of the Committee, available from the Chair.

Educational Policy Committee met frequently and made recommendations to other committees, groups, and administrators of the College, with attention to Assessment (almost weekly for a long while); to the development of an NEH grant application to endow the freshman year; to the development of a proposal in geographic education; to the drafting of the "Insider Case Statement" for fund-raising; to the size of the freshman class and growth of the student body; to the implementation and resolution of difficulties with the Deans' list; to the implementation of the +/- grading system; to grading policies in internship courses; to waivers of requirements for students with learning disabilities; to the waiving of 1 credit of the PE requirement for students in PE classes cancelled due to construction; to sexist language in the Catalog; to the Concentration Writing Requirement; to the possibility of a curriculum review; to add/drop for Applied Music students; to the accounting of a C- as a C for minimum Writing requirements; to the need to make sure students receive course grades as promptly as possible; to the SA and student members of the EPC; to the determination of attempted semesters; to the Funds for Excellence Target Areas and proposals; to a presentation by the Faculty liaison Committee and others to the Board of Visitors on "What We Teach"; to allowing a student to drop a concentration without a faculty signature; to Area credit for students taking 200 level Modern Language courses in a second language; to possible outreach to secondary schools; to minimum GPA's for entry to a concentration; to class sizes; to revisions of its "change in curriculum form"; to the pass/fail option in summer sessions; to enforcing prerequisite requirements; to the inadvisability of removing the Chair of the EPC from College committees concerned with the allocation of resources; and to possible ways to structure an Academic Affairs committee of the Faculty Assembly.

The Committee also began to gather information on Latin Honors and received a request from the Student Association proposing revisions in the Grade Review Procedure. Both matters are under continuing discussion.

The Committee made a number of presentations or recommendations to the Faculty: 1) that the add/drop period be shortened; 2) that the Writing Proficiency Requirement be revised; 3) that the Faculty consider the need and timing for a possible review of the undergraduate curriculum; 4) that the Faculty endorse the various documents developed for the assessment of student outcomes mandated by the state.;5) that the Faculty observe deadlines for reporting grades.

In response to a charge the previous year, the Committee presented to the Faculty a report on the Size of the Freshman Class and Growth at William and Mary; that report was endorsed by the Faculty, and the Committee is moving it towards presentation to the Board of Visitors.

The Committee passed a resolution, December, 1989, urging the Provost to avoid undue cuts in the book acquisition budget of Swem as a response to the reversion of state funds, suggesting that the top priority for the use of private funds be to make up and necessary cuts.

The EPC was represented by its chair on a number of committees: on the Assessment Steering Committee, the Sub-Committee on General Education, and the ad hoc Committee on Disenrollment and Registration; in addition the Chair consulted with the Dean of Undergraduate Studies in March, 1989 on a presentation by the dean about Undergraduate Research; served on a review committee to consider proposals for Wilson Interdisciplinary Research; served on two Marshall Interview Committees, served on the Board of the School of Education's Teacher Preparation Advisory Committee; and consulted regularly with the Deans and other curricular committee chairs in Arts and Sciences.

Because of the requirement for Computer Science 423, proficiency in Mathematics 111, 112, and 211 is also required for a concentration in Computer Science.

The Concentration Writing Requirement can be satisfied by completing either Computer Science 423 or Computer Science 433 with a grade of C or better, or by fulfilling the requirement for Departmental Honors in Computer Science.
