

Educational Policy Committee Annual Report

January 1990-April 1991

The Educational Policy Committee's activities since Spring 1990 reflect the impact of Assessment, Budget, and Curriculum Review. The majority of the Educational Policy Committee's time continues to be spent on consideration of specific curricular requests. The requests approved during the last year (see attached) reflect the effect of assessment-driven curricular changes as well as the implementation of interdisciplinary programs (American Studies, Applied Sciences, International Studies, Public Policy, Women's Studies).

The impact of budget constraints, however, overshadowed efforts to implement curricular changes. Although the budget repercussions of curricular changes have always been a concern of the Educational Policy Committee, the pressures of increasing student enrollment were noted by the committee late in the Spring 1990 semester. With massive budget cuts during the Summer and Fall, the adverse effects on the curriculum mounted. The compromises necessitated by budget constraints are apparent. For Fall 1991, course offerings have decreased, class sizes increased, and departments are more dependent on adjunct faculty at the same time funds for adjuncts are increasingly scarce (see attached). Despite the fact that discussing budget cuts has been a painful process, the greater involvement of the Educational Policy Committee in budget discussions concerning the curriculum is a positive outcome.

The formation of the Curriculum Review Committee means that many recent concerns raised by the Educational Policy Committee (e.g., the nature of Area courses) are currently under study by other faculty groups. Since Spring 1990, however, the Educational Policy Committee has discussed several broad policy issues including the uses of adjunct faculty, attendance policies, the issue of the Minor, the pass/fail system, etc. In addition, the Latin Honors proposal developed over the last few years was passed for implementation this year.
