



### **Distribution of WSCH by Day of Week**









## **Distribution of WSCH by Time of Day (average)**











## Required Space (sq ft) vs. Existing Space (sq ft) by Room Size







# Required Space (sq ft) vs. Existing Space (sq ft) by Room Size




