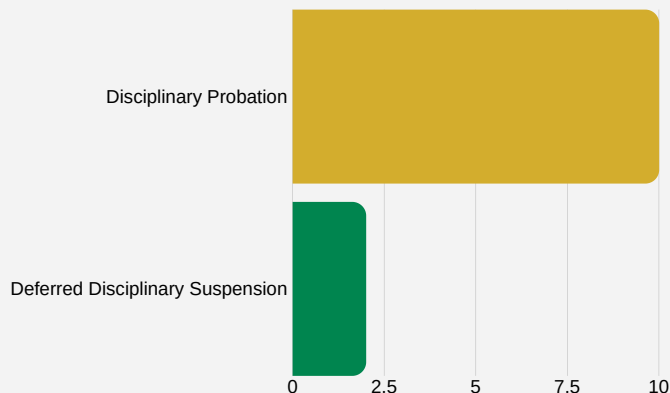

What are Primary Sanctions?

When finding a respondent responsible, the council may issue at least one primary sanction for any single violation. Primary sanctions impact the students' status with the university and range from warning to permanent dismissal.

What are Secondary Sanctions or Educational Measures?

The council may assign additional secondary sanctions or educational measures meant to educate the student and repair or restore after the violation. These measures include apologies, reflections, seminars, and other educational tasks.
