A trade or businesses is considered regularly carried on if it's conducted frequently. For examples, the monthly rental of University space would be considered regularly carried on. Casual sales that occur as part of an activity such as fundraising would not be considered regularly carried on.

Substantially Related to the University's Exempt Purpose If an activity does not play an important part in contributing to the University's educational, research, or public service mission, it may be considered as not substantially related. Some examples of activities that have been considered not to be substantially related include: 1. Dormitory rentals to the public
 Athletic or recreational facility use for non-university customers; facilities use by the public Operation of a parking lot serving non-university customers Advertising – generally any message designed to get the viewer to buy the advertiser's product (Income from advertising would generally be subject to UBI)
