**Payment plan options:**

Members can choose from 3 payment plans: monthly, semesterly, or yearly plan. Changes to this plan can be made at any time at the member's convenience. Each new member must sign a Dues & Fees contract stating that they will fulfil their financial obligation to the Fraternity. Another Dues & Fees contract must be signed by all members by August 1st each subsequent year of membership.

For new members opting for a monthly payment plan, the billed amount will be due by the first of each month, October through May. For initiated members, the billed amount will be due by the first of each month August through May.

For new and initiated members opting for a semester plan, the full semester amount for the fall semester will be due on August 1st for initiated members and October 1st for new members. In the spring, the full amount will be due January 1st.

For new and initiated members opting for a yearly plan, members pay fall and spring semester dues at one time. This amount will be due on October 1st for new members and August 1st for initiated members. All members have the option to confidentially discuss with Honor Board options for payment plans that differ from those listed above (e.g., 11-monthly rather than 9-monthly; change of due date from 1st to 10th or equivalent, etc).

The Fraternity-approved accounting system will issue bills to members/new members prior to the first day of each month of the year. Regardless of the payment plan that members select; an invoice will be sent every month that will either display a charge or a balance of \$0.00.

Scholarship opportunities:

Delta Gamma Executive Offices offers multiple merit-based scholarships on an application basis; some are international for all chapters, some are region-specific, and one is chapter-specific. Applications open in January and close in March, and notifications of awards happen in July. Need-based scholarships are available via application on a rolling basis.

Sorority residency requirements:

All 16 spots must be filled. All members may volunteer to live in the chapter house. The Epsilon Mu chapter of Delta Gamma utilizes a housing point system, which is based on attendance at meetings, events, and office positions and determines how the chapter will fill spots in the chapter house. If more members apply to live in the house than spaces available, members with the highest number of points (according to the Housing Point System) will be given priority. If the house is not at capacity and the Director of House Management must pull members to live in the house, members with the highest number of points (according to the Housing Point System) are last to be pulled.

All Sorority Housing is owned and operated by the University Housing Office. Items included in the per-term range amounts are: Room, deposit, wireless internet, air conditioning.

Housing costs for the 2025-2026 academic year are set by the Office of Residence Life. Sorority housing is billed at the premium room rate, which can be found on the William & Mary Residence Life website.

Other chapter associated costs:

All new members must purchase a badge outside of their dues, with options starting at \$50. New members will be invoiced for a badge prior to initiation. All other apparel is optional, but members typically spend around \$30 in a school year. Members typically spend around \$100 dollars on big-little clue week as a big. Missed events will not incur a fine. Live out initiated members will be billed \$80 for the year, this amount will be prorated if a member goes abroad or is on another status. New Members will be billed \$80, plus a one-time fee of \$150 dollars to become a member of House Corporation.
