### Please describe your payment plans, if provided:

The Gamma Kappa chapter of Kappa Kappa Gamma offers flexible payment plans to support members in meeting their financial obligations while accommodating individual circumstances. Payment plans can be arranged on a monthly or customized basis through our Vice President of Finance and approved by our Finance Adviser. Members are encouraged to reach out proactively to discuss available options and ensure that finances do not become a barrier to full chapter participation. Dues are typically due at the beginning of each semester, with the option to divide payments into up to three installments. Members interested in a payment plan must complete a short application form, which can be obtained from the Vice President of Finance and submitted prior to the first payment deadline usually on the 20<sup>th</sup> of the respective month.



**Please describe scholarship options for new and current members, if provided:**

Gamma Kappa chapter encourages members to apply for scholarships through the Kappa Kappa Gamma Foundation, which offers both merit-based and need-based awards to support members' academic pursuits. For the 2024–2025 academic year, the Foundation awarded over \$1.2 million in scholarships, with most individual awards averaging around \$3,000. Merit-based scholarships are available to full-time students with a minimum GPA of 3.2, while need-based scholarships are open to members with a minimum GPA of 3.0 who demonstrate financial need. All applicants must be initiated by members in good standing and complete an online application that includes references and supporting materials. The application typically opens in mid-November and closes in early February each year. It is important to note that Kappa Kappa Gamma Foundation scholarships are intended solely for educational expenses and cannot be applied toward chapter dues or housing costs. However, William & Mary Panhellenic also offers a separate scholarship each semester that may be used to help cover dues. Members are encouraged to apply for both opportunities to support their financial and academic success.

**Sorority residency requirements:**

The Gamma Kappa chapter requires that all 19 spots in the chapter house be filled each academic year. Spots are filled on a volunteer basis in the following order: Senior Chapter Officers, Seniors, Junior Chapter Officers, Juniors, Sophomore Chapter Officers, and Sophomores. If any spots remain open after volunteers are requested, members will be assigned to live in the house in reverse order (beginning with Sophomores and moving to Senior Officers, until all spots are filled). However, due to increased chapter size and strong interest in living in, the likelihood of members being pulled into the house has decreased in recent years.

All Sorority Housing is owned and operated by the University Housing Office. Items included in the per-term range amounts are: Room, deposit, wireless internet, air conditioning.

Housing costs for the 2025-2026 academic year are set by the Office of Residence Life. Sorority housing is billed at the premium room rate, which can be found on the William & Mary Residence Life website.

**What fees may a PNM encounter that are separate from dues and fees billed by your chapter?**

Members may encounter a few optional fees beyond their regular chapter dues, primarily related to apparel and special events. Required chapter shirts are included in member dues, with the option to place one additional apparel order each semester. When participating in Clue Week as a Big or Little, members may have some associated costs; however, to keep expenses manageable, we cap Big/Little spending at \$100 and provide affordable alternatives such as pass-down items and free bonding activities. To further support members, the chapter has established the Kappa Closet, a shared resource of clothing and accessories for events and themed functions, helping ensure everyone can participate regardless of financial circumstances. Additionally, members who miss the billing deadline, typically 20 days—may be charged a late fee averaging around \$10.
