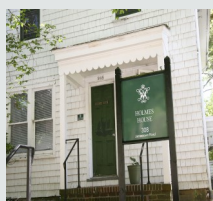

The IC process includes securing required external approvals. The following have been

Accreditation: SACSCOC Report

W&M is accredited by the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC). In 2016, the SACSCOC Board of Trustees reaffirmed William & Mary's accreditation until our next reaffirmation in 2026.

SACSCOC requires that institutions submit a Fifth-Year Interim Report.

Our report is due in early Spring 2022. This report includes 22 standards and covers all areas of the institution. The PIEs respond to one standard. IAE has begun working on the full report. We will be contacting offices soon for assistance in making a compelling case for compliance with each standard.

An Impact Report regarding our

Quality Enhancement Plan (QEP) also is submitted as part of the Fifth-Year Interim Report. W&M's QEP focuses on high impact practices. Teresa Longo and John Donahue in Arts & Sciences have been leading this effort.
