Updates on PPE and Related Supplies



The purchase of personal protective equipment "PPE" has been <u>centralized</u> for W&M and VIMS to maximize efficiency, avoid competing against ourselves in the marketplace, ensure a reliable supplier base, and maximize the use of Virginia certified small, woman-owned, and minority-owned suppliers, where possible. Ordering PPE through FAMIS? Plan ahead: the warehouse will be closed 6/30 - 7/2 for inventory.

As of today, W&M has procured:

- At least one cloth mask secured for all staff and students (order total 20,000)
- Return-to-school kits ordered for all students and staff with early Aug. delivery. Kit includes: 2 face masks, 2oz hand sanitizer, 1pack surface wipes, and will contain message to community about safety and personal responsibility.
- · Large volume disinfecting wipes purchased for high traffic campus locations.
- Nitrile gloves and disposable masks purchased in volume to meet estimated demand.
- 1oz containers for personal hand sanitizer refills secured in quantity to cover all staff.
- N95 masks for Student Health Services order pending
- 314 hand sanitizer stands for various campus locations. (227 campus locations)
- 4,000 face shields.
- 17 Electrostatic sprayers for cleaning designated campus spaces (Athletics, Campus Rec, Swem, Building Services)
- Sneeze guard/Plexiglass suppliers Hackworth and TSRC have been identified to provide product for high traffic areas where public distancing is not possible. Find guidelines on acrylic barriers/sneeze guards here.
- · 4 temperature taker stations.
- · 12 touchless thermometers for health services.
- Work underway to procure products to sanitize electronic devices
- · Antibacterial wipes for each classroom.
