EO77 Update: New Commodity Code in buyW&M

To help properly report single use plastics purchases as mandated by Executive Order 77, buyW&M system administrators established a new commodity code (521515, SUP, SINGLE-USE PLASTICS & STYROFOAM) for use when purchasing <u>single use plastics</u> for university business. Punchout orders have already been updated to populate the commodity code when purchasing these types of products. Please be sure to reference the commodity code when ordering non-catalog items for required state reporting purposes.
