# Purchase Order Updates in buyW&M

Purchase Order Cancellation Request Form: All Purchase Order cancellations now need to be requested using the Purchase Order Cancellation Form found on the Shopping Dashboard under Procurement Forms. The reasoning behind this change is to eliminate PO edits without a change request. Unfortunately, the permission that is associated with PO edits ties to the cancellation permission. To reduce the risk of having PO edits without a change request we need to inactivate this permission. A request ticket resides with Jaggaer to separate these two permissions so we can control the two functionalities separately in the future.

Department Purchase Order and Invoice Searches: There are two new search reports to help Departments capture Purchase Order and Invoice submittals along with accounting information within buyW&M. These searches were generated with the help and feedback of various departments. In order to access these reports you will need to go through the "Manage Searches" option under the user's profile. ### **America To Go Updates**

ATG has updated the ordering process as follows:

- 1. Immediately upon placing an order an email will be sent with a copy of the order attached. It includes a reminder of the next steps: approval process and confirmation by the vendor.
- 2. If an order remains in draft status for more than 24 hours a second notification is sent to the customer reminding them that the order has not been approved and sent to vendor for confirmation.

ATG Reminder: The full name and affiliation is required to be included on the ATG order for business meals for 10 or less attendees.

#### Flower Purchases

The limit amount for flower purchases under the local fund policy has been increased. Using Local Funds, flowers/plants for public or common areas are allowable, flowers/plants for non-employees up to \$150 per person are allowable, and flowers/plants or donations for the death of an employee's immediate family member up to \$150 are allowable. ### **Enterprise Update**

William & Mary, as well as all the VASCUPP institutions, has been notified by Enterprise that due to "the effect of several industry headwinds coupled with this global emergency has had a significant impact on the economics of our business" the pricing under the E&I agreement has increased by 5%, effective July 15th, 2022. Until our website is updated, vehicle renters may notice that pricing may be different than what is currently posted on our website. As an example, the cost of an economy car will increase from \$31.75 to \$33.34.

# IT Headset Ordering in buyW&M

If you purchase headsets from IT via buyW&M, the PO does not get encumbered, received or invoiced. IT will take the money from the index used on the order. After the order is placed there is nothing left to do in buyW&M.

We heard your feedback and now have a new process for individuals needing to be reimbursed via Chrome River that allows you to securely obtain the vendor's tax document and complete the vendor request on the individual's behalf.
