
Alcohol Tax Exemption for Catered Events

Upon recent exploration of the <u>Sales & Use Tax Update Notice</u> from 2016 from the Virginia Department of Taxation on tax exempt status for catered events, alcohol is also identified as being <u>tax exempt</u> when being served at an event that meets the tax exempt requirements. Please note, W&M will be working with ATG to notify the ATG caterers of this ruling. Thank you to the tax team for finding and sharing this information to ensure the university is benefitting from all tax exemption opportunities it is legally able to benefit from.

Guidance on Gift Policy

Under state law, a university employee may not accept any gift, even of nominal value, that tends to influence an employee in the performance of their university job. It is prohibited to accept gifts from current or potential vendors. Gifts from other sources (colleagues, professional networks) may be permitted if the gift is valued at less than a specific dollar amount. Disclosure of the acceptance of non-vendor gifts to you as a university employee to the Conflict of Interest Committee is required under the Conflict of Interest Policy. Questions? SPCC FY24 Annual Training for Cardholders & Approvers

To remain in compliance with William & Mary's small purchase charge card (SPCC) program, all cardholders and approvers are required to complete annual training. Procurement Services has developed a training in Cornerstone to meet this requirement for fiscal year 2024. Cardholders and Approvers can access the course by logging into Cornerstone through William & Mary's Central Authentication Service (CAS). Once logged into Cornerstone, the training will be available by navigating to your Transcript. Please use the attached instructions to log in and access the course materials. This training consists of a self-paced PowerPoint presentation. The training should take less than 30 minutes of your time, and completion will be recorded in Cornerstone, so you do not need to email me once you have completed the training. Please complete the training no later than **Friday**, **February 9**th, **2024**. You must complete the training by the deadline to ensure your card and/or approver responsibility remains active. If you will no longer be a cardholder or approver, please contact bladieu@wm.edu to cancel the card and/or reassign permissions.
