## Championing Military Families on Capitol Hill

On October 1, William & Mary Military & Veteran Affairs visited Capitol Hill to continue conversations that began when Lindsay Blount, Ed.D., spoke at the Congressional Military Family Caucus earlier this year. The team met with Defense Fellows Rebecca A. Knox (Office of Congressman Sanford Bishop) and Amanda Gray (Office of Congresswoman Jen Kiggans) to discuss ongoing military family initiatives.

Alongside Julia Jester, B.S. '98, Ph.D. '03, Director of Federal Affairs, we shared W&M's work supporting military-connected students and the broader communities around them. The team also briefly greeted Congressman Bishop and his Chief of Staff, Kenneth Cutts, to thank them for their leadership and continued support of military families.

These conversations strengthen partnerships that help advance meaningful support for service members, veterans, spouses, and families.



## Inclusive Excellence Symposium

On October 10, a panel of William & Mary military and veteran students presented at the 10th Annual Inclusive Excellence Symposium, discussing belonging at W&M, including their dual transition experiences: transitioning out of the military and transitioning into a highly selective university. While visiting campus October 13, U.S. Senator Tim Kaine and team sat down with students representing WGC-sponsored student groups the Wargaming Lab and William & Mary Global Innovation Challenge (WMGIC) and with participants from the National Security Internship Program, VICEROY Scholars program, and recent Cyber Fortress exercise. Also attending were USAF (retired) Maj Gen Mark Matthews and several students he instructs in the Innovation for Defense course. Senator Kaine discussed the important work that our undergraduates are doing to help make our nation more safe and secure. ## W&M to be the U.S. Academic Home of the Submarine Industrial Base with AUKUS Center of Excellence

Led by the Whole of Government Center of Excellence and in partnership with the Special Assistant for Military & Veteran Affairs, William & Mary will be home to the U.S.-based AUKUS Center of Excellence. This transformative idea was launched on 29 October 2025 as part of the Hampton Roads Alliance's (HRA) Playbook, a plan to grow the region's defense and shipbuilding industry. Alongside inter regional collaboration centers conceptualized in Sheffield, United Kingdom, and Adelaide, Australia, William & Mary will harness academic expertise to strengthen international efforts to design, build and support the next generation of nuclear-powered submarines.





# In Their Shoes



## Air Combat Command International Affairs (ACC/IA) Internship Begins

On Friday, November 7, students attended an information session with Lt Col Christopher DarConte, ACC/IA Deputy Director, to begin their ACC/IA internship for the 2025-26 academic year. Lt Col DarConte discussed the ACC/IA mission and priorities, and students had the opportunity to ask questions and share potential research topics for the internship. Through this guided, largely virtual program, interns conduct open-source intelligence research and prepare comprehensive assessments for command-wide foreign programs impacting U.S. strategic partners in the areas of security cooperation, international engagements, and political-military affairs. Final presentations will be given in April 2026 during a visit to Langley Air Force Base in Hampton, Virginia.



## W&M Team 1693 Cyber Competes

A team of four students studying computer science at William & Mary – Lilli Arrington '28, Carson Gada '27, and two members of the inaugural cohort of VICEROY scholars Christine Hwang '27 and Elijah Gilliam '27 -- recently competed as Team "1693 Cyber" in Chapter 1: Shieldbearer, a VICEROY cyber competition. Sponsored by the Griffiss Institute, Georgia Cyber Range, and Augusta University's School of Computer and Cyber Sciences, this event allowed students to apply classroom learning to real world cybersecurity scenarios, enhance teamwork, and gain hands-on experience. Team 1693 Cyber placed 13th out of 44 teams nationwide, reflecting W&M's and VICEROY's shared commitment to developing a skilled cybersecurity workforce. [Read more about the "Summer of Cyber".](#)

## Lewis B. Puller Clinic Assists Veteran with PTSD Disability Claim


The Lewis B. Puller, Jr. Veterans Benefits Clinic recently helped a male veteran obtain a disability rating of 100% for posttraumatic stress disorder along with severe depression due to a sexual assault suffered while the veteran was on active duty decades previously. In this instance, the veteran first sought the Clinic's assistance through a Military Monday appointment. During Military Mondays, Puller Clinic attorneys and students meet with veterans at a local Starbucks to provide veterans with pro bono advice and counsel regarding disability claims involving the Department of Veterans Affairs. After discussing the circumstances of his claims, the Puller Clinic accepted the veteran as a client of the Clinic.

While serving in the Marine Corps at the very end of the 1970s into the beginning of the 1980s, the veteran was drugged and sexually assaulted by a fellow servicemember. The veteran sought medical attention at a military hospital, where a doctor subsequently recommended discharge. The veteran's discharge document contained an adverse remark regarding the veteran's sexuality. As a result of the trauma of the sexual assault, he began to experience symptoms of PTSD and depression. The discharge note compounded the results of the sexual assault.

For over forty years, the veteran carried this trauma alone. In 2024, he independently succeeded in having the adverse remark on his discharge document removed and was issued a new discharge certificate. Based on the removal of the adverse remark on the discharge certificate, the medical evidence of mental health issues, and the effective advocacy by the Puller Clinic, the severity of the veteran's condition was recognized by Department of Veterans Affairs at the 100% compensation level. As a result of this decision and the ensuing benefits, the veteran is more financially secure and mentally healthy. The veteran finally received disability compensation that recognizes the trauma he endured while serving his country on active duty.

### About the Puller Clinic

At the Lewis B. Puller, Jr. Veterans Benefits Clinic, students work directly with veterans, under the supervision of experienced attorneys, to advocate for their disability claims and help address a wide range of concerns like mental health, housing, and employment.
