
### **Student Assembly**

A SUMMARY OF WILLIAM AND MARY'S STUDENT GOVERNMENT

### Four Branches of Student Government

- Executive SA President, Vice President, and Executive Departments
- Legislative SA Senate
- Judicial SA Review Board
- Undergraduate Undergraduate Council (comprised of class officers)

## **Executive** Branch



### **Executive Branch**

- Headed by the SA President and Vice President who are elected as a ticket each March
- President diffuses responsibility across Executive Departments
- Departments of Student Rights, College Policy, Finance, Public Affairs, Diversity, Health and Safety, and Student Life

### Legislative Branch

### Legislative Branch

- Student Assembly Senate
- Headed by Chairman and Secretary
- All bills introduced and sent to one or more of the Senate's five committees: Policy, Finance, Outreach, Public Affairs, and Student Life
- Senate confirms Executive Department Secretaries and other appointees (including Student Liaisons to the Board of Visitors)

### **Judicial Branch**

- Student Assembly Review Board
- Determines if bills or acts of the other branches are in line with the organization's constitution.
- Primarily has served as an appeals board for election decisions made by the Election Commission in recent years.

### **Undergraduate Branch**

- The Undergraduate Council is primarily comprised of class officers: Class Presidents, Vice Presidents for Advocacy, Vice Presidents for Social Affairs, Class Treasurers, and Class Secretaries.
- Largely event-focused, notably Homecoming festivities.
- Associated with Senior Class Gift Fundraising

#### **Graduate Branch**

- The Graduate Council meets on a regular basis with representatives from each of the five graduate school associations: Student Bar Association (School of Law), Graduate Education Association (School of Ed), the Graduate Student Association (Arts & Sciences), the MBAA (Business School), and VIMS Graduate Student Association (School of Marine Science).
- Graduate students additionally vote for Student Assembly President and Vice President.

Each student pays a \$98 Student Activities Fee

• Fee is used to provide funding for a host of campus organizations.

### Student Activities Budget

• Funding for each organization is appropriated through the Executive Appropriations Committee and then confirmed by the Senate and signed by the SA President.

The Road to Richmond program has been in existence for 20 years, providing an opportunity for students to lobby in the state capitol for increased funding to WM.

- In previous years, the SA has funded two postdoctoral positions in the Counseling Center for a span of one year
- Continues to provide free STI testing for students in the Health Center

### SA Initiatives - Mental Health

- Mental health an increasingly salient issue on college campuses nationwide
- Department of Health and Safety promoting services offered by the Counseling Center
- Prioritize mental health in university budget for next fiscal year

### SA Initiatives – City of Williamsburg

• SA leaders have met with the Mayor, Council Members, and other city officials at two separate meetings last semester, with two more planned for this semester.


 Working on extension of four-person rule and adjusted parking provisions
