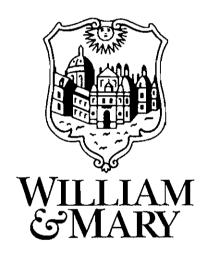

Chair Jeffrey B. Trammell called the meeting to order at 4:30 p.m. Recognizing that a quorum was present, Mr. Trammell moved adoption of the minutes of the meeting of February 1, 2012. Motion was seconded by Mr. Banks and approved by voice vote of the Committee.

MINUTES

Committee on Audit April 25, 2012

Board Conference Room - Blow Memorial Hall

Attendees: The Honorable John C. Thomas, Chair; Michael Tang, Vice Chair; Edward L. Flippen; and Laura L. Flippin. Absent: Leigh A. Pence and L. Clifford Schroeder, Sr. Others present: Kiersten L. Boyce; Michael R. Halleran; Samuel E. Jones; Jennifer B. Latour; Deborah A. Love; Anna B. Martin; Chris McKenna; and Michael L. Stump.

Chair John C. Thomas called the meeting to order at 4:28 p.m. and recognizing that a quorum was present, asked for a motion to approve the minutes of the February 1, 2012 meeting. Motion was made by Mr. Flippen and seconded by Mr. Tang and approved by voice vote.

Mr. Thomas informed the Committee that the Auditor of Public Accounts (APA) had not finished their work and did not have a report for the Committee.

Mr. Thomas asked Ms. Boyce for her report to the Committee. Ms. Boyce discussed her report about the protection of minors on campus; the President asked Ms. Boyce to research this. She discussed Athletics' efforts concerning summer camps, including the requirement for background checks for certain individuals hired to staff the camps. Ms. Boyce told the Committee that Ms. Love worked with Conference Services to improve their contractual protections for minors reserving College facilities for summer programs. Mr. Tang advised the Committee that the depth of the College's review of these programs may create new liabilities for the College. Ms. Boyce discussed the possibility of providing an anonymous process to report suspected abuse of minors and other illegal conduct. Mr. Flippen asked if the College has control of all the upcoming summer activities on campus involving minors. Ms. Boyce said we do not and that this will happen when the College institutionalizes the policies and procedures we discussed. Mr. Flippen asked if these recommendations had been executed; Ms. Boyce responded "not yet".

Ms. Boyce is attempting to increase awareness of the College's three-year-old Code of Ethics, including particularly the obligation to report illegal and unethical actions. Ms. Boyce explained that her office's website lists all the avenues to report complaints, including web links to the appropriate websites. Ms. Flippin asked if there was a comprehensive training program for all the matters just discussed. Ms. Martin responded "no", but all mandatory training is addressed through on-line courses and tests. Mr. Thomas thanked Ms. Boyce for her report and her efforts. Mr. Thomas reminded the Committee that the compliance function is still new and much remains to be done.

Mr. Thomas informed the Committee of two audits added to Internal Audit's annual work plan: Development and Highland. Mr. Thomas asked Mr. Stump to discuss projects completed and in process. Mr. Stump referred the Committee to the Report of Internal Audit Activity in Enclosure D and informed the Committee that two of the projects will be discussed in closed session. The Vice President for Student Affairs asked Mr. Stump to be a member of the committee to assist the Vice President with the fraternity housing selection process. Mr. Stump briefly described the

process, emphasizing the controls, planning, and education involved. The new fraternity housing complex will cost approximately \$25 million and should be completed during the summer of 2013. Mr. Stump discussed his ongoing work on the President's Honor System Review Committee. The draft report is finished and is being discussed today, at this very moment, in a forum in the Sadler Center.

Mr. Stump briefly discussed the seven projects in process.

Mr. Thomas moved that, pursuant to Sections 2.2-3711.A.1 and 19 of the Code of Virginia, the meeting be closed to discuss personnel matters involving identifiable College employees and security of the College. Motion was seconded by Mr. Tang and approved by voice vote. Observers were asked to leave the room and the Committee went into closed session at 4:51p.m.

The Committee reconvened in open session at 5:36 p.m. Mr. Thomas reviewed the topics discussed in the closed session and moved the adoption of the **Resolution** certifying the closed session was held in accordance with the Freedom of Information Act. Motion was seconded by Mr. Tang and approved by roll call vote conducted by Mr. Thomas. (**Certification Resolution** is appended.)

RICHARD BLAND COLLEGE CAPITAL OUTLAY PROGRESS REPORT

Umbrella Maintenance Project – Renovation of Student Commons

Construction on the Student Commons is 95% complete. The renovation includes roof replacement, installation of sprinkler and monitored fire alarm systems, new HVAC system, new electrical wiring coming into the building, new wiring in bathrooms, and increased handicapped access. The project is scheduled to be completed by September 30, 2012.

Umbrella Maintenance Project – Various Projects

This project includes the replacement of the chiller in Statesman Hall, converting the key system at the Center for Student Affairs to achieve better safety, the addition of sprinkler and monitored fire alarm systems to the Maintenance Building, as well as a generator to provide emergency power. This would include an upgrade in electrical service. The project includes a metal storage facility to enable both the custodial and maintenance departments to stock needed supplies and materials, storage space for equipment, and work space for maintenance. An RFP is being prepared to hire an architect for this project.

RICHARD BLAND COLLEGE CERTIFICATE IN LIBERAL ARTS PROGRAM

Current Commonwealth of Virginia legislation allows for two-year colleges to develop a uniform certificate of general studies program that will be transferable to public four-year institutions. Based on this legislation, Richard Bland College (RBC) is working to develop a one-year Certificate in Liberal Arts based on guidelines issued from the State Council of Higher Education (SCHEV).

Currently, due diligence is being conducted with the RBC instructional programs committee to ensure maximum transferability of the courses included in the certificate (initial proposed certificate attached).

The proposed certificate will address Governor McDonnell's goal of 100,000 additional degrees and meets several objectives set forth in the Top Jobs 21 legislation including:

- New Programs or initiatives
- Increased enrollment of Virginia students
- Increased degree completion for Virginia residents who have partial credit for a degree
- Increased degree completion in a timely manner
- Improved retention and graduation rates
- Enhanced transfer programs

The goals of the proposed certificate will be to improve the quality of students and increase the RBC completion rates. Students who intend to transfer after one year of study without obtaining an Associate's Degree would be able to complete an RBC credential in one year and then matriculate to a four-year institution. The certificate would also provide an avenue of service for students at Fort Lee's Army Logistics University (ALU). Students at ALU could fulfill the majority of general education requirements for Virginia's four-year public institutions in one year or less based on program delivery.

This program would benefit Richard Bland College (RBC) by improving our completion rates for students who transfer out prior to attaining an associate's degree. This program could also help RBC to attract a stronger student population and to tap new markets such as Army Logistics University at Fort Lee.

Faculty and student relationships are very important on any campus. For the Richard Bland College environment, it allows us as students to have open communication with each other and causes us to become empowered enough to build strong relationships with the faculty. As a student, I believe this improves learning. Strong relationships with faculty creates an environment that fosters students' opinions and thoughts about how to become more informed citizens who are able to use their information and education to communicate their ideas and guide their behaviors.

To create this environment, we are starting the process of initiating relationships between and among students and students, students and faculty, students and administration, and students and staff. Our attempts at starting these relationships have begun.

Faculty members have made the students aware of the opportunity to build learning communities on campus. A learning community is a program that will allow students to connect with each other and go over key concepts in a course that they may have missed in class. When exposing students to the idea of a learning community, professors are adamant that they will be a partner in this process.

On September 19th Dr. Love, a history professor, will hold a brown bag learning series for all students. He has partnered with the Student Assembly with the purpose of offering advice on studying for History and explaining to students how to understand that historical concepts can be informative of our decisions today and help build us as productive citizens. This session will be beneficial by reminding us that it is our civic duty to be informed by our past and to use as a base for our future decisions.

Speaking of future decisions and actions, voting is an important decision as an adult and is a symbolic gesture of our independence. With this in mind, RBC students will partner with the faculty, administrators, and staff to hold a campus-wide voter registration drive. In the months of September and October, non-partisan volunteers and state election officials from the local community will hold a campus-wide voter registration drive and hold information sessions to help students understand the entire process. Our first drive was held on Thursday, August 30, 2012. Thirty-five students registered to vote. This is a stepping stone for our students in taking the leap into adulthood.

MINUTES Committee on Administration April 26, 2012 Board Conference Room – Blow Memorial Hall

Attendees: Dennis H. Liberson, Chair; Charles A. Banks, III, Vice Chair; R. Philip Herget, III; John C. Thomas. Other Board members present: Michael Tang. Others present: Michael A. Halleran, Anna B. Martin, Deborah A. Love, Courtney Carpenter, Virginia A Ambler, and faculty members Dennis Taylor and Lynda Butler, and other administrative staff.

Chair Dennis H. Liberson called the meeting to order at 8:00 a.m. Recognizing that a quorum was present, Mr. Liberson requested a motion to approve the minutes of the meeting of February 2, 2012. Motion was made by Mr. Thomas, seconded by Mr. Banks, and approved by voice vote of the Committee.

As requested at the February meeting, Provost Halleran reported to the committee regarding faculty compensation. Using federally collected IPEDS data for the College's SCHEV Faculty Salary Peer Group, and adjusting the data mix for Fall 2010 for the schools the College does not have (medical, engineering, etc.), the College did not reach the 25th percentile, let alone the 60th, and never ranked better than 22nd out of 26 universities. He then reviewed the actual dollar-gap between the College and its aspiration of the 60th percentile over the past decade – between fall 1999 and 2010, the gap more than tripled for full professors.

Professor Dennis Taylor, co-director of the College's Committee on Sustainability (COS) Steering Committee, provided the committee with an update on the sustainability organization and FY 2012 activity. The Green Fee that supports projects reached two significant milestones: over \$1.0M in total life-to-date expenditures (since 2008), and nearly \$200K in an endowment. Once the \$200K threshold is reached, the interest earned can be spent on projects as well. After reviewing projects, internships, and cost-avoidance measures, Mr. Taylor engaged the committee in a discussion on measurement of sustainability going forward, how the definition of sustainability informs such, and the necessity for nationally accepted standards and definitions. Student interest has not lessened in this area, and the College continues to see growth in student scholarship.

Chief Information Officer, Courtney Carpenter, presented an IT FY 2012 overview for the committee. Accomplishments included \$1.0M network upgrade, and installation of new phone, email, and calendaring systems. The College continues to pursue e-commerce solutions to business issues, replacement of current card access program, and distance education.

The reports completed, and there being no further business, the Committee adjourned at 9:00 a.m.

Mr. John T. Wells, Dean and Director of the Virginia Institute of Marine Science, reviewed the results of the 2012 General Assembly session, including fifty percent of detailed planning funds for a new Consolidated Research Facility, and \$8.05 M to replace the aging Research vessel, *Bay Eagle*. Mr. Wells also highlighted the status of construction projects at Wachapreague from the written update.

Ms. Anna B. Martin, Vice President for Administration, reviewed highlights of the 2012 General Assembly session, which saw several infrastructure projects funded, as well as the renovation of the historic Brafferton. The College also received approval to expend College funds — with the promise of reimbursement — for preliminary working drawings (approximately 35% completion) supporting the renovation of Tyler Hall.

Ms. Martin reported that the College continues to make strong progress on the programming and schematic design of Integrated Science Center 3 (ISC 3). The Provost charged the building committee and the design team with making the facility truly integrated, with flexible labs featuring inter-disciplinary research and a "machine for science."

Ms. Martin and Ms. Virginia Ambler, Vice President for Student Affairs, reported to the Committee on the College's selection process for the new Fraternity Housing. They reviewed the mandatory criteria that must be met by a qualifying chapter, including its national organization. Thirty percent of undergraduates are in the Greek system.

Ms. Martin presented Resolutions 31 and 32 for approval. The Committee had no questions. Ms. Brashear requested a motion to recommend Resolutions 31 and 32 to the full Board. Motion was made by Mr. Tang, seconded by Mr. Snyder, and approved by a voice vote of the Committee.

The Committee thanked Ms. Brashear for her service as chair.

RESOLUTION OF THE BOARD OF VISITORS OF THE COLLEGE OF WILLIAM AND MARY IN VIRGINIA – 2012 9(D) POOLED BOND PROGRAM: IMPROVE AUXILIARY FACILITIES

WHEREAS, pursuant to and in furtherance of Chapter 3.2, Title 23 of the Code of Virginia of 1950, as amended (the "Act"), the Virginia College Building Authority (the "Authority") developed a program (the "Program") to purchase debt instruments issued by public institutions of higher education in the Commonwealth of Virginia ("Participating Institutions" and each a "Participating Institution") to finance or refinance projects of capital improvement ("Capital Projects" and each a "Capital Project") included in a bill passed by a majority of each house of the General Assembly of Virginia (the "General Assembly");

WHEREAS, under the Program the Authority from time to time issues its Educational Facilities Revenue Bonds (Public Higher Education Financing Program) ("Pooled Bonds") to finance the purchase or refunding of debt instruments issued by Participating Institutions to finance or refinance Capital Projects;

WHEREAS, if a Participating Institution desires to finance or refinance a Capital Project through the Program it must enter into a loan agreement with the Authority, under which: (i) the Participating Institution will issue its promissory note pursuant to Chapter 3, Title 23 of the Code of Virginia of 1950, as amended, to evidence a loan to it by the Authority; (ii) the Authority will agree to issue Pooled Bonds and use proceeds thereof to purchase the promissory note; (iii) the Participating Institution will agree to use proceeds of Pooled Bonds, loaned to it and received in exchange for its promissory note, to finance or refinance the Capital Project and to not take actions that may jeopardize any federal tax-exempt status of interest on Pooled Bonds allocable to financing or refinancing the Capital Project; and (iv) the Participating Institution will agree to make payments under the promissory note in sums sufficient to pay, together with certain administrative and arbitrage rebate payments, the principal of, premium, if any, and interest due on such Pooled Bonds;

WHEREAS, the Board of Visitors (the "Board") of <u>the College of William and Mary</u> (the "Institution") from time to time desires to finance or refinance Capital Projects for the Institution as a Participating Institution under the Program, and now proposes that the Institution issue its promissory note or notes (collectively, the "Note") to be sold to the Authority in accordance with a loan agreement or loan agreements between the Institution and the Authority (collectively, the "Loan Agreement"), under which proceeds of Pooled Bonds will be loaned to and received by the Institution in exchange for the Note, to finance or refinance costs of the following Capital Projects authorized for bond financing by the General Assembly: the <u>Improve Auxiliary Facilities</u>, (Project Code: 204-17934) (the "Project"); and

WHEREAS the Board desires to designate certain Institution officers (i) delegated the authority to approve the forms of and to execute and deliver the Loan Agreement, the Note and any amendments thereto, and any other documents necessary or desirable in

connection with financing or refinancing costs of the Project through and participation in the Program; and (ii) responsible for monitoring post-issuance compliance with covenants of the Institution related to maintaining any federal tax-exempt status of interest on Pooled Bonds.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD:

Section 1. The Project is hereby designated to be undertaken and financed or refinanced by the Authority and, accordingly, the <u>President, Provost, Vice President of Finance, Vice President for Administration</u> (the "Authorized Officers") are each hereby delegated and invested with full power and authority to approve the forms of the Loan Agreement, the Note and any amendments thereto (in connection with any refunding of Pooled Bonds financing or refinancing the Project or otherwise), and any pledge to the payment of the Note and any amendment thereto of total gross university sponsored overhead, unrestricted endowment income, tuition and fees, indirect cost recoveries, auxiliary enterprise revenues, general and nongeneral fund appropriations and other revenues not required by law or previous binding contract to be devoted to some other purpose, restricted by a gift instrument for another purpose or excluded from such pledge as provided in the Loan Agreement, subject to the provisions of Section 3 hereof.

Section 2. Subject to the provisions of Section 3 hereof, the Authorized Officers are each hereby delegated and invested with full power and authority to execute, deliver and issue, on behalf of the Institution, (a) the Loan Agreement, the Note and any amendments thereto (in connection with any refunding of Pooled Bonds financing or refinancing the Project or otherwise), with approval of such documents in accordance with Section 1 hereof evidenced conclusively by the execution and delivery of the respective document, and (b) any other documents, instruments or certificates as may be deemed necessary or desirable to finance or refinance costs of the Project through and participate in the Program, and to further carry out the purposes and intent of this resolution. The Authorized Officers are directed to take such steps and deliver such certificates in connection with delivery of the Note, and any amendment thereto, as may be required under any existing obligations, including bond resolutions relating to any outstanding general revenue pledge bonds.

Section 3. The authorizations given above as to the approval, execution, delivery and issuance of the Loan Agreement, the Note and any amendments thereto (in connection with any refunding of Pooled Bonds financing or refinancing the Project or otherwise) are subject to the following parameters: (a) the principal amount to be paid under the Note allocable to any component of the Project, together with the principal amount of any other indebtedness with respect to such component, shall not be greater than the amount authorized for such component by the General Assembly plus amounts needed to fund issuance costs, original issue discount, other financing (including without limitation refunding) expenses and any other increase permitted by law; (b) the aggregate principal amount of the Note shall in no event exceed \$\frac{8,000,000}{200,000}\$ as the same may be so increased; (c) the aggregate interest rate payable under the Note shall not exceed a "true" or "Canadian" interest cost more than 50 basis points higher than the interest rate for "AA" rated securities with comparable maturities, as reported by

Thomson Municipal Market Data (MMD) or another comparable service or index, as of the date that the interest rates are determined, taking into account any original issue discount or premium; (d) the weighted average maturity of the principal payments due under the Note shall not exceed 20 years after the original issue date of the Note; (e) the last principal payment date under the Note shall not extend beyond the reasonably expected weighted economic life of the Project; and (f) subject to the foregoing, the actual amount, interest rates, principal maturities, and date of the Note shall be approved by an Authorized Officer, as evidenced by the execution thereof.

Section 4. The Board acknowledges that if there is a failure to make, as and when due, any payment of the principal of, premium, if any, and interest on any promissory note issued by the Institution as a Participating Institution to the Authority under the Program, including without limitation the Note and any amendments thereto, the State Comptroller is authorized under the Program and Section 23-30.29:3 of the Code of Virginia of 1950, as amended, to charge against appropriations available to the Institution all future payments of principal of, premium, if any, and interest on such promissory note when due and payable and to make such payments to the Authority or its designee, so as to ensure that no future default will occur on such promissory note.

Section 5. The Board agrees that if the Authority determines the Institution as a Participating Institution shall be subject to continuing disclosure obligations under Rule 15c2-12 of the federal Securities and Exchange Commission with respect to any Pooled Bonds, (a) an Authorized Officer shall, and is hereby authorized and directed to, enter into a continuing disclosure undertaking in form and substance reasonably satisfactory to the Authority, and (b) the Institution will comply with the provisions and disclosure obligations contained therein.

Section 6. The Board designates the <u>Vice President for Finance</u> to be responsible for implementing procedures to monitor post-issuance compliance with covenants in any loan agreement between the Institution as a Participating Institution and the Authority, including the Loan Agreement and any amendments thereto, related to maintaining tax-exempt status for federal income tax purposes of interest on any Pooled Bonds, including without limitation monitoring the use of any portion of all Institution Capital Projects financed or refinanced with such Pooled Bonds and compliance with any applicable federal income tax remedial action requirements in connection with certain changes in such use. Such officer shall make a determination as to such post-issuance compliance at least annually for so long as such Pooled Bonds remain outstanding.

WHEREAS, there have been passed by the General Assembly of Virginia and signed by the Governor acts entitled "Commonwealth of Virginia Higher Educational Institutions Bond Act of 2012" (the "2012 Act") "Commonwealth of Virginia Higher Educational Institutions Bond Act of 2011" (the "2011 Act"), "Commonwealth of Virginia Higher Educational Institutions Bond Act of 2010" (the "2010 Act"), "Commonwealth of Virginia Parking Facilities Bond Act of 2009" (the "2009 Act"), "Commonwealth of Virginia Higher Educational Institutions Bond Act of 2009" (the "2009 Act"), "Commonwealth of Virginia Higher Educational Institutions Bond Act of 2008" (the "2008 Act"), "Commonwealth of Virginia Higher Educational Institutions Bond Act of 2007" (the "2007 Act"), and "Commonwealth of Virginia Higher Educational Institutions Bond Act of 2006" (the "2006 Act") and, together with the 2007 Act, 2008 Act, 2009 Acts, 2010 Acts, 2011 Acts and the 2012 Act, the "Acts");

WHEREAS, pursuant to the Acts, the Treasury Board of the Commonwealth of Virginia (the "Treasury Board") is authorized, by and with the consent of the Governor, to sell and issue bonds or bond anticipation notes of the Commonwealth of Virginia (the "Commonwealth") for the purpose of providing funds, together with other available funds, for paying the cost of acquiring, constructing, renovating, enlarging, improving and equipping certain revenue-producing capital projects at certain institutions of higher learning of the Commonwealth and for paying issuance costs, reserve funds and other financing expenses (the "Financing Expenses"), all in accordance with the provisions of Section 9(c) of Article X of the Constitution of Virginia;

WHEREAS, for the College of William and Mary (the "Institution"), such revenue-producing capital projects include <u>Construct New Dormitory</u>, 204-17808; and <u>Renovate Dormitories</u>, 204-17933 (each individually, a "Project" and, collectively, the "Projects"); and

WHEREAS, the Treasury Board is proposing to sell and issue bonds or bond anticipation notes pursuant to the Acts for such revenue-producing capital projects, in one or more series;

NOW, THEREFORE, BE IT RESOLVED BY THE RECTOR AND VISITORS OF THE COLLEGE OF WILLIAM AND MARY:

Section 1. The Board of Visitors of the Institution (the "Board") requests the Treasury

Board to sell and issue bonds (the "Bonds") or bond anticipation notes ("BANs") in an aggregate principal amount not to exceed \$\frac{14,411,000}{\text{11,000}}\text{ to finance all or a portion of the costs of each Project plus Financing Expenses (for each individual Project, the "Individual Project Bonds" or "Individual Project Notes" and, collectively, the "Individual Project Borrowing" and for all Projects, the "Project Bonds" or "Project Notes" and, collectively, the "Project Borrowings"). The Individual Project Borrowings will be identified by amount by the State Treasurer upon issuance of any Bonds or BANs.

Section 2. With respect to each Project, the Board (a) covenants to fix, revise, charge and collect student housing revenues and other rates, fees and charges, for or in connection with the use, occupation and services of such Project and (b) pledges such rates, fees and charges remaining after payment of (i) the expenses of operating such Project and (ii) the expenses related to all other activities funded by the student housing revenues ("Individual Project Net Revenues") to the payment of the principal of, premium, if any, and interest on the Individual Project Borrowing relating thereto. The Board further covenants that it will fix, revise, charge and collect such rates, fees and charges in such amounts so that Individual Project Net Revenues will at all times be sufficient to pay, when due, the principal of, premium, if any, and interest on the related Individual Project Borrowing and on any other obligations secured by such Individual Project Net Revenues (such payments collectively the "Required Payments"). Each Individual Project Borrowing shall be secured on a parity with other obligations secured by the Individual Project Net Revenues relating to such Individual Project Borrowing (other than any obligations secured by a prior right in Individual Project Net Revenues). Any Individual Project Net Revenues pledged herein in excess of the Required Payments for an Individual Project Borrowing may be used by the Institution for any other lawful purpose.

Section 3. It is hereby found, determined and declared that, based upon responsible engineering and economic estimates and advice of appropriate officials of the Institution, as shown on the Financial Feasibility Studies attached hereto as Exhibit A, with respect to each Project, the anticipated Individual Project Net Revenues pledged herein will be sufficient to pay the Required Payments for such Project so long as the aggregate amount of net debt service on the Individual Project Borrowing for such Project actually payable in any bond year does not exceed the amounts assumed in the Financial Feasibility Study relating thereto.

Section 4. The Board covenants that the Institution will furnish the Treasury Board its general purpose financial statements, within 30 days of their issuance and receipt, audited by a firm of certified public accountants or the Auditor of Public Accounts which shall include a schedule of revenues and expenditures for auxiliary enterprise systems. If Individual Project Net Revenues for any Project are insufficient to pay Required Payments for such Project during such period, the

Institution shall provide evidence of a plan to generate Individual Project Net Revenues for such Project sufficient to make such Required Payments in the future.

Section 5. The Board covenants that so long as any of the Project Notes are outstanding, the Institution will pay to the State Treasurer, not less than 30 days before each interest payment date, an amount estimated by the State Treasurer to be due and payable on such date as interest on the Project Notes. The Board covenants that so long as any of the Project Bonds are outstanding, the Institution will pay to the State Treasurer, not less than 30 days before each interest or principal payment date, the amount certified by the State Treasurer to be due and payable on such date as principal of, premium, if any, and interest on the Project Bonds.

Section 6. The Board covenants that the Institution will pay from time to time its proportionate share of all expenses incurred in connection with the sale and issuance of any series of Bonds that includes Project Bonds or Project Notes and all expenses thereafter incurred in connection with the Bonds, including without limitation the expense of calculating any rebate to the United States of the earnings derived from the investment of gross proceeds of the Bonds, all as certified by the State Treasurer to the Institution.

Section 7. The Board covenants that the Institution will not take or omit to take any action the taking or omission of which will cause the Bonds to be "arbitrage bonds" within the meaning of Section 148 of the Internal Revenue Code of 1986, as amended, including regulations issued pursuant thereto (the "Code"), or otherwise cause interest on the Bonds to be includable in the gross income of the owners thereof for federal income tax purposes under existing laws. Without limiting the generality of the foregoing, the Institution will pay from time to time its proportional share of any rebate to the United States of the earnings derived from the investment of the gross proceeds of the Bonds.

Section 8. The Board covenants that the Institution will proceed with duc diligence to undertake and complete the Projects and that the Institution will spend all of the available proceeds derived from the sale of the Project Borrowings for costs associated with the Projects and appropriated for the Projects by the General Assembly.

Section 9. The Board covenants that the Institution will not permit the proceeds of each Individual Project Borrowing to be used in any manner that would result in (a) 5% or more of such proceeds being used in a trade or business carried on by any person other than a governmental unit, as provided in Section 141(b) of the Code, (b) 5% or more of such proceeds being used with respect to any output facility within the meaning of Section 141(b)(4) of the Code, or (c) 5% or more of such proceeds being used directly or indirectly to make or finance loans to any persons other than a

The Institution need not comply with such covenants if the Institution obtains the written approval of the State Treasurer and an opinion of nationally recognized bond counsel acceptable to the Treasury Board that such covenants need not be complied with to prevent the interest on the Bonds from being includable in the gross income of the owners thereof for federal income tax purposes.

Section 10. The Board covenants that for so long as any of the Bonds are outstanding the Institution will not enter into any operating lease, management contract or similar agreement with any person or entity, other than a state or local governmental unit, for all or any portion of any of the Projects without first obtaining the written approval of the State Treasurer and an opinion of nationally recognized bond counsel acceptable to the Treasury Board that entering into such agreement will not cause the interest on the Bonds to be included in the gross income of the owners thereof for federal income tax purposes.

Section 11. The Board covenants that for so long as any of the Bonds are outstanding, the Institution will not sell or dispose of all or any part of any of the Projects without first obtaining the written approval of the State Treasurer and an opinion of nationally recognized bond counsel acceptable to the Treasury Board that such sale or disposition will not cause interest on the Bonds to be included in the gross income of the owners thereof for federal income tax purposes.

Section 12. The officers of the Institution are authorized and directed to execute and deliver all certificates and instruments and to take all such further action as may be considered necessary or desirable in connection with the sale and issuance of the Bonds.

Section 13. The Board acknowledges that the Treasury Board will rely on the representations and covenants set forth herein in issuing the Bonds, that such covenants are critical to the security for the Bonds and the exclusion of the interest on the Bonds from the gross income of the owners thereof for federal income tax purposes, that the Board will not repeal, revoke, rescind or amend any of such covenants without first obtaining the written approval of the Treasury Board, and that such covenants will be binding upon the Board so long as any of the Bonds are outstanding.

Section 14. This resolution shall take effect immediately.

Wells; other College and VIMS staff; and staff from Wells Fargo Advisors, the Board of Visitors' investment consultant.

Timothy Dunn, Chair, convened the Committee meeting at 9:25 a.m. Recognizing that a quorum was present, Mr. Dunn requested a motion to approve the minutes of the February 3, 2012 meeting. Motion was made by Mr. Scott, seconded by Mr. Herget and approved by voice vote of the Committee.

Vice President Samuel Jones presented an overview of the College budget, addressing priorities within the College's Six-Year Plan. In an institution-wide effort to become more cost efficient, \$2.6 million in reallocations will shift current funds to bigher priorities, including pay increases for faculty and staff. The FY 2013 budget also includes an additional \$1.4 million from all sources in need-based financial aid for undergraduates.

The College will receive \$1.2 million in new funds from the State which will help support ongoing operating expenses. However, there are offsetting costs imposed by the State budget which include: a loss of \$339,000 in State support for the Eminent Scholars program; an additional cost of approximately \$1.3 million to VRS and to the State benefit system; \$2.4 million the College will need to raise to pay its share of a proposed 3 percent bonus for State employees (contingent upon the Commonwealth meeting certain revenue goals by June 30, 2012). Although capital projects continue to receive strong support from the Commonwealth, State support for the College's operating budget will be less than 13 percent for FY 2013.

Vice President Jones presented to the Committee the tuition and fee proposal for FY 2013, with three variations for consideration, all intended to keep any increase in tuition and fees below 5%. After a lengthy discussion, the Chair requested that Vice President Jones prepare and present for approval to the Full Board a revised tuition and fee resolution, incorporating modifications as agreed upon by the Committee. As a result of the modifications, tuition & mandatory fees for instate undergraduate students will increase \$438 (3.3%) and \$1382 (3.8%) for out-of-state undergraduates for FY 2013. Total costs, including tuition, fees, room and board, will be \$22,888 (3.9% increase) for in-state undergraduates and \$46,662 (4.0% increase) for out-of-state undergraduates.

Mr. Dunn then asked for a motion to approve **Resolution 36**, FY 2012-13 Tuition and Fee Structure for Full- and Part-time Students, amended as recommended by consensus of the Committee; and the following resolutions as a block: **Resolution 35**, FY 2012-13 Operating Budget for Educational and General Programs; **Resolution 37**, FY 2012-13 Auxiliary Enterprise Operating Budgets; **Resolution 38**, FY 2012-13 Sponsored Programs Operating Budget; **Resolution 39**, FY 2012-13 Student Financial Assistance; **Resolution 40**, FY 2012-13 Applied Music Fee; **Resolution 41**, FY 2012-13 Board of Visitors Private Funds Budget; and **Resolution 43**, Creation of Quasi-Endowment: Muscarelle Museum of Art. Motion was made by Mr. Flippen, seconded by Mr. Scott, and approved by voice vote of the Committee. (**Resolution 36(R)** is appended.)

Virginia Institute of Marine Science Dean/Director John Wells reviewed the 2012 General Assembly operating and capital actions impacting the FY 2013 and 2014 budget for VIMS. Mr. Wells highlighted FY 2013 funding priorities and discussed revenues and expenditures/reallocations. Mr. Dunn made a motion to approve **Resolution 44**, FY 2012-13 Operating Budget. Motion was seconded by Mr. Herget and approved by voice vote of the Committee.

Due to time constraints, the staff of Wells Fargo Advisors was unable to present the quarterly report on the Board of Visitor's investment portfolio. Mr. Dunn reported that FYTD 2012 the endowment increased 0.7% and total Board assets, as of March 31, 2012 are at \$67.8 million (includes Muscarelle gift). A revision to the Investment and Spending Policy for Endowment includes adjusting the language regarding afternative investments to clarify the role and management within that fund and an update of the benchmark asset allocation ranges to allow the Investments Subcommittee more flexibility. Mr. Dunn asked for a motion to approve Resolution 42, Revision to the Investment and Spending Policy for Endowment. Motion was made by Mr. Campbell, seconded by Mr. Scott, and approved by voice vote of the Committee.

There being no further business, the Committee adjourned at 11:22 a.m.

For fiscal year 2013, it is recommended that the total cost (tuition, fees, room, and board) for an in-state undergraduate student increase 3.9% to \$22,888 and the total cost for an out-of-state undergraduate student increase 4.0% to \$46,662. Within these amounts, tuition and fees increase 3.3% and 3.8%, respectively. Tuition and fee increases for in-state and out-of-state graduate and professional students range from 3.9% to 7.9%, reflecting market conditions in each area.

Reflecting the Board of Visitors' ongoing commitment to the College's Six Year Plan, revenue generated through the proposed increases allows the College to annualize the cost of faculty and staff salary increases provided in FY 2012 and support its share of a 3% salary bonus for faculty and staff, as well as state mandated increases in health insurance and retirement in FY 2013. These funds also provide targeted support for undergraduate and graduate student financial aid consistent with the College's Six Year and Strategic Plans.

Fee allocations for auxiliary services, facility debt service, student activities, and average charges for room and board support projected expenditures for operations and required debt service on facilities while allowing some contribution to the College's auxiliary reserve.

THEREFORE, BE IT RESOLVED, that the Board of Visitors of the College of William and Mary in Virginia approves the FY 2012-13 Tuition and Fee Schedule as well as room and board charges as shown on the attached schedules.

COLLEGE OF WILLIAM AND MARY FY 2014 OPERATING AND CAPITAL BUDGET AMENDMENTS

Using guidance from the Governor's Office, the Secretary of Education, and the State Department of Planning and Budget, the College of William and Mary has developed operating and capital budget amendments for consideration by the Governor as part of the Commonwealth's 2012-14 budget development process.

Operating budget requests are limited in number and reflect high priority items in the College's Six-Year Plan. Guidance from the Secretary of Education states that an "institution's funding requests should be consistent with the priorities noted in its updated Six-Year Plan, which supports both the Governor's priorities and the goals of the TJ21 legislation". Capital requests should be limited to supplemental funding for previously approved projects. Funds should not be requested for items typically considered "state-wide" issues by the Commonwealth of Virginia. State-wide issues include faculty and staff salaries, base adequacy funding, undergraduate student financial assistance, and continuation of the Higher Education Equipment Trust Fund program.

THEREFORE, BE IT RESOLVED, That the Board of Visitors of the College of William and Mary approves the administration's recommended operating and capital budget amendments for the College for submission to the Commonwealth as part of the 2012-14 budget development process.

FY 2014 OPERATING BUDGET AMENDMENTS

• Enrollment Growth

FY 2013-14 \$ 356,000 GF

The College has committed to increasing in-state undergraduate enrollment by 150 students over the next four years with the first cohort arriving in Fall 2011. Enrollment projections submitted as part of the Six Year Plan reflect this increase. The College anticipates adding additional resources to support these students and ensure their success.

• Center for Energy and the Environment

FY 2013-14 \$ 400,000 GF

Building on existing program strengths of the College and the Virginia Institute of Marine Science, the Center for Energy and the Environment supports research and economic development within the commonwealth. Program areas include alternative fuel and energy sources and remediation and restoration of Virginia waterways including the Chesapeake Bay. The CEE will provide expanded opportunities for STEM training of undergraduates, adding to the Commonwealth's workforce pool. Included in this request is funding support for high speed computing, computational modeling and simulation, and incremental support for the College's Existing Center for Geospatial Analysis.

FY 2014 CAPITAL BUDGET AMENDMENTS

• Renovation: Tyler Hall

FY 2013-14 \$ 16,364,000 GF

The 2012-14 Appropriation Act authorizes the College to proceed with detailed planning for the renovation of Tyler Hall. This amendment requests funds to complete planning and proceed with renovation prior to the 2014-16 biennium. Once renovated, Tyler Hall will house the departments of Government, Economics, and Public Policy.

• Renovation: Residence Life Facilities

FY 2013-14 \$ 9,650,000 NGF

Over the past year the College has developed a plan to accelerate the renovation of its residence halls by taking facilities completely off-line for a year and the surrounding summers. This approach requires additional debt authority beyond the \$5 million previously authorized for dormitory renovations. The requested authority allows the College of move forward with full renovation of Chandler Hall, air conditioning of Barrett Hall, and planning for the full renovation of Landrum Hall.

COLLEGE OF WILLIAM AND MARY 2012 DEBT MANAGEMENT REPORT

The College of William and Mary Debt Management Policy was established to address all forms of long-term debt including fixed and variable rate options for capital construction projects and capital leases. Key objectives of the policy include the following:

- To provide guidance to the College in undertaking long-term debt obligations benefiting the College;
- To provide a structured framework for the issuance of long-term debt;
- To provide an on-going process for the College to evaluate the level of its annual debt service and consolidated debt burden; and
- To document the exercise of due diligence in the execution and/or management of the College debt portfolio and use of its financial resources.

The Debt Management Policy is applicable to the College of William and Mary, the Virginia Institute of Marine Science, and Richard Bland College.

Background

To date, the College of William and Mary has issued none of its own debt but rather had debt issued on its behalf by the Commonwealth of Virginia. While the College remains responsible for principal and interest associated with this debt, this approach allows the College to minimize issuance costs and take advantage of the Commonwealth's strong credit position.

Long-term debt is used primarily to support the construction or renovation of major auxiliary facilities including residence halls, university centers and dining facilities, parking improvements, and recreational and athletic facilities. College supported debt service for academic facilities has been used to provide supplemental funding for projects receiving significant support from the Commonwealth or for projects where significant private support is available. The typical debt vehicle is a 20 years, fixed rate 9(c) or 9(d) bond issued by the Commonwealth of Virginia. Over the course of the bond period, the Treasurer of Virginia may refinance projects to take advantage of cost saving opportunities.

Standard and Poor's Bond Rating

The College was required to be rated by one of the major credit rating firms as part of its application for Tier 3 status under the higher education restructuring act. The Act required that institutions have at least an "AA-" credit rating for consideration as a Tier 3 institution. In December 2011, Standard and Poor's reaffirmed its "AA" issuer credit rating for the College

citing its strong student quality and demand, consistent break-even financial performance, and solid fund raising and endowment.

Current Debt Position—As of June 30, 2012, outstanding long-term debt totaled \$204.5 million consisting of \$53.7 million in 9(c) bonds and \$150.8 million in 9(d) bonds (see Appendix A). Section 9(c) bonds are general obligation bonds issued by the Commonwealth on behalf of the College pursuant to Section 9 of Article X of the Constitution of Virginia. As such, while the College is responsible for repayment, these bonds are backed by the full faith and credit of the Commonwealth. Section 9(d) bonds are issued through the Virginia College Building Authority's Pooled Bond Program and backed by the general revenue pledge of the College. As debt is issued, the College's fee structure is adjusted to generate the funds necessary to support any new debt issuance or, in certain cases, private funds to support the necessary debt service are identified consistent with the requirements of the Debt Management Policy.

FY 2011 Debt Issues—Additional debt totaling \$22.4 million will be issued in Fall 2012. Projects supported with this debt issuance include \$8.0 million supporting xpansion of the Sadler Center and \$14.4 million supporting construction of Fraternity Houses and Dormitory Renovations. The College's FY 2013 fee structure as approved by the Board of Visitors in April, 2011 includes support for these projects.

Variable Rate Debt—The College currently has no outstanding variable rate debt.

Annual Debt Service Cost as Percentage of Total Operating Expense—The Debt Management Policy stipulates that maximum annual debt service cost as a percentage of total operating expense shall not exceed 10% and that debt issued in any given year shall be limited to an amount that allows the debt service to total operating expense ratio to remain at or below the 10% maximum. Information regarding this ratio follows:

The increase in the debt service to operating expense ratio over this period reflects College investment in new or expanded campus facilities. Major projects include construction of the Jamestown Road and Fraternity Residence Halls, the Integrated Science Center, and the School of Business facility as well as expansion of the Student Recreation Center and upgrades to the College's utility systems.

Debt Service authorized by the Board of Visitors and the Commonwealth but not yet issued—Debt supported capital project previously authorized by the Board of Visitors and the Commonwealth for which the College has not yet requested that debt be issued includes the following:

As of June 30, 2012, the Virginia Institute of Marine Science has no outstanding long-term debt nor have any new debt supported projects been authorized by the Board of Visitors or the Commonwealth of Virginia.

As of June 30, 2012, Richard Bland College does not have any long-term 9(c) or 9(d) debt. In conjunction with providing on-campus housing for its students, the institution signed a Support and Operating Agreement with the Richard Bland College Foundation to operate the residence halls opened in Fall, 2008. The Foundation financed this project by issuing \$27 million in tax exempt revenue bonds through the Industrial Development Authorities of Prince George, Dinwiddie, Sussex, and Isle of Wight counties. The College has made a general revenue pledge approved by the 2007 General Assembly in support of the debt retirement and operating costs of the residence halls. For accounting purposes this is recognized as a long-term obligation capital lease on the books of Richard Bland College.

Faculty Positions

FY 2013-14 \$251,411 GF (on-going) \$140,270 GF (one-time) 2.0 FTE

This initiative requests establishment of two faculty positions that will aid the Institute's three-part mission to educate students and citizens, conduct interdisciplinary research in coastal ocean and estuarine science, and provide advisory service to policy makers, industry, and the public. Establishing new faculty positions will increase the number of students in the STEM disciplines, enhance VIMS' ability to educate the public and improve science literacy, provide necessary information to local, state and federal regulatory agencies, and conduct cutting-edge research in emerging areas such as renewable energy and biosensor development that create economic opportunities. Moreover, an increase in faculty will enable us to respond more quickly and effectively to the needs of the Commonwealth. Over the years, VIMS' faculty have conducted research on many critical State issues such as the Pfiesteria outbreak, introduction of non-native oysters in Chesapeake Bay, and the population status of Atlantic menhaden, and have disseminated advice on those areas to the Commonwealth. The *Code of Virginia* explicitly defines VIMS as the Commonwealth's advisor on marine-related issues and outlines over 30 VIMS-specific mandates.

Information Technology & High Performance Computing

FY 2013-14 \$409,302 GF (on-going) \$785,000 GF (one-time) 3.0 FTE

This initiative requests equipment and operating funds to centralize support for the High Performance Computing platforms, which includes increasing the network capacity by tenfold to ensure state-of-the-art modeling and simulation computations. The equipment upgrades will meet the rapidly-growing needs of increased data collection capacity for highly-sophisticated programs that conduct fish DNA analysis, engage in genome studies, and conduct other real-time simulation and modeling analyses in the coastal and ocean environment. VIMS fulfills a unique niche in HPC by modeling water quality analysis for environmental and regulatory purposes, and storm-surge flooding predictions from hurricanes for risk assessment purposes.

Research Equipment Service Contracts

FY 2013-14 \$300,000 GF 0.0 FTE

This proposal requests funds for research and academic support by providing a mechanism to sustain equipment purchased by the State's Higher Education Equipment Trust Fund (HEETF). The HEETF allocations to VIMS over the past five years have been approximately \$2.5 million (\$500,000 per year), which has allowed VIMS to procure equipment items such as DNA sequencers, Gas Chromatographs, Mass Spectrometers, and related analytical equipment. These are mission-dependent scientific pieces of equipment, all of which support STEM activities at VIMS. Specific examples include genetic identification of fish species and fish stocks in support of management at both the national and international level, isolation and identification of harmful algal bloom species (including those producing toxins), identification and isolation of microscopic parasites of commercially valuable crustaceans (crabs and lobsters), and identification and environmental tracking of man-made complex organic compounds with known or potential human and/or environmental impacts. Moreover, VIMS has been able to pair HEETF funds with external grant and contract research activities in a way that has allowed VIMS to establish a competitive advantage for conducting cutting edge STEM research, particularly in Marine Science. Failure to maintain manufacturer dependent service compromises the full appreciation of the investment by the Commonwealth, increases expenses inefficiently by having ad hoc service calls, and importantly, can extend the research downtime thus delaying grant and contract deliverables and advisory service responses to the Commonwealth and other state agencies.

CAPITAL AMENDMENTS

Planning: Construct New Oyster Hatchery

\$1,152,000 GF

This project supports the construction of a new 22,000 square-foot Hatchery Complex to replace the 40 year old VIMS Oyster Hatchery and will include office and laboratory space for oyster research, restoration efforts, industry and economic development, marine finfish culture and educational programs. This project must be coupled with the relocation of the Facilities Management Complex.

Planning: Relocate and Construct Facilities Management Maintenance Facility

\$576,000 GF

This project provides for a modern replacement building to house administrative offices, maintenance trades shops, automotive and equipment repair garage, grounds keeping, housekeeping, storage, and shipping and receiving. The new 15,000 square-foot facility would be relocated to a more appropriate part of campus to make way for the New Oyster Hatchery which must be located along the shoreline.

New Construction: Eastern Shore Administration & Education Complex

\$2,663,000 GF

This project supports the design and construction of three new buildings that total 10,200 square-feet to replace outdated buildings vulnerable to flooding on the Wachapreague campus. The complex includes administrative offices, an educational conference center with classrooms, convertible meeting rooms, a distance learning classroom, and a maintenance shop to support buildings, grounds, and vessel repairs. VIMS intends to fund the planning for this project with a combination of private funds and institutional funds.

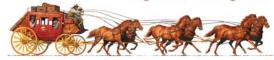




Investment Portfolio Evaluation For Periods Ending June 30, 2012

I. Executive Summary

Observations & Recommendations

After four consecutive quarters of growth in calendar year 2011, GDP has yet again declined. Fourth quarter 2011 annualized GDP was a solid 3.0% but dipped to 1.5% in 1Q 2012 and is expected to be just as low for 2Q 2012 and the rest of the year. Financial markets have seen their optimism deflated by periods of weaker growth due to many factors including the fluid European crisis, weaker consumer spending, and the stagnant labor market. Jobless claims and unemployment has moved slightly higher throughout 2012.

After two strong quarters of absolute returns, equity markets sold off sharply in April and May with the S&P 500 Index declining 6.6% for the two months and the MSCI EAFE Index losing 13.0% as the global financial crisis (growth and labor) took its toll. However, patient investors were rewarded in June as global equity markets rallied with the S&P 500 Index up 4.1% and the MSCI EAFE Index up 7.1%. It appears that any positive economic and/or financial data sparks the markets and investors are seeking risk assets given the historically low yield environment.

U.S. Treasury prices rose and yields declined across all maturities during the 2nd quarter with high yield, investment grade financials, and emerging markets debt widening the most. The 10-year treasury yield ended June at 1.66%. The Fed continued to say that they are likely to keep the federal funds rate near zero until late 2014. Emerging markets sovereigns and corporations issued a large supply of debt as inflows into this asset class left investors flush with cash. The Emerging Markets Debt asset class generated a 7.1% YTD gain as measured by the JPM Global Diversified Index. High yield issuance was much lower after a record issuance of \$107 million in 1Q 2012, but the asset class has still been one of fixed income's best in 2012, rising 6.7%.

<u>Total Portfolio</u>: *The William & Mary Board of Visitors (BOV) Endowment* lost 3.3% for the 2nd quarter. For the fiscal year ending June 30, 2012, the portfolio was down 2.7%. Most of the negative performance for the fiscal year came from the large cap manager, Aletheia and the

international and emerging market equities. International and emerging markets were a difficult asset class for this time period and further discussion on the committee's decision with Aletheia is below. Overall portfolio asset allocation was in line with policy targets at quarter-end.

Domestic Equity: The committee elected to terminate the Aletheia account in late May of 2012. With the proceeds from the termination, it was decided to make three purchases over the following three months of the passively managed S&P 500 ETF, the SPDR SPY. The College issued a formal Request for Proposal to find a suitable, actively managed replacement. Fifteen managers responded to the RFP and a summary will be provide to the Investment Sub-Committee to decide upon the manager.

BlackRock Large Cap Value posted a loss of 6.4% for the 2nd quarter as compared to the Russell 1000 Value's loss of 2.2%. The lead Portfolio Manager, Bob Doll, has announced his retirement effective July 2012. Chris Leavy will be the successor to Doll. Leavy previously worked at Oppenheimer where he served as CIO, Head of Value Equities and as a portfolio manager. His background has emphasized more of the bottom-up, fundamental analysis but he does have some experience with quantitative analysis similar to Doll's structure. He has no plans to significantly change the architecture that Doll has established with this portfolio. However, with this news, our Manager Strategy Group has placed the portfolio under "Watch."

Artisan Mid Cap Value posted a loss of 5.7% for the quarter while the Russell Midcap Value index lost 3.3%. For the fiscal year-to-date, the fund is down 0.5% and likewise the benchmark lost 0.4%. The portfolio was hurt by an overweight position to technology, energy, and industrials as well as an underweight to utilities. Stock selection through most of the portfolio was relatively weak. On a positive note, many of the fund's top performers for the quarter were insurance names such as Allstate, Allied World Assurance Company, and Arch Capital.

Royce Opportunity fund lost 5.2% for the quarter. The fund's benchmark lost 3.5% but the fund has gained 11.2% for the YTD period, ahead of the benchmark's gain of 8.5%. For the quarter, 6 of the 9 sectors were negative contributors to the fund with information technology, industrials, and energy having the largest negative impact. Stock selection in aggregate was additive to returns relative to the benchmark, especially within the consumer discretionary sector. Top performers included Cray, Cambrex Corporation, and MDC Holdings while Maxwell Technologies, bebe stores, and OM Group were the worst performing stocks.

International Equity: Dodge & Cox International lost 8.4% for the 2nd quarter. Relatively, the fund underperformed the MSCI EAFE for the quarter by 150 bps. The fund's overweight to healthcare helped results as this was the best performing sector for the quarter. Bayer and GlaxoSmithKline were both positive for the quarter. However, an overweight to information technology was detrimental as this was the worst performing sector for the quarter. Stock selection within financials and an underweight to consumer staples was a drag on performance. The account was managed by Delaware for most of the fiscal year (through February 2012).

Domestic Fixed Income: The PIMCO Total Return Fund gained 2.8% for the quarter versus a gain of 2.1% for the benchmark. Year-to-date, the fund has outperformed by 340 bps (5.8% vs. 2.4%). Most bonds gained in absolute terms during the quarter, helped by a sharp decline in US Treasury yields as investors fled risky assets. Factors that attributed to performance include; exposure to Canada, an underweight to corporate bonds which lagged like-duration Treasuries, exposure to local currency debt in Brazil and Mexico, and an allocation to select non-agency mortgage-backed debt. Detracting from performance was an underweight to longer maturity US interest rates as the yield curve flattened.

Pioneer Strategic Income fund gained 1.1% for the 2nd quarter but lagged the Barclays Aggregate index which posted a gain of 2.1%. Interest rate sensitivity was the primary reason behind the fund's relative

underperformance as it detracted 57 bps from relative returns. Non-dollar currency exposure also hurt the fund, detracting 18 bps from relative performance. The fund's bias to lower quality bonds helped performance as did the yield curve positioning.

International Fixed Income: The *GMO Global Bond Strategy* gained 1.3% for the 2nd quarter compared to the Citigroup World Government Bond index's gain of 0.9%. Exposure to the Short Duration Collateral Fund and the World Opportunity Overlay Fund contributed positively to the quarter's gains. Developed markets interest rate positioning and exposure to emerging country debt detracted.

The *GMO Emerging Country Debt Strategy* returned 0.3% in the quarter while the JPM EMBI Global Diversified returned 2.8%. Market selection accounted for 85 bps of negative alpha, almost entirely due to the overweight in Argentina which was the worst performer for the quarter (-8.8% return). The overweight in the Ivory Coast added 22 bps. Stock selection in Venezula (the second worst performer for the quarter) was also negative.

Alternatives: The alternative portfolio lost 1.3% for the 3-month period ending May 31, 2012 but relatively outperformed the benchmark's loss of 1.8%. For the fiscal year-to-date, the alternatives are down 4.1% while the HFRI Fund of Funds index lost 5.3%. Commodities were hit the hardest in the quarter with the benchmark losing 13.3% for the 3-month period ending May 31, 2012. Your investment in Gresham was also negative but relatively outperformed with a negative 12.7%. The diversified funds (Corbin Pinehurst and Dorchester) were both positive for the 3-month period with gains of 0.5% and 0.2% respectively.

Periods Ending June 30, 2012– Performance*



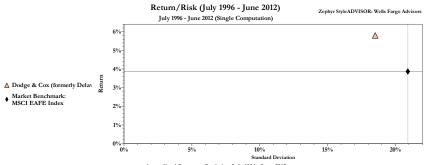

Regional Distribution BOV Developed International





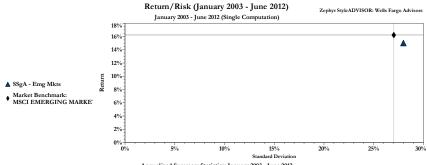


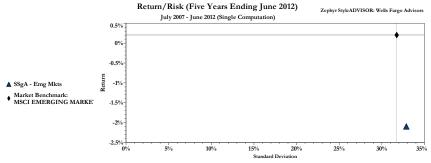

V. Capital Markets Review

Second Quarter 2012 - Overview

Capital Markets Overview

A positive first quarter led to a celebration of things to come for the markets, but the party was short lived. Most leading economic indicators showed evidence of a U.S. economy that continues to expand, but the pace of growth is not enough to satisfy job expectations by households, profits of investors or the public purse at all levels of government. While the U.S. economy has been resilient to global problems, investors remain sensitive to Europe's deepening financial problems.

The U.S. economy continues to grow at a below-average rate. This quarter marked the three-year anniversary from the end of the 2008-2009 recession. Unlike previous economic cycles, the current recovery is slower than nine out of the 10 previous recoveries since 1949. Corporations continue to deleverage debt, cautiously invest in growth, and are reluctant to add to payrolls due to market uncertainty.

Despite a 4.1% gain in June, the S&P 500 Index ended the quarter with a 2.8% loss. The Dow Jones Industrial Average also gained 4.1% in June, trimming its quarterly loss to 1.8%. The NASDAQ Composite gained 3.9% in June, but still lost 4.8% for the quarter. Although suffering second quarter losses, the major averages finished the first half of the year with encouraging gains. The S&P 500 is up 9.5%, the Dow is up 6.8%, and the NASDAQ is up 13.3% for the year.

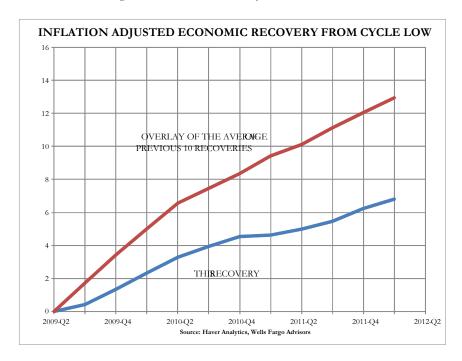
European market concerns were eased after Greece elected the pro-austerity party. Germany agreed again to expanded measures to reduce borrowing costs designed to stem further financial turmoil.

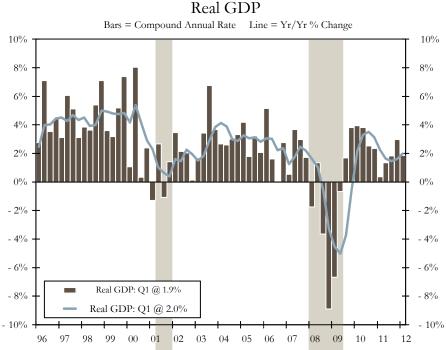
Albeit slow, the U.S. economy is doing better than many foreign economies and has strengthened the dollar while pushing commodities lower. Consequently, U.S. stocks have outperformed commodities. This is a change from the past decade when commodities outperformed stocks.



Economy remains sluggish, but showing signs of improvement

Economic growth in this recovery continues to fall well short of what the U.S. experienced in the last 10 recoveries.







Most sectors declined in the second quarter as defensive sectors outperformed cyclicals

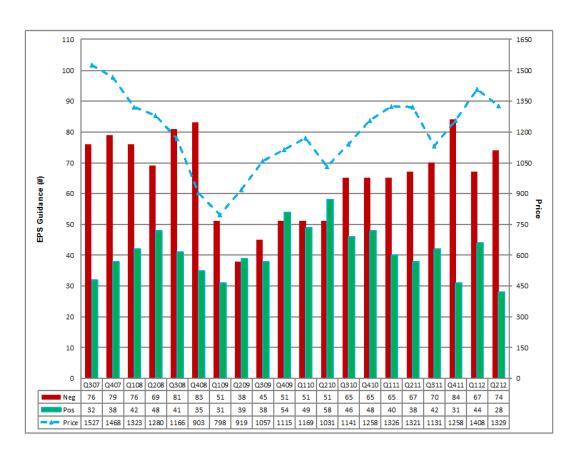
- > Telecoms and Utilities were the big winners of the quarter as investors sought larger dividend paying companies with greater revenue based in the United States.
- Fears of an economic slowdown in China and the United States led to softer performance for the Industrial, Material, and Energy sectors.
- Value outperformed Growth as credit downgrades in the financial sectors in Europe and the United States weighed on Growth strategies.

Second quarter earnings guidance turned more negative

- ➤ 74 companies in the S&P 500 have issued negative EPS guidance for the second quarter. 28 companies have issued positive EPS guidance.
- Compared to the trailing 5 Year Average, there were 32% fewer positive preannouncements and 13% more negative preannouncements made regarding Q2 earnings.
- The average price decline* after negative guidance was -1.4% in Q2 and the 5 year average decline was -1.5%.
- The average price increase* after positive guidance was 2.4% in Q2 and the 5 year average increase was 3.0%.

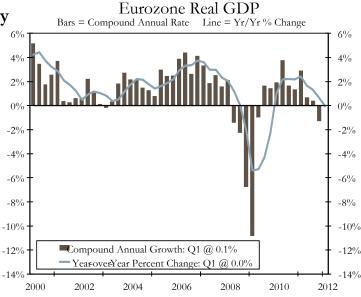
Second Quarter 2012 - International

International markets persevere in the face of a very slow global recovery

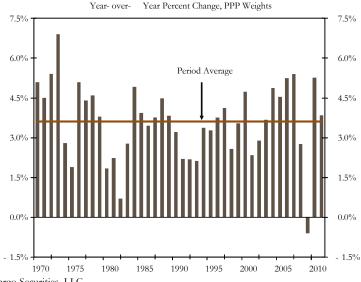
- European woes continue to weigh on the markets. The European crisis remains the principal risk to global confidence. June provided a few glimmers of hope that Europe might get its act together after all.
- ➤ Greek voters gave austerity measures another chance. The proausterity parties won by a slight margin on the June 17th election. However, the new coalition government wants to renegotiate the terms of the bailout package.
- ➤ On their June 29th meeting, the EU leaders agreed in principle to create an EU-wide supervisory mechanism that will use available bailout funds to recapitalize troubled banks. In return for direct support (for their banks), EU members have agreed (always in principle) to turn over national bank control to Brussels.

Conditions of world economy continue to improve at a slower rate than expected

- ➤ USA and China (two biggest world economies) are experiencing a sluggish rebound.
- ➤ Growth in the Chinese economy remains positive, but has slowed this year. Real GDP rose only 8.1%, the slowest year-over-year growth rate since the second quarter of 2009.
- Many European economies have slipped back into recession this year.



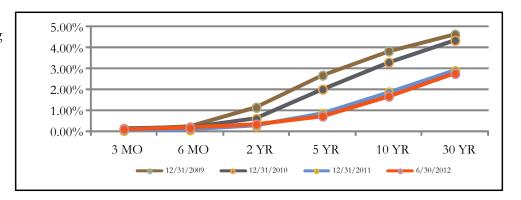
Real Global GDP Growth



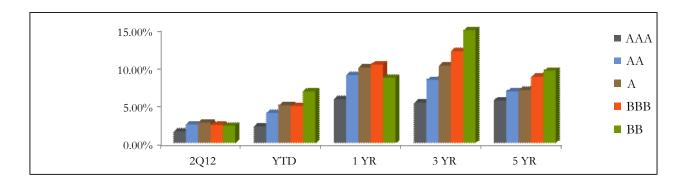


Investors flock to the safety of Treasuries under global uncertainty

- The yield on the benchmark 10-year Treasury note set a new all time record low of 1.47% at the end of May, ending the quarter only slightly higher at 1.67%.
- ➤ Treasury prices, which move inversely to yields, increased substantially to generate a return on the Barclays Long Term U.S. Treasury benchmark of 10.57% for the quarter. The shorter-term Barclays 1-3 Year Treasury benchmark posted a modest 0.20% return.



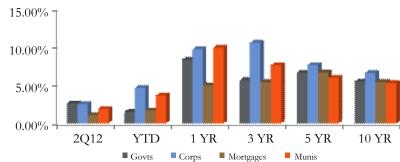
> The Fed announced it will be extending its program referred to as "Operation Twist", the process of selling shorter-term Treasuries and buying longer-term Treasuries in an effort to keep long term rates down.

Top quality sovereign debt has benefited from perceived safe-haven flows

- Investors reacted to continued struggles in several Euro Nation countries, particularly Spain, by shifting into a "risk off" mentality that focused on retaining capital instead of searching for yield.
- Safe-haven debt rallied as investors avoided the uncertainty associated with bailout packages and austerity measures taking place in several European countries.



- Germany, Switzerland, Sweden and Japan all offer lower yields than U.S. Treasuries. Yields on Spanish debt increased near 7%, a level that is considered unsustainable in the long run.
- For the quarter, government debt slightly outperformed corporate with returns of 2.63% and 2.52%, respectively. Municipal bonds also performed well as they saw solid new-issue demand and continued strong bond fund inflows, returning 1.88% for the quarter.

Strengthening U.S. Dollar keeps downward pressure on commodity prices

- The fear of a prolonged global slowdown kept pressure on commodity prices this quarter. The financial crisis in Europe kept pressure on the Euro and investors favored the perceived safe haven value of the U.S. Dollar and Yen over the Euro.
- Gold pulled back and then made a modest recovery edging close to the psychologically important \$1,600 level. Gold prices floundered after recent Federal Reserve meeting minutes showed that the central bank was split on whether the U.S. economy required new monetary stimulus measures.

NASDAQ Composite - A cap-weighted index comprised of all common stocks that are listed on the NASDAQ Stock Market (National Association of Securities Dealers Automated Quotation system).

S&P 500 - A broad-based measurement of changes in stock market conditions based on the average performance of 500 widely held common stocks. This index does not contain the 500 largest companies nor the most expensive stocks traded in the U.S. While many of the stocks are among the largest, this index also includes many relatively small companies. This index consists of approximately 380 industrial, 40 utility, 10 transportation and 70 financial companies listed on U.S. market exchanges. It is a capitalization-weighted index (stock price times number of shares outstanding), calculated on a total return basis with dividends reinvested.

Russell 1000 - The 1000 largest companies in the Russell 3000 index, based on market capitalization.

Russell 2000 Value - A segment of the Russell 2000 with a less-than-average growth orientation. Companies in this index have low price-to-book and price-earnings ratios, higher dividend yields and lower forecasted growth values than the Russell 2000 Growth index.

Russell 2500 - The index consisting of the bottom 500 stocks in the Russell 1000(as ranked by market capitalization) and all of the stocks in the Russell 2000. This index is intended to be used as a measure of small to medium/small stock performance, and it represents over 22% of the Russell 3000 total market cap.

MSCI EAFE - A market capitalization-weighted index representing all of the MSCI developed markets outside North America. It comprises 20 of the 22 countries in the MSCI World. These 20 countries include the 14 European countries in the MSCI Europe and the 6 Pacific countries in the MSCI Pacific. This index is created by aggregating the 20 different country indexes, all of which are created separately.

MSCI World - This market capitalization-weighted index represents all 22 of the MSCI developed markets in the world. It is created by aggregating the 22 different country indexes, all of which are created separately.

MSCI Emerging Markets Free (EMF) - A market capitalization-weighted index representing 26 of the emerging markets in the world. Several factors are used to designate whether a country is considered to be emerging vs. developed, the most common of which is Gross Domestic Product Per Capita. The "Free" aspect indicates that this index includes only securities that are allowed to be purchased by global investors. This index is created by aggregating the 26 different country indexes, all of which are created separately.

Barclays Capital Government/Credit - This index includes all bonds that are in the Barclays Capital Government Bond and the Barclays Capital Credit Bond indices.

Barclays Capital Government Intermediate - All bonds covered by the Barclays Capital Government Bond index with maturities of 1 and 10 years.

Barclays Capital Aggregate Bond - This index is made up of the Barclays Capital Government/Credit, the Mortgage-Backed Securities, and the Asset-Backed Securities indices. All issues in the index are rated investment grade or higher, have at least one year to maturity, and have an outstanding par value of at least \$100 million.

Barclays Capital Government Long Term - All bonds covered by the Barclays Capital Government Bond index with maturities of 10 years or greater.

Barclays Capital Municipal Bond - This market cap weighted index includes investment grade tax-exempt bonds and is classified into four main sectors: General Obligation, Revenue, Insured, and Pre-refunded. To be included in this index, the original transaction size of a bond must have been greater than \$50 million.

Merrill Lynch Convertibles - The convertible securities used in this index span all corporate sectors and must have a par amount outstanding of \$25 million or more. The maturity must be at least one year. The coupon range must be equal to or greater than zero and all quality of bonds are included. Excluded from this index are preferred equity redemption stocks. When the component bonds of this index convert into common stock, the converted securities are dropped from the index.

Merrill Lynch High Yield Master - Market-cap weighted index providing a broad-based measure of bonds in the US domestic bond market rated below investment grade but not in default. Includes only issues with a credit rating of BB1 or below as rated by Moody's and/or S&P, at least \$100 million in face value outstanding and a remaining term to final maturity equal to or greater than one year.

Dow Jones Wilshire REIT Index - A measurement of equity REITs and Real Estate Operating Companies. No special-purpose or health care REITs are included. It is a market capitalization-weighted index for which returns are calculated monthly using buy and hold methodology; it is rebalanced monthly.

Citigroup 3 Month Treasury Bill - Representing the monthly return equivalents of yield averages that are not marked to market, this index is an average of the last three three-month Treasury bill issues.

50/50 Blend (S&P 500/BCIGC) - A blended benchmark consisting of 50% S&P 500 and 50% Barclays Capital Government/Credit Intermediate indices.

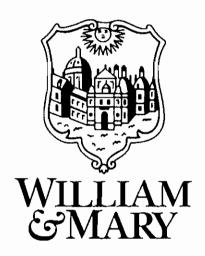

FY 2012-13 TUITION AND FEE STRUCTURE FOR FULL- AND PART-TIME STUDENTS

Consistent with tuition and fee authority granted to the College by the 2012 General Assembly, the attached schedules for full-time and part-time tuition, special and general fees, room, and board are recommended for approval by the Board of Visitors of the College of William and Mary in Virginia.

For fiscal year 2013, it is recommended that the total cost (tuition, fees, room, and board) for an in-state undergraduate student increase 3.9% to \$22,888 and the total cost for an out-of-state undergraduate student increase 4.0% to \$46,662. Within these amounts, tuition and fees increase 3.3% and 3.8%, respectively. Tuition and fee increases for in-state and out-of-state graduate and professional students range from 3.9% to 7.9%, reflecting market conditions in each area.

Reflecting the Board of Visitors' ongoing commitment to the College's Six Year Plan, revenue generated through the proposed increases allows the College to annualize the cost of faculty and staff salary increases provided in FY 2012 and support its share of a 3% salary bonus for faculty and staff, as well as state mandated increases in health insurance and retirement in FY 2013. These funds also provide targeted support for undergraduate and graduate student financial aid consistent with the College's Six Year and Strategic Plans.

Fee allocations for auxiliary services, facility debt service, student activities, and average charges for room and board support projected expenditures for operations and required debt service on facilities while allowing some contribution to the College's auxiliary reserve.

THEREFORE, BE IT RESOLVED, that the Board of Visitors of the College of William and Mary in Virginia approves the FY 2012-13 Tuition and Fee Schedule as well as room and board charges as shown on the attached schedules.

A RESOLUTION HONORING CAROLYN COGGIN HOLMES EXECUTIVE DIRECTOR OF ASH LAWN-HIGHLAND

Carolyn Coggin Holmes began directing Ash Lawn-Highland, the home of President James Monroe, in 1975. During her 37 years at the helm, she built Ash Lawn-Highland, which currently draws 60,000 visitors per year, into a significant historical attraction.

In 1974, the philanthropist Jay Winston Johns bequeathed this property to The College of William and Mary, President Monroe's alma mater. At the time, the College feared Ash Lawn-Highland, which was in disrepair, would be a drain on the College's resources. Mrs. Holmes, the wife of David L. Holmes, Professor of Religious Studies Emeritus at William and Mary, expressed her interest in Ash Lawn-Highland during a chance encounter with several College leaders. Initially given only a 15-month contract, she set about the work of restoring the Monroe home and daunting task of turning the 535-acre property into a self-sustaining operation.

Thanks to Mrs. Holmes' efforts, a visitor to Ash Lawn-Highland today would struggle to believe those humble beginnings were true. President Monroe's "cabincastle" provides modern patrons with a glimpse of 19th century life through examples of early American and Victorian architecture, decorative arts from those periods, and craft demonstrations. Educational programming ranges from lessons in candlemaking and weaving to exploring President Monroe's life and leadership. Ash Lawn-Highland is also a popular location for special events and meetings throughout the year.

No aspect of Ash Lawn-Highland's operation falls beyond Mrs. Holmes' purview from the catalogue of furnishings, 90 percent of which either belonged to the Monroes or are exact replicas of known pieces in their home, to the provision of peacocks to roam the property. The success of Ash Lawn-Highland has been rooted in Mrs. Holmes' vision and devoted leadership of Monroe's estate.

A RESOLUTION HONORING JAMES B. McNEER AND NANCY W. McNEER

Dr. James B. McNeer became the third President of Richard Bland College of The College of William and Mary in Virginia on August 1, 1996, and has skillfully led the institution for 16 years. His presidency marked a transformational period for Richard Bland while holding true to the mission of expanding educational and career opportunities for its students.

Under Dr. McNeer's leadership, Richard Bland College has continued to serve traditional college-age and adult students, many of whom are the first in their family to attend college. A significant portion of graduating Richard Bland students transfer to four-year institutions to complete their baccalaureate degrees. Though he is quick to credit the College's caring faculty for nurturing its students, Dr. McNeer's efforts deserve much of the praise for the overwhelmingly positive student outcomes. He has championed the College's cause in the community and state legislature, and been a mentor on campus. Delegate M. Kirkland Cox, a Richard Bland alumnus, described Dr. McNeer as a role model of uncommon grace.

The campus of Richard Bland College changed dramatically in recent years with Dr. McNeer leading the way. In 2010, the College opened the Integrated Science and Technology Center, now named James B. McNeer Hall, which was the first academic building constructed on campus in four decades. McNeer Hall, a 52,000 square-foot building, houses academic computing, biology, chemistry, mathematics, and physics classrooms as well as a faculty and student lounge. In 2008, the College opened two residence halls, making Richard Bland the only two-year college in Virginia with on-campus housing for students. In addition to the new buildings, the College completed a major renovation of its library and student center, added a health center, expanded its bookstore, built a 500,000-gallon water tower, and created a campus police department.

Dr. McNeer successfully led Richard Bland's first capital campaign, which raised more than \$5 million over a four-year period. Completed in 2010, The Campaign for the Future of Richard Bland College assisted in building support facilities for the residential village, increased the number of endowed scholarships, and assisted in funding other campus-wide enhancements. One of those enhancements, the new Recreation Complex, will feature tennis courts, a softball field, and outdoor basketball and volleyball courts.

Dr. McNeer first joined Richard Bland College in 1968. At the time, the College enrolled about 400 students. Today, Richard Bland enrolls more than 1,600

students. The tremendous growth is in many ways due to Dr. McNeer's vision for the institution and diligence in pursuing it. During his 44-year career at Richard Bland, he has seemingly held every position on campus, including Professor, Director of Admissions and Financial Aid, Assistant to the President, Dean of Faculty, Provost, and, ultimately, President. While Provost, he simultaneously held the office of Mayor of Colonial Heights. He has also served on Colonial Heights' School Board and Public Library Board as well as served as chairman of the Crater District Planning Commission, the Tri-Cities' civilian spokesman for three federal Base Realignment and Closing commissions, a member of the Virginia Commission on Military Bases, and a member of the Board of Directors of Southside Regional Medical Center. In March 2012, the Virginia General Assembly passed a joint resolution commending Dr. McNeer on his tremendous career at Richard Bland College and in service to the community and Commonwealth. Dr. McNeer will retire as President on June 30, 2012.

Nancy W. McNeer has served for the past sixteen years as the first lady of Richard Bland College. During her tenure, she consistently demonstrated her enthusiasm and support, and served actively as part of the presidential team, even while fulfilling the responsibilities of her 30-year career as a public school teacher. Mrs. McNeer brought a thoughtful standard of excellence to all events and programs she hosted for the College. She served with distinction in her role as college ambassador in visits with alumni, donors, and friends.

RESOLUTION OF THE BOARD OF VISITORS OF THE COLLEGE OF WILLIAM AND MARY IN VIRGINIA – 2012 9(D) POOLED BOND PROGRAM: IMPROVE AUXILIARY FACILITIES

WHEREAS, pursuant to and in furtherance of Chapter 3.2, Title 23 of the Code of Virginia of 1950, as amended (the "Act"), the Virginia College Building Authority (the "Authority") developed a program (the "Program") to purchase debt instruments issued by public institutions of higher education in the Commonwealth of Virginia ("Participating Institutions" and each a "Participating Institution") to finance or refinance projects of capital improvement ("Capital Projects" and each a "Capital Project") included in a bill passed by a majority of each house of the General Assembly of Virginia (the "General Assembly");

WHEREAS, under the Program the Authority from time to time issues its Educational Facilities Revenue Bonds (Public Higher Education Financing Program) ("Pooled Bonds") to finance the purchase or refunding of debt instruments issued by Participating Institutions to finance or refinance Capital Projects;

WHEREAS, if a Participating Institution desires to finance or refinance a Capital Project through the Program it must enter into a loan agreement with the Authority, under which: (i) the Participating Institution will issue its promissory note pursuant to Chapter 3, Title 23 of the Code of Virginia of 1950, as amended, to evidence a loan to it by the Authority; (ii) the Authority will agree to issue Pooled Bonds and use proceeds thereof to purchase the promissory note; (iii) the Participating Institution will agree to use proceeds of Pooled Bonds, loaned to it and received in exchange for its promissory note, to finance or refinance the Capital Project and to not take actions that may jeopardize any federal tax-exempt status of interest on Pooled Bonds allocable to financing or refinancing the Capital Project; and (iv) the Participating Institution will agree to make payments under the promissory note in sums sufficient to pay, together with certain administrative and arbitrage rebate payments, the principal of, premium, if any, and interest due on such Pooled Bonds;

WHEREAS, the Board of Visitors (the "Board") of <u>the College of William and Mary</u> (the "Institution") from time to time desires to finance or refinance Capital Projects for the Institution as a Participating Institution under the Program, and now proposes that the Institution issue its promissory note or notes (collectively, the "Note") to be sold to the Authority in accordance with a loan agreement or loan agreements between the Institution and the Authority (collectively, the "Loan Agreement"), under which proceeds of Pooled Bonds will be loaned to and received by the Institution in exchange for the Note, to finance or refinance costs of the following Capital Projects authorized for bond financing by the General Assembly: the <u>Improve Auxiliary Facilities</u>, (Project Code: 204-17934) (the "Project"); and

WHEREAS the Board desires to designate certain Institution officers (i) delegated the authority to approve the forms of and to execute and deliver the Loan Agreement, the Note and any amendments thereto, and any other documents necessary or desirable in

connection with financing or refinancing costs of the Project through and participation in the Program; and (ii) responsible for monitoring post-issuance compliance with covenants of the Institution related to maintaining any federal tax-exempt status of interest on Pooled Bonds.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD:

Section 1. The Project is hereby designated to be undertaken and financed or refinanced by the Authority and, accordingly, the <u>President, Provost, Vice President of Finance, Vice President for Administration</u> (the "Authorized Officers") are each hereby delegated and invested with full power and authority to approve the forms of the Loan Agreement, the Note and any amendments thereto (in connection with any refunding of Pooled Bonds financing or refinancing the Project or otherwise), and any pledge to the payment of the Note and any amendment thereto of total gross university sponsored overhead, unrestricted endowment income, tuition and fees, indirect cost recoveries, auxiliary enterprise revenues, general and nongeneral fund appropriations and other revenues not required by law or previous binding contract to be devoted to some other purpose, restricted by a gift instrument for another purpose or excluded from such pledge as provided in the Loan Agreement, subject to the provisions of Section 3 hereof.

Section 2. Subject to the provisions of Section 3 hereof, the Authorized Officers are each hereby delegated and invested with full power and authority to execute, deliver and issue, on behalf of the Institution, (a) the Loan Agreement, the Note and any amendments thereto (in connection with any refunding of Pooled Bonds financing or refinancing the Project or otherwise), with approval of such documents in accordance with Section 1 hereof evidenced conclusively by the execution and delivery of the respective document, and (b) any other documents, instruments or certificates as may be deemed necessary or desirable to finance or refinance costs of the Project through and participate in the Program, and to further carry out the purposes and intent of this resolution. The Authorized Officers are directed to take such steps and deliver such certificates in connection with delivery of the Note, and any amendment thereto, as may be required under any existing obligations, including bond resolutions relating to any outstanding general revenue pledge bonds.

Section 3. The authorizations given above as to the approval, execution, delivery and issuance of the Loan Agreement, the Note and any amendments thereto (in connection with any refunding of Pooled Bonds financing or refinancing the Project or otherwise) are subject to the following parameters: (a) the principal amount to be paid under the Note allocable to any component of the Project, together with the principal amount of any other indebtedness with respect to such component, shall not be greater than the amount authorized for such component by the General Assembly plus amounts needed to fund issuance costs, original issue discount, other financing (including without limitation refunding) expenses and any other increase permitted by law; (b) the aggregate principal amount of the Note shall in no event exceed \$\frac{8,000,000}{8,000,000}\$ as the same may be so increased; (c) the aggregate interest rate payable under the Note shall not exceed a "true" or "Canadian" interest cost more than 50 basis points higher than the interest rate for "AA" rated securities with comparable maturities, as reported by

Thomson Municipal Market Data (MMD) or another comparable service or index, as of the date that the interest rates are determined, taking into account any original issue discount or premium; (d) the weighted average maturity of the principal payments due under the Note shall not exceed 20 years after the original issue date of the Note; (e) the last principal payment date under the Note shall not extend beyond the reasonably expected weighted economic life of the Project; and (f) subject to the foregoing, the actual amount, interest rates, principal maturities, and date of the Note shall be approved by an Authorized Officer, as evidenced by the execution thereof.

Section 4. The Board acknowledges that if there is a failure to make, as and when due, any payment of the principal of, premium, if any, and interest on any promissory note issued by the Institution as a Participating Institution to the Authority under the Program, including without limitation the Note and any amendments thereto, the State Comptroller is authorized under the Program and Section 23-30.29:3 of the Code of Virginia of 1950, as amended, to charge against appropriations available to the Institution all future payments of principal of, premium, if any, and interest on such promissory note when due and payable and to make such payments to the Authority or its designee, so as to ensure that no future default will occur on such promissory note.

Section 5. The Board agrees that if the Authority determines the Institution as a Participating Institution shall be subject to continuing disclosure obligations under Rule 15c2-12 of the federal Securities and Exchange Commission with respect to any Pooled Bonds, (a) an Authorized Officer shall, and is hereby authorized and directed to, enter into a continuing disclosure undertaking in form and substance reasonably satisfactory to the Authority, and (b) the Institution will comply with the provisions and disclosure obligations contained therein.

Section 6. The Board designates the <u>Vice President for Finance</u> to be responsible for implementing procedures to monitor post-issuance compliance with covenants in any loan agreement between the Institution as a Participating Institution and the Authority, including the Loan Agreement and any amendments thereto, related to maintaining tax-exempt status for federal income tax purposes of interest on any Pooled Bonds, including without limitation monitoring the use of any portion of all Institution Capital Projects financed or refinanced with such Pooled Bonds and compliance with any applicable federal income tax remedial action requirements in connection with certain changes in such use. Such officer shall make a determination as to such post-issuance compliance at least annually for so long as such Pooled Bonds remain outstanding.

Section 7. This resolution shall take effect immediately upon its adoption.

The Board of Visitors of the Institution hereby adopts this declaration of official intent under Treasury Regulations Section 1.150-2 and declares that the Institution intends to reimburse itself, in accordance with such Section 1.150-2, with the proceeds of Indebtedness for Expenditures made on, after or within 60 days prior to the date of the adoption of this Resolution with respect to the Project, except that Expenditures made more than 60 days prior to the date hereof may be reimbursed as to certain de minimis or preliminary expenditures described in Treasury Regulations Section 1.150-2(f) and as to other expenditures permitted under applicable Treasury Regulations.
- 2. The maximum principal amount of Indebtedness expected to be issued for the Project is \$8,000,000.
- 3. This Resolution shall take effect immediately upon its adoption.

WHEREAS, there have been passed by the General Assembly of Virginia and signed by the Governor acts entitled "Commonwealth of Virginia Higher Educational Institutions Bond Act of 2012" (the "2012 Act") "Commonwealth of Virginia Higher Educational Institutions Bond Act of 2011" (the "2011 Act"), "Commonwealth of Virginia Higher Educational Institutions Bond Act of 2010" (the "2010 Act"), "Commonwealth of Virginia Parking Facilities Bond Act of 2009" (the "2009 Act"), "Commonwealth of Virginia Higher Educational Institutions Bond Act of 2009" (the "2008 Act"), "Commonwealth of Virginia Higher Educational Institutions Bond Act of 2008" (the "2008 Act"), "Commonwealth of Virginia Higher Educational Institutions Bond Act of 2007" (the "2007 Act"), and "Commonwealth of Virginia Higher Educational Institutions Bond Act of 2006" (the "2006 Act") and, together with the 2007 Act, 2008 Act, 2009 Acts, 2010 Acts, 2011 Acts and the 2012 Act, the "Acts");

WHEREAS, pursuant to the Acts, the Treasury Board of the Commonwealth of Virginia (the "Treasury Board") is authorized, by and with the consent of the Governor, to sell and issue bonds or bond anticipation notes of the Commonwealth of Virginia (the "Commonwealth") for the purpose of providing funds, together with other available funds, for paying the cost of acquiring, constructing, renovating, enlarging, improving and equipping certain revenue-producing capital projects at certain institutions of higher learning of the Commonwealth and for paying issuance costs, reserve funds and other financing expenses (the "Financing Expenses"), all in accordance with the provisions of Section 9(c) of Article X of the Constitution of Virginia;

WHEREAS, for the College of William and Mary (the "Institution"), such revenue-producing capital projects include <u>Construct New Dormitory</u>, 204-17808; and <u>Renovate Dormitories</u>, 204-17933 (each individually, a "Project" and, collectively, the "Projects"); and

WHEREAS, the Treasury Board is proposing to sell and issue bonds or bond anticipation notes pursuant to the Acts for such revenue-producing capital projects, in one or more series;

NOW, THEREFORE, BE IT RESOLVED BY THE RECTOR AND VISITORS OF THE COLLEGE OF WILLIAM AND MARY:

Section 1. The Board of Visitors of the Institution (the "Board") requests the Treasury

Board to sell and issue bonds (the "Bonds") or bond anticipation notes ("BANs") in an aggregate principal amount not to exceed \$\frac{14,411,000}{\text{to finance all or a portion of the costs of each Project plus Financing Expenses (for each individual Project, the "Individual Project Bonds" or "Individual Project Notes" and, collectively, the "Individual Project Borrowing" and for all Projects, the "Project Bonds" or "Project Notes" and, collectively, the "Project Borrowings"). The Individual Project Borrowings will be identified by amount by the State Treasurer upon issuance of any Bonds or BANs.

Section 2. With respect to each Project, the Board (a) covenants to fix, revise, charge and collect student housing revenues and other rates, fees and charges, for or in connection with the use, occupation and services of such Project and (b) pledges such rates, fees and charges remaining after payment of (i) the expenses of operating such Project and (ii) the expenses related to all other activities funded by the student housing revenues ("Individual Project Net Revenues") to the payment of the principal of, premium, if any, and interest on the Individual Project Borrowing relating thereto. The Board further covenants that it will fix, revise, charge and collect such rates, fees and charges in such amounts so that Individual Project Net Revenues will at all times be sufficient to pay, when due, the principal of, premium, if any, and interest on the related Individual Project Borrowing and on any other obligations secured by such Individual Project Net Revenues (such payments collectively the "Required Payments"). Each Individual Project Borrowing shall be secured on a parity with other obligations secured by the Individual Project Net Revenues relating to such Individual Project Borrowing (other than any obligations secured by a prior right in Individual Project Net Revenues). Any Individual Project Net Revenues pledged herein in excess of the Required Payments for an Individual Project Borrowing may be used by the Institution for any other lawful purpose.

Section 3. It is hereby found, determined and declared that, based upon responsible engineering and economic estimates and advice of appropriate officials of the Institution, as shown on the Financial Feasibility Studies attached hereto as Exhibit A, with respect to each Project, the anticipated Individual Project Net Revenues pledged herein will be sufficient to pay the Required Payments for such Project so long as the aggregate amount of net debt service on the Individual Project Borrowing for such Project actually payable in any bond year does not exceed the amounts assumed in the Financial Feasibility Study relating thereto.

Section 4. The Board covenants that the Institution will furnish the Treasury Board its general purpose financial statements, within 30 days of their issuance and receipt, audited by a firm of certified public accountants or the Auditor of Public Accounts which shall include a schedule of revenues and expenditures for auxiliary enterprise systems. If Individual Project Net Revenues for any Project are insufficient to pay Required Payments for such Project during such period, the

Institution shall provide evidence of a plan to generate Individual Project Net Revenues for such Project sufficient to make such Required Payments in the future.

Section 5. The Board covenants that so long as any of the Project Notes are outstanding, the Institution will pay to the State Treasurer, not less than 30 days before each interest payment date, an amount estimated by the State Treasurer to be due and payable on such date as interest on the Project Notes. The Board covenants that so long as any of the Project Bonds are outstanding, the Institution will pay to the State Treasurer, not less than 30 days before each interest or principal payment date, the amount certified by the State Treasurer to be due and payable on such date as principal of, premium, if any, and interest on the Project Bonds.

Section 6. The Board covenants that the Institution will pay from time to time its proportionate share of all expenses incurred in connection with the sale and issuance of any series of Bonds that includes Project Bonds or Project Notes and all expenses thereafter incurred in connection with the Bonds, including without limitation the expense of calculating any rebate to the United States of the earnings derived from the investment of gross proceeds of the Bonds, all as certified by the State Treasurer to the Institution.

Section 7. The Board covenants that the Institution will not take or omit to take any action the taking or omission of which will cause the Bonds to be "arbitrage bonds" within the meaning of Section 148 of the Internal Revenue Code of 1986, as amended, including regulations issued pursuant thereto (the "Code"), or otherwise cause interest on the Bonds to be includable in the gross income of the owners thereof for federal income tax purposes under existing laws. Without limiting the generality of the foregoing, the Institution will pay from time to time its proportional share of any rebate to the United States of the earnings derived from the investment of the gross proceeds of the Bonds.

Section 8. The Board covenants that the Institution will proceed with due diligence to undertake and complete the Projects and that the Institution will spend all of the available proceeds derived from the sale of the Project Borrowings for costs associated with the Projects and appropriated for the Projects by the General Assembly.

Section 9. The Board covenants that the Institution will not permit the proceeds of each Individual Project Borrowing to be used in any manner that would result in (a) 5% or more of such proceeds being used in a trade or business carried on by any person other than a governmental unit, as provided in Section 141(b) of the Code, (b) 5% or more of such proceeds being used with respect to any output facility within the meaning of Section 141(b)(4) of the Code, or (c) 5% or more of such proceeds being used directly or indirectly to make or finance loans to any persons other than a

governmental unit, as provided in Section 141(c) of the Code. The Institution need not comply with such covenants if the Institution obtains the written approval of the State Treasurer and an opinion of nationally recognized bond counsel acceptable to the Treasury Board that such covenants need not be complied with to prevent the interest on the Bonds from being includable in the gross income of the owners thereof for federal income tax purposes.

Section 10. The Board covenants that for so long as any of the Bonds are outstanding the Institution will not enter into any operating lease, management contract or similar agreement with any person or entity, other than a state or local governmental unit, for all or any portion of any of the Projects without first obtaining the written approval of the State Treasurer and an opinion of nationally recognized bond counsel acceptable to the Treasury Board that entering into such agreement will not cause the interest on the Bonds to be included in the gross income of the owners thereof for federal income tax purposes.

Section 11. The Board covenants that for so long as any of the Bonds are outstanding, the Institution will not sell or dispose of all or any part of any of the Projects without first obtaining the written approval of the State Treasurer and an opinion of nationally recognized bond counsel acceptable to the Treasury Board that such sale or disposition will not cause interest on the Bonds to be included in the gross income of the owners thereof for federal income tax purposes.

Section 12. The officers of the Institution are authorized and directed to execute and deliver all certificates and instruments and to take all such further action as may be considered necessary or desirable in connection with the sale and issuance of the Bonds.

Section 13. The Board acknowledges that the Treasury Board will rely on the representations and covenants set forth herein in issuing the Bonds, that such covenants are critical to the security for the Bonds and the exclusion of the interest on the Bonds from the gross income of the owners thereof for federal income tax purposes, that the Board will not repeal, revoke, rescind or amend any of such covenants without first obtaining the written approval of the Treasury Board, and that such covenants will be binding upon the Board so long as any of the Bonds are outstanding.

Section 14. This resolution shall take effect immediately.

COLLEGE OF WILLIAM AND MARY FY 2014 OPERATING AND CAPITAL BUDGET AMENDMENTS

Using guidance from the Governor's Office, the Secretary of Education, and the State Department of Planning and Budget, the College of William and Mary has developed operating and capital budget amendments for consideration by the Governor as part of the Commonwealth's 2012-14 budget development process.

Operating budget requests are limited in number and reflect high priority items in the College's Six-Year Plan. Guidance from the Secretary of Education states that an "institution's funding requests should be consistent with the priorities noted in its updated Six-Year Plan, which supports both the Governor's priorities and the goals of the TJ21 legislation". Capital requests should be limited to supplemental funding for previously approved projects. Funds should not be requested for items typically considered "state-wide" issues by the Commonwealth of Virginia. State-wide issues include faculty and staff salaries, base adequacy funding, undergraduate student financial assistance, and continuation of the Higher Education Equipment Trust Fund program.

THEREFORE, BE IT RESOLVED, That the Board of Visitors of the College of William and Mary approves the administration's recommended operating and capital budget amendments for the College for submission to the Commonwealth as part of the 2012-14 budget development process.

FY 2014 OPERATING BUDGET AMENDMENTS

• Enrollment Growth FY 2013-14 \$ 356,000 GF

The College has committed to increasing in-state undergraduate enrollment by 150 students over the next four years with the first cohort arriving in Fall 2011. Enrollment projections submitted as part of the Six Year Plan reflect this increase. The College anticipates adding additional resources to support these students and ensure their success.

• Center for Energy and FY 2013-14 the Environment \$400,000 GF

Building on existing program strengths of the College and the Virginia Institute of Marine Science, the Center for Energy and the Environment supports research and economic development within the commonwealth. Program areas include alternative fuel and energy sources and remediation and restoration of Virginia waterways including the Chesapeake Bay. The CEE will provide expanded opportunities for STEM training of undergraduates, adding to the Commonwealth's workforce pool. Included in this request is funding support for high speed computing, computational modeling and simulation, and incremental support for the College's Existing Center for Geospatial Analysis.

FY 2014 CAPITAL BUDGET AMENDMENTS

• Renovation: Tyler Hall <u>FY 2013-14</u> \$ 16,364,000 GF

The 2012-14 Appropriation Act authorizes the College to proceed with detailed planning for the renovation of Tyler Hall. This amendment requests funds to complete planning and proceed with renovation prior to the 2014-16 biennium. Once renovated, Tyler Hall will house the departments of Government, Economics, and Public Policy.

• Renovation: Residence Life Facilities FY 2013-14 \$ 9,650,000 NGF

Over the past year the College has developed a plan to accelerate the renovation of its residence halls by taking facilities completely off-line for a year and the surrounding summers. This approach requires additional debt authority beyond the \$5 million previously authorized for dormitory renovations. The requested authority allows the College of move forward with full renovation of Chandler Hall, air conditioning of Barrett Hall, and planning for the full renovation of Landrum Hall.

OPERATING AMENDMENTS

Faculty Positions

FY 2013-14 \$251,411 GF (on-going) \$140,270 GF (one-time) 2.0 FTE

This initiative requests establishment of two faculty positions that will aid the Institute's three-part mission to educate students and citizens, conduct interdisciplinary research in coastal ocean and estuarine science, and provide advisory service to policy makers, industry, and the public. Establishing new faculty positions will increase the number of students in the STEM disciplines, enhance VIMS' ability to educate the public and improve science literacy, provide necessary information to local, state and federal regulatory agencies, and conduct cutting-edge research in emerging areas such as renewable energy and biosensor development that create economic opportunities. Moreover, an increase in faculty will enable us to respond more quickly and effectively to the needs of the Commonwealth. Over the years, VIMS' faculty have conducted research on many critical State issues such as the Pfiesteria outbreak, introduction of non-native oysters in Chesapeake Bay, and the population status of Atlantic menhaden, and have disseminated advice on those areas to the Commonwealth. The *Code of Virginia* explicitly defines VIMS as the Commonwealth's advisor on marine-related issues and outlines over 30 VIMS-specific mandates.

Information Technology & High Performance Computing

FY 2013-14 \$409,302 GF (on-going) \$785,000 GF (one-time) 3.0 FTE

This initiative requests equipment and operating funds to centralize support for the High Performance Computing platforms, which includes increasing the network capacity by tenfold to ensure state-of-the-art modeling and simulation computations. The equipment upgrades will meet the rapidly-growing needs of increased data collection capacity for highly-sophisticated programs that conduct fish DNA analysis, engage in genome studies, and conduct other real-time simulation and modeling analyses in the coastal and ocean environment. VIMS fulfills a unique niche in HPC by modeling water quality analysis for environmental and regulatory purposes, and storm-surge flooding predictions from hurricanes for risk assessment purposes.

Research Equipment Service Contracts

FY 2013-14 \$300,000 GF 0.0 FTE

This proposal requests funds for research and academic support by providing a mechanism to sustain equipment purchased by the State's Higher Education Equipment Trust Fund (HEETF). The HEETF allocations to VIMS over the past five years have been approximately \$2.5 million (\$500,000 per year), which has allowed VIMS to procure equipment items such as DNA sequencers, Gas Chromatographs, Mass Spectrometers, and related analytical equipment. These are mission-dependent scientific pieces of equipment, all of which support STEM activities at VIMS. Specific examples include genetic identification of fish species and fish stocks in support of management at both the national and international level, isolation and identification of harmful algal bloom species (including those producing toxins), identification and isolation of microscopic parasites of commercially valuable crustaceans (crabs and lobsters), and identification and environmental tracking of man-made complex organic compounds with known or potential human and/or environmental impacts. Moreover, VIMS has been able to pair HEETF funds with external grant and contract research activities in a way that has allowed VIMS to establish a competitive advantage for conducting cutting edge STEM research, particularly in Marine Science. Failure to maintain manufacturer dependent service compromises the full appreciation of the investment by the Commonwealth, increases expenses inefficiently by having ad hoc service calls, and importantly, can extend the research downtime thus delaying grant and contract deliverables and advisory service responses to the Commonwealth and other state agencies.

CAPITAL AMENDMENTS

Planning: Construct New Oyster Hatchery

\$1,152,000 GF

This project supports the construction of a new 22,000 square-foot Hatchery Complex to replace the 40 year old VIMS Oyster Hatchery and will include office and laboratory space for oyster research, restoration efforts, industry and economic development, marine finfish culture and educational programs. This project must be coupled with the relocation of the Facilities Management Complex.

VIRGINIA INSTITUTE OF MARINE SCIENCE FY 2014 OPERATING AND CAPITAL BUDGET AMENDMENTS

Planning: Relocate and Construct Facilities Management Maintenance Facility

\$576,000 GF

This project provides for a modern replacement building to house administrative offices, maintenance trades shops, automotive and equipment repair garage, grounds keeping, housekeeping, storage, and shipping and receiving. The new 15,000 square-foot facility would be relocated to a more appropriate part of campus to make way for the New Oyster Hatchery which must be located along the shoreline.

New Construction: Eastern Shore Administration & Education Complex

\$2,663,000 GF

This project supports the design and construction of three new buildings that total 10,200 square-feet to replace outdated buildings vulnerable to flooding on the Wachapreague campus. The complex includes administrative offices, an educational conference center with classrooms, convertible meeting rooms, a distance learning classroom, and a maintenance shop to support buildings, grounds, and vessel repairs. VIMS intends to fund the planning for this project with a combination of private funds and institutional funds.

COLLEGE OF WILLIAM AND MARY APPOINTMENT OF INVESTMENT MANAGER

At the May, 2012 meeting of the Investments Subcommittee of the Committee on Financial Affairs, Wells Fargo Advisors, financial advisor to the Board of Visitors for investment of private funds, recommended that the Board replace its current large cap growth manager. This recommendation resulted from the Investment Subcommittee's request that Wells Fargo evaluate the performance of the Board's existing manager in this area relative to other manager options. As a result, the Subcommittee authorized Wells Fargo Advisors to work with the College to issue a request for proposals (RFP).

On September 13, 2012, Wells Fargo Advisors presented the results of the RFP process to the Investments Subcommittee. After review and discussion, the Investments Subcommittee recommends to the Committee on Financial Affairs and the Board of Visitors that the Board replace its previous large cap growth manager with Goldman Sachs Asset Management.

THEREFORE, BE IT RESOLVED that the Board of Visitors of the College of William and Mary in Virginia accepts the recommendation of the Committee on Financial Affairs that its previous large cap growth manager be replaced and that Goldman Sachs Asset Management be retained as the College's large cap growth manager.

COLLEGE OF WILLIAM AND MARY

SIX-YEAR PLAN UPDATE

WHEREAS, the College of William & Mary has a long tradition of providing an excellent liberal arts education to the citizens of the Commonwealth and the nation; and

WHEREAS, the Governor's Commission on Higher Education has indicated "the Commonwealth's commitment . . . to having a distinctive 'public ivy' at William & Mary;" and

WHEREAS, consistent with the requirement of the Higher Education Opportunity Act (the Act), the College developed its initial Six-Year Plan rooted in this commitment, the goals set out in its Strategic Plan, and the objectives of the Act; and

WHEREAS, the Commonwealth's planning process requires an update to the six year-plan on an annual basis, incorporating funding actions by the Commonwealth as reflected in the final FY 2013 budget approved by each institution's Board of Visitors.

WHEREAS, the College has reviewed those expenditures necessary to support and enhance its instructional, research, student service, and administrative operations, prioritized those expenditures, and recommended funding through a combination of Commonwealth, College, and reallocated revenue; and

WHEREAS, the College continues to evaluate opportunities to improve the effectiveness and efficiency of its academic and administrative programs and activities;

THEREFORE, BE IT RESOLVED, That upon recommendation of the President, the Board of Visitors of the College of William and Mary, approves the College's Six-year Plan Update to reflect FY 2013 expenditures and tuition and fee charges consistent with the College's FY 2013 operating budgets as approved by the Board, and FY 2014 expenditures as proposed in the College's original Six-Year Plan adjusted to include \$3,721,000 supporting faculty salary increases as a first step to achieve the 60th percentile of the State Council of Higher Education in Virginia's (SCHEV) approved faculty salary peer group for the College. Planned FY 2014 expenditures include \$9,016,700 in College support supplemented by incremental state funding and further reallocation of funds within the College's overall operating budget.

BE IT FURTHER RESOLVED, That the Board defers setting tuition rates for FY 2014 pending consideration of tuition options that more fully address the Higher Education Commission's goal of improved affordability for lower and middle-income families consistent with Higher Education Advisory Committee income guidelines while providing the resources necessary to implement the College's Six-Year Plan.

BE IT FURTHER RESOLVED, That in response to the Commonwealth's direction that the Virginia Institute of Marine Science prepare a separate Six-Year Plan, the Board of Visitors of the College of William and Mary approves the Institute's Six-Year Plan Update to reflect FY 2013 expenditures consistent with the Institute's FY 2013 operating budget as approved by the Board, and FY 2014 expenditures as proposed in the Institute's original Six-Year Plan adjusted to reflect the impact of any state funding actions.

RESOLUTION OF THE BOARD OF VISITORS OF THE COLLEGE OF WILLIAM AND MARY REGARDING CHANGES TO THE BYLAWS

WHEREAS, the Bylaws of the Board of Visitors set forth basic expectations for the Board's organization and operation, as well as that of the College of William and Mary and Richard Bland College. In addition, the Bylaws contain delegations of the Board's authority to key designees at both institutions; and

WHEREAS, it is the practice of the Board periodically to revisit such organization and delegations to ensure that their forms permit the continued wise and prudent operation of the Board, the College of William and Mary, and Richard Bland College, and to make changes as appropriate; and

WHEREAS, the Board desires to: (1) give flexibility to the new President of Richard Bland College as she implements organizational changes that will better permit the College to flourish; (2) adjust its own organization to respond to changing needs; and (3) clarify its delegations of authority to transact business in the Board's name;

BE IT THEREFORE RESOLVED, that the Board of Visitors of The College of William and Mary in Virginia suspends the application of Article I, Sections 4, 7, 9, 12, and 15, as well as Article II, Section 9 (second paragraph), effective September 20, 2012; and

BE IT FURTHER RESOLVED, that the Rector work with the presidents of the College of William and Mary and Richard Bland College to prepare recommended changes to the Bylaws to achieve the goals set forth in this resolution, together with such other recommendations that seem prudent and appropriate. Such recommendations should be ready for the Board's consideration at its next regularly scheduled meeting.

CLOSED MEETINGS

The Board of Visitors may consider in closed session certain matters, including those listed below. The Code is very specific as to how these matters will be described in public session and in closing the meeting the motion must be specific as to the matters to be considered in closed session. There may be no discussion in closed session of matters not identified in the original motion.

§2.2-3712.D. - At the conclusion of any closed meeting, the Board of Visitors shall immediately reconvene in open meeting and shall take a roll call or other recorded vote to be included in the minutes, certifying that to the best of each member's knowledge (i) only public business matters lawfully exempted from open meeting requirements under this chapter and (ii) only such public business matters as were identified in the motion by which the closed meeting was convened were heard, discussed or considered in the meeting by the public body. Any member of the public body who believes that there was a departure from the requirements of subdivisions (i) and (ii), shall so state prior to the vote, indicating the substance of the departure that, in his judgment, has taken place. The statement shall be recorded in the minutes.
