## HAZARD MITIGATION & SECURITY ASSESSMENT

Two Components

Security Vulnerability Assessment

Campus Hazard Mitigation Plan

- Physical survey of key areas across campus
- Limited review of current security technology
- Limited review of William & Mary Safety programs
- Discussions with administrators & key stakeholders
- Meetings with City of Williamsburg Police & Fire Departments

- Consultant premise: effective program requires an understanding of risks and the balancing of four elements:
  - -Use of technology based on assessment of need and properly used, monitored and maintained;
  - -Policies, procedures and processes that address specific needs, are well-written, routinely audited and kept current;
  - -Professional management & staffing of safety & security functions; and
  - -Campus-wide training and participation in safety & security efforts

#### Findings & Recommendations:

- William & Mary Police Department has a respected role in the campus community
- Of interest, even concern, is what appears to be a genuine feeling that members of the community are "immune from crime while on the campus."
- The relationship between law enforcement agencies, the College, the City of Williamsburg and the security force at Colonial Williamsburg is exceptional.
- Lighting and emergency phones are noted as a significant issue; a comprehensive review of all fixtures and lighting levels on pedestrian paths, parking areas and garages should be conducted.
- Adopt an appropriate design for bike racks that enhances appearance and, in turn, contributes to reduction in thefts.
- Give serious consideration of strengthening the design standard for securing classrooms.
- Consider additional technology, particularly cameras, in Swem Library
- Enhance access controls, alarms and cameras at William & Mary Hall

#### Findings & Recommendations

- Enhance security technologies, particularly video technology within Police Station including training and system management.
- Strengthen card access policy
- Explore a broader organizational model for safety management such as a Department of Public Safety

- VIMS
  - Alarm and camera monitoring program
  - Additional card access
  - Motion sensors
  - Gates
- DC Office
  - Crime prevention presentations
  - Opt in to DC emergency notification alerts

## CAMPUS HAZARD MITIGATION PLAN

#### Assessment of vulnerability to natural disasters using:

- Insurance claims
- Information from the National Climatic Data Center
- Damage history
- Institutional knowledge and experience
- Seismology reports
- Campus-wide survey
  - 1500 responses; consultant had never experience that size response
  - Hurricanes, winter storms, flooding and tornadoes (in that order) are of highest concern to campus community

## CAMPUS HAZARD MITIGATION PLAN

#### **CONCLUSION**

- Williamsburg campus is not prone to exceptional natural events.
- This negates the need for complex and costly mitigation efforts.
- Many problems can be minimized by activities such as tree trimming, storm water management and roof maintenance and leak prevention and repair
- Efforts should focus on:
  - projects that address maintenance issues, and
  - plans that provide for the continuation and or restoration of activities on campus.
